April 7, 1931

The Mayor and Trustees, City of Park Hills, Ky.,

Gentlemen:

A few days ago the City Engineer of Covington notified me as city engineer of Park Hills that a bad break had occured in the large stone and brick sewer in Park Hills leading from The Street Railway storm sewer and flume between the street

Railway and Amsterdam Pike to the Covington Trunk sewer along Lewis street.

I first thought that it was a linethat had been laid by the Street Railway. Their records show that it had been laid before they constructed their sewer, some 40 years ago. I have been unable to learn who built the sewer but it is on private land in Park Hills through the property of Godfried Schoettle and Ella Roberts, it then crosses Montague Road and connects into the Covington sewer east of Montague Road. The break is a serious one and will cost a considerable sum of money to repair. The distance from the east end of the sewer to the caved in section is 210 feet and to the center of Montague road our corporation line is 185 feet. These measurements fix the break as being in Covington and relieves us of any liability. I am notifying the Covington Authorities to that effect. The City of Covington seems to take the attitude that as the sewer serves outside territiry, the expense of repairs should not fall on Covington.
