THE CITY COUNCIL OF THE CITY OF PARK HILLS MET IN REGULAR SESSION AT THE PARK HILLS CITY BUILDING AT 8:00 P.M. on JANUARY 10, 1972, WITH MAYOR HELLMANN PRESIDING AND COUNCILMEN DROEGE, EHRMAN, GORMLEY, NIEHAUS, SORRELL AND STUTLER PRESENT.

The minutes of the December 13, 1971 meeting were approved as read by the Clerk.

This being the organization meeting of the newly elected Council, the regular order of business was suspended to permit its organization.

- The City Attorney presented Ordinance No. 1 1972, "AN ORDINANCE PROVIDING FOR THE TIME AND PLACE OF THE REGULAR MONTHLY MEETINGS OF THE CITY COUNCIL OF THE CITY OF PARK HILLS FOR THE TWO YEAR TERM OF OFFICE BEGINNING JANUARY 1, 1972 AND ENDING DECEMBER 31, 1973." A motion was made by Mr. Gormley and seconded by Mr. Droege that Ordinance No. 1- 1972 be adopted as read. Mr. Droege, aye; Mr. Ehrman, aye; Mr. Gormley, aye; Mr. Niehaus, aye; Mr. Sorrell, aye; Mr. Stutler, aye, and the motion carried.
- 2. The City Attorney presented Ordinance No. 2 1972, "AN ORDINANCE FIXING THE SALARIES FOR THE CITY ATTORNEY, ASSISTANT CITY ATTORNEY, CITY CLERK AND TREASURER, CITY ASSESSOR, CITY ENGINEER, CHIEF MAINTENANCE MAN, CHIEF OF POLICE AND PATROLMEN, AND AMENDING EXISTING SALARY ORDINANCES TO CONFORM TO THE SALARIES AS ESTABLISHED BY THIS ORDINANCE". A motion was made by Mr. Ehrman and seconded by Mr. Stutler that Ordinance No. 2 1972 be adopted as read. Mr. Droege, aye; Mr. Ehrman, aye; Mr. Gormley, aye; Mr. Niehaus, aye; Mr. Sorrell, aye; Mr. Stutler, aye, and the motion carried.
- 3. The City Attorney then presented Resolution No. 1, 1972, "A RESOLUTION APPOINTING VARIOUS PERSONS TO THE APPOINTED POSITIONS WITHIN THE CITY OF PARK HILLS". A motion was made by Mr. Stutler and seconded by Mr. Ehrman that Resolution No. 1, 1972 be adopted as read. Mr. Droege, aye; Mr. Ehrman, aye; Mr. Gormley, aye; Mr. Niehaus, aye; Mr. Sorrell, aye; Mr. Stutler, aye, and the motion carried.
- 4. The City Attorney presented Resolution No. 2, 1972, "A RESOLUTION AUTHORIZING THE MAY AND CITY CLERK-TREASURER TO WITHDRAW FUNDS DEPOSITED TO THE PARK HILLS ACCOUNTS." A motion was made by Mr. Gormley and seconded by Mr. Sorrell that Resolution No. 2, 1972 be adopted as read. Mr. Droege, aye; Mr. Ehrman, aye; Mr. Gormley, aye; Mr. Niehaus, aye; Mr. Sorrell, aye; Mr. Stutler, aye, and the motion carried.

- 5. The Mayor then appointed Councilmen to the various committees.
 - a) Fire Department Thomas Sorrell
 - b) Safety Commissioner Joseph Stutler
 - c) Police Commissioner Jack Ehrman
 - d) Finance Committee Joseph Gormley, Lee Droege
 - e) Public Works Dept. Joseph Niehaus, Joseph Stutler

The regular routine of business was then resumed.

COMMITTEE REPORTS

Public Works Dept. - Councilmen Niehaus & Stutler reporting.

- 1. Reported on a surface drain situation at 834 St. James Avenue, which had resulted in the flooding of a basement. The matter would be further handled by the Public Works Dept., who were authorized to take any further action to prevent a reoccurrence.
- 2. A stoppage of a drain at the rear of the newly constructed Tresler Car Wash had also been called to the attention of the Public Works Dept. by the City Clerk. The matter was to be investigated further by the committee before determining a course of action.
 - 3. The City Clerk and the City Engineer reported on action taken to remedy a ceptic tank situation in the Trumbell residence, property owned by Carl Votel, at Far Hills and Cecelia Avenue. City Engineer Paul had been in contact with Mr. Votel, who wished to tap the residence into the new Cecelia sewer line. The City Engineer was directed to contact Mr. Votel, who would prepare a set of specifications for such action, which must be approved by the City Engineer and submitted to Councilman Niehaus for his approval. No work to be done until approvals were received.
 - 4. Councilman Stutler reported another meeting of the No. Ky. Solid Waste Disposal Organization would be held on January 19th.
 - 5. Reported that Mr. John Vocke, Chief Maintenance Man, was still absent from his job because of illness.
 - 6. Mr. Niehaus had investigated the drainage problem on Breckinridge Road and would contact Public Works employees in repair of same.

Fire Dept. - Councilman Sorrell reporting

- 1. No monthly or annual report available at this time.
- 2. Mayor Hellmann requested of Ass't. Chief Dreyer that the practice of the Fire Dept. in listing and enumerating as Fire Dept. runs assists made to the Park Hills Police Dept. in ambulance or squad runs be discontinued, since these runs were a part of the Police Dept. record and thus constituted a duplication. Such runs could be kept by the Fire Dept., but not reported in the monthly report submitted to City Council.^{Ast}Chief Dreyer readily agreed.
- The matter of insurance coverage for Volunteer Policemen, 3. Volunteer Firemen, deputized citizens under various circumstances which might arise, were considered at length by the Council. Numerous probabilities were discussed and the Clerk reported, having been asked to so do, that he had contacted the City insuror concerning certain of these possibilities. The existance of several insurance policies provided and paid for by the City. including Workmen's Compensation, fleet automobile coverage, Police Casualty policy and Firemen's Casualty policy complicated the possibility of giving definite answers to the questions posed. City Attorney Brooking said that Volunteer Police or Volunteer Firemen. when requested by a Policeman to assist in making a squad run, would be covered for personal injuries under the General Liability clause of the automobile fleet insurance policy maintained by the City of Park Hills. A Volunteer Fireman, simply riding as a passenger in the Police cruiser, is not a member of the official family and has no coverage from the City whatsoever. Any member of the Park Hills official family riding in a City owned vehicle, while he is on duty for the City, is adequately covered.

Ass't. Fire Chief Dreyer reported that there was some variance in the coverage provided Volunteer Firemen in a policy provided by the Volunteer Fire Dept. from its own funds, from those policies under which protection to Volunteer Firemen might be provided under City paid policies. Ass't. Chief Dreyer's interpretation of the various coverages for Volunteers did not agree in full with those given by the City Clerk or the City Attorney.

Due to the complexity of the problem, it was agreed that Mayor Hellmann should contact the City insuror, the Bilz Agency, and set up a meeting with its representative, the Mayor, the Chief of the Fire Dept. or his representative, the Chief of the Police Dept., Mr. Ehrman, Mr. Stutler, Mr. Sorrell and the City Clerk, at which meeting an effort would be made to determine exact coverage under each policy. Police Dept. - Mr. Ehrman reporting

- 1. Presented the report of the Park Hils Dept. for December, 1971, which was received and filed.
- 2. Presented the annual report of the Park Hills Dept. for the year 1971, which was received and filed.
- 3. Lt. Tom Boylson discussed the specifications to be provided for the purchase of mobile Police radio equipment under the State Highway Safety Act, a Kentucky-Federal Grant-in-Aid, made available to the City of Park Hills, following which City Attorney Brooking presented Ordinance No. 3 1972, "AN ORDINANCE ADVERTISING FOR BIDS FOR MOBILE RADIO EQUIPMENT FOR THE BENEFIT OF THE POLICE DEPT. OF THE CITY OF PARK HILLS". A motion was made by Mr. Ehrman and seconded by Mr. Droege that Ordinance No. 3 1972 be adopted as read. Mr. Droege, aye; Mr. Ehrman, aye; Mr. Gormley, aye; Mr. Niehaus, aye; Mr. Sorrell, aye; Mr. Stutler, aye, and the motion carried.
- 4. Chief Klauser indicated to Council that the present radar unit was ineffective and inoperative. Discussion followed and Chief Klauser was directed to secure estimates of cost of replacing the present radar system. Because of financial commitments this purchase might have to be delayed until a new fiscal year.
- 5. The City Clerk told Council that as of this date he had contacted the Wellen Ford Co., which had been unable to certify the exact date of delivery of the new Police cruiser purchased, delivery to be sometime during the month of January.
- 6. Chief Klauser requested a meeting between the Mayor, Councilman Ehrman, Councilman Stutler and a delegation of the Police Dept. of Klauser, Kathman and Heideman. Upon request, the Mayor set the date of this meeting for February 2, 1972.
- 7. Damage to the Police cruiser received in a manner unknown was reported. The Clerk was directed to notify the insurance company and have the damage repaired.
- 8. Inresponse to question by Chief Klauser concerning the Hahn Hotel/Motel, City Attorney Brooking indicated a hearing was scheduled for January 18, 1972.

City Engineer Report

- Earl L. Paul, Park Hills City Engineer, filed with Council the certificate of apportionment for the cost of improvements of the sewer systems on Scenic and Cecelia Avenues and on Exter Dr. and Mount Allen Lane, and on motion by Stutler, seconded by Niehaus, same were approved and filed with a record of this meeting. Mr. Droege, aye; Mr. Ehrman, aye; Mr. Gormley, aye; Mr. Niehaus, aye; Mr. Sorrell, aye; Mr. Stutler, aye, and the motion carried.
- 2. Chairman Joseph Niehaus of the Park Hills Public Works Dept. reported to Council that on November 20, 1971, and December 18, 1971, after written notice to all residents involved, together with members of Council and the City Engineer, an on-site inspection was made of all sewer improvements on Scenic Avenue, Cecelia Avenue, Exter Dr. and Mt. Allen Lane, and that exceptions were noted of work to be completed on restoration and that the committee approved all sewer systems for Council acceptance. A motion was made by Mr. Niehaus and seconded by Mr. Stutler that this report be accepted. Mr. Droege, aye; Mr. Ehrman, aye; Mr. Gormley, aye; Mr. Niehaus, aye; Mr. Sorrell, aye; Mr. Stutler, aye, and the motion carried.
- The City Attorney presented Ordinance No. 4 1972. "AN 3. Said assessment being \$20,694,300.00.

Mr. Hahn also indicated that the former owners of this property, Ruttle-Anness had objected to the property being torn down.
- 3. Mr. Ted Richardson, a prospective purchaser of the Safari building, sought permission from Council to purchase the property for the purpose of conducting a sales and warehouse business. Council approved Mr. Richardson's request.
- 4. Mr. Antrobus of Cecelia Avenue entered a complaint about ground sinking in the area of sewer installation. It was pointed out that this would be taken care of during the restoration work of the project.

The regular order of business was then postponed to permit the reading of bid for the purchase of mobile radio equipment for the benefit of the Police Department of Park Hills.

Bid No. 1 - A. P. Chilly, Lexington, Ky. Bidding on Motorda equipment 1 mobile unit W/T1156 scanner - \$1097.00 2 portable units - \$2,346.00 Bid No. 2 - Blue Grass Communications, Highland Hts., Ky. Bidding on General Electric equipment 1 mobile auto radio - \$1,167.10 2 portable radios - \$938.00 each-Total \$1,876.00

The Police committee recommended that the bid of the Blue Grass Communications Co. be accepted and that, in addition, two remote microphones be purchased at a cost of \$55.00 each, and that the City likewise assume an installation charge and maintenance of the mobile unit for a year at a cost of \$81.65, making a grand total of \$3,234.75. The Clerk informed Council that the Police casualty policy, which covered both paid and volunteer men, issued by the Maryland Casualty Co., was being cancelled as of March 11, 1972, due to the fact that this company was dropping this type of coverage in the State of Ky. Discussion fillowed and it was pointed out that the paid members of the department were protected under Workmen's Compensation Insurance, and a motion was made by Mr. Gormley and seconded by Mr. Ehrman that the City Clerk-Treasurer be directed to secure coverage for the volunteer members of the department from any company on the best possible terms. Finance Dept.

- 1. Mr. Droege presented the report of the General Fund for the month of January, which was received and filed.
- 2. Mr. Gormley presented the detailed Budget Report for the seventh month operations of the Fiscal Year, which was received and filed.
- 3. The Clerk-Treasurer presented the list of persons who had failed to pay the sewer assessment on Sewer Project No. 2 and was directed to transmit same to the Park Hills Legal Dept. for suitable action.
- 4. The Clerk-Treasurer reported that during the month the City had received from the DeCoursey estate a bequest in the amount of \$1,161.29, which had been deposited in the Reserve Account, earmarked for Park maintenance.

5. The City Clerk again introduced the matter of the Homestead exemptions and suggested that if the exemptions were to be effective for the tax year 1972 that some action must be taken very shortly. Following lengthy discussion, this matter was postponed to a later date.

THE CITY COUNCIL OF THE CITY OF PARK HILLS MET IN REGULAR SESSION AT THE PARK HILLS CITY BUILDING AT 8:00 P.M. ON MONDAY, MARCH 13, 1972, WITH MAYOR HELLMANN PRESIDING AND COUNCILMEN DROEGE, GORMLEY, SORRELL, NIEHAUS AND STUTLER PRESENT. COUNCILMAN EHRMAN ABSENT ON VACATION.

The minutes of the March 8, 1972 meeting were approved as read by the Clerk.

PETITIONS AND DELEGATIONS

Mrs. Bradley of 1118 Mt. Allen Road presented to Council 1. a petition signed by many Mt. Allen Road residents, asking that Mt. Allen Road be cut off as an entrance to the grounds of the No. Kentucky State College and that a throughway from Mt. Allen Lane, permitting residents residing thereon ready access to Park Hills streets, be provided. Mayor Hellmann spoke for the City. Mrs. Bradley indicated that she had contacted the President of the college, who had indicated a willingness to have Mt. Allen closed at the beginning of the fall session. when the premises would be occupied by the law school affiliate of the college, following the college's removal to Highland Heights. Mr. Brooking, speaking for the City, inquired of Mrs. Bradley if she had secured Dr. Steeley's consent for the City of Park Hills to erect on college property a turnaround area, since people driving to the end of the street would find it impossible to continue on and if turning around would have to turn in private driveways of the residences adjacent to the college. Mr. Brooking told the petitioners that if Mt. Allen Lane were constructed to

provide entrance and egress for Mt. Allen Lane residents to So. Arlington Road that the cost would be apportioned among all the abutting property owners, including those on Mt. Allen Road at an estimated cost of \$30,000.00.

Mr. Brooking also pointed out that a law suit would have to be filed to close Mt. Allen Road at the college entrance and that the college would have to grant land to the City for the construction of the turn-around area. He indicated that the cost of the law suit would be approximately \$300.00 and must be borne by the residents of Mt. Allen Lane and Mt. Allen Road. Mr. Brooking, for the benefit of the petitioners present, pointed out that this same route had been taken earlier, but when the residents of Mt. Allen Road were reluctant to pay the legal fees for the suit, the matter was dropped. He indicated that the law requires that where a public rightof-way was to be closed, permission has to be granted by the Kenton County Circuit Court. A suggestion by the petitioners that Mt. Allen Lane be rebuilt to permit its exit into the present Exter Dr. was to be considered, at present Kxxxxxxx. is not passable for vehicles to Exter Dr. Mt. Allen Lane

The City Engineer was directed to examine Mt. Allen Lane and prepare a preliminary estimate of the cost of making it passable to Exter Dr., with the idea that the City might share in the cost of preparation, reporting at the next regular Council meeting. Mr. Brooking returned the petition to Mrs. Bradley for further signatures and any action was deferred until the April meeting.

- Mr. King of 700 St. Joseph Lane appeared about surface 2. water coming into his basement. This complaint had been investigated by the Public Works Dept. and Mr. Stutler. A plat plan, prepared by the Public Works Dept., showed at least 3 houses on an auxillary line, which emptied into the City sewers. It appeared that the solution to the problem was the removal of all roof drains from this auxillary line on residences at 700 - 626 - 624 - 622 St. Joseph Lane. The Clerk was directed to write the owners of these properties, so informing them. A copy of the plat prepared by the Public Works Dept. is made a part of these minutes.
- 3. Mr. Gardner of 621 St. Joseph, appeared about blockage in his line. Mr. Stutler of the Public Works Dept. agreed to investigate the complaint.

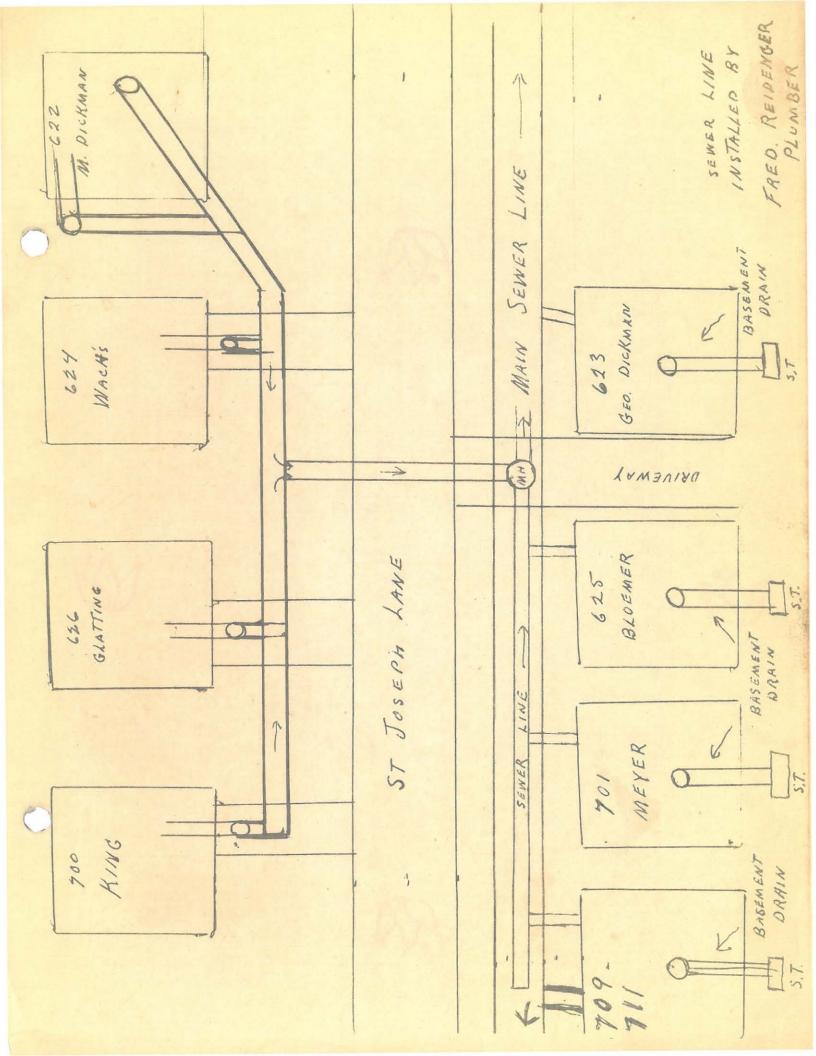
The regular order of business was then waived to permit the receipt of bids for the razing of the Hahn Hotel/Motel property.

Mr. Brooking then presented Ordinance No. 8, 1972, "AN ORDINANCE ACCEPTING THE CONTRACT FOR THE DEMOLITION AND RAZING OF THE PROPERTY KNOWN AS THE HAHN HOTEL /MOTEL COMPLEX. 1116-1424 DIXIE HIGHWAY." A motion was made by Mr. Sorrelland seconded by Mr. Stutler that Ord. No.8, 1972 be adopted as read. Mr. Droege, aye; Mr. Gormley, aye; Mr. Niehaus, aye; Mr. Sorrell, aye; Mr. Stutler, aye, and the motion carried.



At this time Mr. James Hartbarger appeared before Council to discuss the erection of an A-Frame chalet to be erected on lower Amsterdam Road. The City Clerk had requested the assistance of the City Engineer before approval of the plans. The City Engineer informed Council that, in his opinion, the plans met all the requirements of the building code and the planning and zoning code. Mr. Hartbarger indicated that in deference to the request of Fire Chief Dreyer, he would substitute an asphalt shingle roof for the wood shingle originally proposed. Council then directed the City Clerk to issue the permit when same was applied for.

Mr. Hartbarger then discussed with Council his request to build an efficiency apartment, containing five one-room efficiency apartments, on the rear portion of the lots indicated as 1004 and 1006 Amsterdam Road. Mr. Hellmann stated that the temporary moratorium on apartment buildings was still in effect. The City Clerk pointed out that if the apartments were permitted on the rear portions of these lots, facing Locust Street, that the minimum backyard lot line of 40 feet could not be met. Members of Council had visited the site, following an earlier informal request by Mr. Hartbarger, and discussion followed in which it was agreed that the Board would meet on March 20th in a recessed session to give Mr. Hartbarger an answer to his request. Mr. Hartbarger agreed.

COMMITTEE REPORTS

Public Works Dept. - Mr. Niehaus & Mr. Stutler reporting

- 1. Agreed to dredge the exit of the surface water drain lying between 832 and 834 St. James just as soon as the weather permits.
- 2. The City Engineer had set up an appointment with Mr. Carl Votel relative to the Trumbell sewer problem at 604 St. Arlington Rd.
- 3. Agreed to request the Fire Dept. to pump out the flooded area **kkm** at the rear of the Tresler Comet station in an attempt to determine if the drain serving this area was open.

Fire Dept. - Mr. Sorrell reporting

- 1. Presented the report of the Park Hills Volunteer Fire Dept. for the month of January, 1972 which was received and filed.
- 2. Reminded Council that the Park Hills Fire Dept. was to be the host of the No. Ky. Firemen Assn. meeting to be held March 28, 1972 at the Notre Dame Academy.

Police Department - Chief Klauser reported in the absence of Councilman Ehrman

- 1. Presented the report for the month of February which was received and filed.
- 2. The City Clerk announced that in compliance with Council's request, he was in the process of securing insurance coverage for the members of the Volunteer Dept.
- 3. Chief Klauser's request that Council consider the addition of three more members to the Volunteer Division was heard by Council, but any action deferred.
- 4. The new radio system for the police cruiser to be delivered during the first week of April.
- 5. Comment was made on the traffic conditions leading to Devou Park on Sundays.

Safety Committee - Mr. Stutler reporting

- 1. Requested vigilance on the part of the Police Dept. to prevent residential looting, such as has been the recent practice in Ft. Thomas.
- 2. Requested that Police on private duty at the Covington Catholic H.S. enforce automobile parking violations. Claimed that cars were parked so close to fire plugs as to make them inoperable.
- 3. Suggested that Engine No. 21 be investigated to determine why it would not readily start.
- 4. Council agreed to Mr. Stutler's request that the City Attorney prepare an ordinance prohibiting parking on both sides of So. Arlington Road from the Dixie Hwy. to Cecelia Ave. This action had been taken at the request of Mr. Holtman of So. Arlington Rd., who said that such action was the unanimous request of the persons residing on the street.

City Engineer's Report

1. A letter from the Ass't. City Attorney, in which the John Exterkamp family, who owed money for sewer installations on Exter Dr. had agreed to have the amount they owed offset from the balance due the Exterkamp Co. on sewer construction on Scenic-Cecelia-Exter Dr. and Mt. Allen Lane. The City Engineer questioned the legality of such action since he said that Exterkamp must provide to the City signed affidavits indicating that all subcontractors had been paid before the balance of the money due him on sewer installation was paid by the City. THE CITY COUNCIL OF THE CITY OF PARK HILLS MET IN REGULAR SESSION ON MONDAY, APRIL 10, 1972, AT 8:00 P.M. AT THE PARK HILLS CITY BUILDING WITH MAYOR HELLMANN PRESIDING AND COUNCILMEN DROEGE, EHRMAN, GORMLEY, NIFHAUS, SORRELL AND STUTLER PRESENT.

The minutes of the March 13th and March 20th 1972 meetings were approved as read by the Clerk.

PETITIONS AND DELEGATIONS

Mayor Hellmann turned the meeting over to City Attorney L. Brooking, who introduced Dr. Steely, the President of the No. Ky. State College, who appeared to discuss the question of the closing of Mt. Allen Rd. at the college entrance adjacent thereto. Dr. Steely pointed out that the traffic problem would be greatly reduced with the opening of the college on its new site in Highland Heights, Ky. and that present facilities would be used mainly as the law school division of the No. Ky. State College. He stated that the enrollment of the law school would be approximately 500 and that, in addition, the two-year program would be continued on the present site. The law school would operate largely at night. He indicated to the assembly that he would not be adverse to the closing of Mt. Allen Rd., if such were legal at the time of the relocation of the four-year program. He stated he could not affirm the willingness of the State to grant property for the construction of a turn-around at the barrier since the title of the property was vested in the State of Ky. and not No. Ky. State College.

The group present, including representatives from the Mt. Allen Rd. area, discussed with Dr. Steely and the Council the installation of a stop light by the State at the college entrance off of the Dixie Hwy. and the residents, the Council and Dr. Steely agreed to take such steps as possible to secure the installation of this light since the same would facilitate the use of the road by students.

City Attorney Brooking pointed out that under State law two exits were required from State owned property in order to comply with the law involving insurance coverage and a ready access to the area by fire fighting equipment. Residents of Mt. Allen Rd. displayed disappointment at this ruling, but it appeared that this requirement could not be eliminated.

Following Dr. Steely's presentation, Mayor Hellmann gave the estimate of cost of building additional roads to alleviate the situation. These estimates had been provided by the City Engineer and were as follows: From No. Ky. State College to Arlington Rd. via Mt. Allen Lane; \$25,000.00. From the college to Exter Dr. - \$13,000.00. --From Mt. Allen Rd. to Mt. Allen Lane - \$9,000.00. He then pointed out that if any of these plans were adopted the entire cost of the project must be levied against and paid for by the abutting property owners without City participation.

Mr. John Heley, a resident of Mt. Allen Rd., living immediately adjacent to the college, protested the closing of the road as not being a suitable solution to the problem. Mr. Hellmann restated the position of the City in its effort to get a traffic light installed at the Dixie Hwy. entrance to the college. Discussion then arose about citizens of Mt. Allen Rd. being allowed to park on Mt. Allen Rd., some of the residents maintaining that the display of the City sticker would indicate Park Hills residents. City Attorney Brooking pointed out that it would be illegal to prohibit parking by non-residents in favor of residents and also that many Park Hills residents, not living on Mt. Allen Rd. attended the college. Following lengthy discussion, a motion was made by Mr. Stutler and seconded by Mr. Droege that no parking be permitted on Mt. Allen Rd. on days other than Saturdays, Sundays and holidays. This motion was accompanied by the reading of Resolution No. 4 1972, "A RESOLUTION PROHIBITING PARKING ON MT. ALLEN RD. EXCEPT ON SATURDAYS, SUNDAYS AND HOLIDAYS." The motion to adopt Resolution No. was made by Mr. Stutler and seconded by Mr. Droege. Mr. Droege, aye; Mr. Ehrman, aye; Mr. Gormley, aye; Mr. Niehaus, aye; Mr. Sorrell, aye; Mr.s Stutler, aye, and the motion carried.

The City Attorney then presented Resolution No. 5, 1972, "A RESOLUTION DIRECTING THE MAYOR AND SAFETY DIRECTOR TO INSTALL A STREET LIGHT." A motion was made by Mr. Stutler and seconded by Mr. Niehaus that Resolution No. 5, 1972, be adopted as read.
