THE CITY COUNCIL OF THE CITY OF PARK HILLS MET IN REGULAR SESSION ON THURSDAY, JANUARY 13, 1977, IN MEETING POSTPONED FROM JANUARY 10, 1977, WITH MAYOR NIEHAUS PRESIDING AND COUNCILMEN GORMLEY, KAPPAS, McKINLEY, SCHLOTHAUER AND SORRELL PRESENT. COUNCILWOMAN SCHMITZ ABSENT DUE TO BEING HOSPITALIZED.

The minutes of the December 13, 1976 meeting were approved as submitted by the Clerk.

### OLD BUSINESS

1. The City Clerk presented bids for the purchase of air masks and accessory equipment, according to specifications provided at the December 13th meeting of Council.

Bid No. 1 - Webco Co. - \$2,404.00

Bid No. 2 - The Sutphen Co. - \$4,036.00

Bid No. 3 - The T & M Equipment Co. - \$2,285.48

The bids were referred to a committee of the Fire Chief and Ass't. Fire Chief for tabulation, who reported that only the bid of the Webco Co. met the advertised specifications. Whereupon, a motion was made by Mr. Sorrell and seconded by Mr. McKinley that the bid of the Webco Co., Ft. Mitchell, Ky., of \$2,404.00 be accepted, with payment to be made from the Federal Revenue Sharing Fund, as provided in the Budget for the Fiscal Year 1976-77. Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mr. Sorrell, aye, and the motion carried.

2. The City Clerk told Council he had finally been able to secure a quotation covering the Rescue Squad's public liability through the Lenke-Gross Insurance Co. of Fort Thomas. Several types of coverage were listed, and following discussion, a motion was made by Mr. McKinley and seconded by Mr. Gormley that the City provide such insurance, covering the Rescue Squad's public liability. The amount and limits selected were as follows:

3. The City Clerk, having been directed by the Mayor to investigate the possibility of securing Public Official Liability Insurance, reported as follows: The first investigation from the Lenke-Gross Ins. Co. of Ft. Thomas provided a limit of one million dollars, with a one thousand dollar deductible per loss being assumed by the City at an annual premium of \$1,824.00, guaranteed for a three-year period. Council thought the amount excessive

and directed the Clerk to continue his research in this matter.

Mr. Ken Gross, Principal of the Covington Catholic High School was present to further the project of the Covington Catholic H.S. in its purchase of ground upon which to establish a multi-purpose recreational area. Said ground being the old Kramer Farm lined between St. James Ave., Old State Road, the Dixie Hwy. and the present property of the Covington Catholic H.S. Mr. Gross presented drawings and topographical maps of the area and described for Council the type of installations to be established. Lengthy discussion followed. in which the City Engineer pointed out to Mr. Gross certain changes in the surface drainage of the area which must be complied with in order to protect abutting property owners. The Clerk then directed the attention of the Council to the fact that this request for a Conditional Use, as provided for in the Park Hills Planning & Zoning Ordinance, could only be officially considered by the Park Hills Board of Adjustment, which must follow the table of procedure as provided for in Article 19 of the Park Hills Planning & Zoning adopted June, 1974. The Clerk presented Ord.

to the Mayor and interested Council members copies of the table of procedure. Mr. Gross was also presented with the same, as well as the required copies of the request for a hearing before the Board of Adjustment. The office of the City Clerk would provide the addresses of abutting property owners who must be notified and, upon request, of the Secretary of the Park Hills Bd. of Adjustment, would compose, address and mail the required notices to the abutting property owners concerning the date, time, place and purpose of this board's meeting.

5. Police Chief Ostendorf informed Council that the No. Ky. Information Network would no longer be funded by the Federal Govt. and that its operation would be assumed by the Police Dept. of the City of Covington, beginning March 1, 1977, who would make the services of the Network available to other cities at a charge as yet undetermined.

#### NEW BUSINESS

1. The City Attorney presented Ord. No. 1, 1977, "AN ORDINANCE FIXING THE TAX RATE OF THE CITY OF PARK HILLS FOR THE YEAR 1977 LEVYING A TAX ON ALL REAL AND PERSONAL PROPERTY SUBJECT TO TAXATION FOR GENERAL PURPOSES; FIXING THE DATE OF PAYMENT, AND PROVIDING A PENALTY FOR FAILURE TO PAY SAME AT SUCH TIME". A motion was made by Mr. Gormley and seconded by Mr. Sorrell that Ord. No. 1, 1977, be adopted as read. Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mr. Sorrell, aye, and the motion carried.

- 2. The City Clerk presented Ord. No. 2, 1977, "AN ORDINANCE PROVIDING FOR THE ADVERTISING AND RECEIPT OF BIDS FOR THE PURCHASE OF FIRE HOSE TO BE USED BY THE FIRE DEPARTMENT OF THE CITY OF PARK HILLS, KENTUCKY". A motion was made by Mr. Sorrell and seconded by Mr. Schlothauer that Ord. No. 2, 1977, be adopted as read. Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mr. Sorrell, aye, and the motion carried.
- 3. The City Clerk then presented Res. No. 1, 1977, "A RESOLUTION APPROVING THE ACTION OF THE CITY CLERK-TREASURER IN BORROWING THE SUM OF FIFTEEN THOUSAND DOLLARS (\$15,000.00) FROM THE SECURITY BANK FOR A PERIOD NOT TO EXCEED SIX MONTHS AT AN INTEREST RATE OF EIGHT PERCENT (8%) PRO-RATED DAILY". A motion was made by Mr. Gormley and seconded by Mr. Schlothauer that Res. No. 1, 1977, be adopted as read. Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mr. Sorrell, aye, and the motion carried.
- 4. The City Clerk then presented Res. No. 2, 1977, "A RESOLUTION DESIGNATING THE CITY CLERK-TREASURER AS THE SOLE SIGNATURE NECESSARY FOR DEPOSITS AND WITHDRAWALS FROM THE CITY OF PARK HILLS SANITATION MAINTENANCE AND REPLACEMENT FUND". A motion was made by Mr. McKinley and seconded by Mr. Gormley that Res. No. 2, 1977, be adopted as read. Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mr. Sorrell, aye, and the motion carried.
- 5. Upon inquiry by the City Clerk, Council agreed to continue the issuance of Park Hills Dog Tags. The Clerk pointed out that the sale of the tags had dropped off 50%. The office of the Clerk was directed to have printed and mailed, at the beginning of the next Dog Tag period, cards to dog owners registered with the City, informing them of the necessity of the purchase of such tags.
- 6. The Clerk indicated that the interim agreement made by the City of Park Hills with the S.P.C.A. had expired, but that the arrangement had continued since June 30, 1976. Council approved the continuance, and a motion was made by Mr. McKinley and seconded by Mr. Schlothauer that the City of Park Hills, with the S.P.C.A. for dog control, be indefinitely continued with the agreement to be reviewed annually. Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mr. Sorrell, aye, and the motion carried.

  - c. The Semi-Annual Budget Report of Receipts and Disbursements for the Fiscal Year 1975-76.
  - d. The Report of the Assessed Valuation of the City of Park Hills for the Tax Year 1977, which showed an increase of \$1,334,950.00 over the 1976 valuation.
- 2. Mr. Schlothauer suggested billing the residents for the full charge of the trash collection fee. - 3. Covington Catholic H.S. recreational facility project Mayor Niehaus announced that a preliminary hearing of the Board
  of Adjustment with the prospective developers had been
  held on February 1, 1977, followed on Febuary 10, 1977,
  by the required public hearing for the granting of a
  Conditional Use requested by the Covington Catholic H.S.
  No decision had been rendered at this public hearing and
  the Board of Adjustment was again, on this date, in the
  process of holding a hearing to determine the facts
  relevant to the granting or refusal of this Conditional
  Use Permit.
- 4. Police Chief Ostendorf again discussed Park Hills participation in the No. Ky. Information Network. Beginning March 1, 1977, the operation of the NKIN would be taken over by the City of Covington, the Federal matching grant having expired and not being renewed. The annual cost to the City of Park Hills, as determined by the City of Covington, would be \$1,045.00. Following discussion, a motion was made by Mr. Sorrell and seconded by Mr. Kap pas that the City of Park Hills continue to participate in the NKIN at the price indicated above. Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.

#### COMMITTEE REPORTS

Public Works Dept.

1. In the absence of Councilman Schlothauer, the City Clerk made a report on the cost of snow removal, indicating that to date this cost was more than \$3,000.00, being triple the amount of money budgeted in the Fiscal Year 1976-77.

#### Police Department

- 1. Mr. McKinley submitted the report of the Park Hills Police Dept. for the month of January, 1977, which was received and filed.
- 2. Chief Ostendorf submitted the Annual Report for the calendar year 1976, which was received and filed with thanks.

#### Fire Department

1. Chief Dreyer made an oral report of the activities of the Park Hills Volunter Fire Dept. for the month of January, 1977.

### Finance Department

- 1. A motion was made by Mr. Gormley and seconded by Mr. McKinley that the following Finance Dept. reports, as prepared by the City Treasurer, be approved as submitted.
  - A. The report of the General Fund for the month ending January 31st.
  - B. The report of Expenditures for the 7th month of the Fiscal Year 1976-77.

The Clerk then presented to Council a report of expenditures authorized from the Federal Revenue Sharing Fund, which indicated that with payment already made for purchases received and the payment for purchases ordered and earmarked for payment from Federal Revenue Sharing Funds, that the Budget would be exceeded by several thousand dollars. He further emphasized that there would be no Federal Revenue Sharing Funds available for additional purchases for the balance of the Fiscal Year ending June 30, 1977.

- 2. The Clerk then informed Council that from letters received from the Federal Revenue Sharing office, it appeared that the amount received by the City of Park Hills for the entitlement period beginning January 1 through September 30, 1977, would be \$13,776.00. This represented a decrease of approximately \$5,000.00 from funds received in the last entitlement period.
- 3. The Clerk-Treasurer informed Council that due to the inclusion of the Rescue Squad expenditures in the Budget, the high cost of snow removal and other increased cost factors that it was necessary that no expenditures be made from the General Fund, which were not absolutely essential. The Mayor cautioned the Department Heads against any additional spending other than the normal routine maintenance and fixed charges.
- 4. The Clerk announced that he had been informed that Mr. Konstantine Petridis, owner of Dino's Lounge on the Dixie Highway, was transferring his Park Hills Liquor & Beer Carry-out License to a Mr. Larry Wise, but that the transfer had not been made since clearance of Mr. Wise had not been secured through the Police Dept. A motion was made by Mr. Gormley and seconded by Mr. Sorrell that the Clerk be directed to issue the transfers when clearance had been received from the Park Hills Police Dept. Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mrs. Schmits, aye; Mr. Sorrell, aye, and the motion carried.

#### Rescue Squad

1. Mr. Kappas stated that at this time he had no report.

### City Engineer-Zoning Administrator Report

- 1. Mr. Earl Paul reported briefly on the matter of the Conditional Use Request made by the Covington Catholic H.S. and referred to the earlier part of these minutes.
- 2. He indicated that he was in contact with an owner who wished to build a house on Park Hills subdivision Lot No. 160, located at the intersection of Emerson and Breckinridge Roads. The plans as submitted would require a dimensional variance so the matter would be presented to the Park Hills Board of Adjustment for a hearing in this matter. The Clerk pointed out that under the new Zoning Ordinance the Board of Adjustment has the authority to make a dimensional variance of 50% instead of 25%, as under the old ordinance.

#### PETITIONS AND DELEGATIONS

- 1. Mr. Steve Bankamper, who had requested a hearing before the Council, for an installation of a Parking Pad across the street from his residence at 1045 Hamilton Avenue, failed to make an appearance and no action was taken in this matter.
- Mr. Mal Malone of Lawton Road, told Council that public advertisement as well as his personal inquiry, had revealed the fact that the property owned by Martha Butler, and which had been rezoned several years ago as an area for the development of a PUD area, was now offered for sale and inquired what effect a sale would have on the contract existant between the City of Park Hills and Martha Butler and Wm. P. Butler for the development of a condominium project on the site. The Clerk secured for the City Attorney all papers, including the contract between the City of Park Hills and the contractor, Wm. P. Butler, developer, for his study in determining if said contract and agreement between the City and the Butlers would be valid in case of a transfer. Following preliminary examination of the documents, the City Attorney told Council that it appeared that said contract was valid only between the City and the Butlers for the project as designed and approved by the City Council&that any transfer of the property did not include the transfer of all rights incurred upon the Butlers by the City. The City Attorney, however, agreed to study the papers in detail and report back his findings at a later meeting with Council.

#### BUILDING REPORTS

The City Clerk announced that one permit had been issued to Covington Catholic H. S. for grading on their own property in action approved by the City Engineer-Zoning Administrator.

#### COMMUNICATIONS

Public Liability Insurance protecting members of the City Council and the City Clerk. Mr. Frank Gross of Ft. Thomas had supplied figures, indicating that said insurance with one million dollar liability would be \$1,824.00 per annual premium. The Clerk indicated that he had contacted Mr. Gross concerning lesser liability limits, but had been informed that another underwriter would write said policy with a limit of \$100,000.00 at an annual premium of \$2638.00. In view of the financial situation of the City it was decided to take no action in this matter.

THE CITY COUNCIL OF THE CITY OF PARK HILLS MET IN REGULAR SESSION AT THE PARK HILLS CITY BUILDING ON MONDAY, MARCH 14, 1977, AT 8:00 P.M. WITH MAYOR NIEHAUS PRESIDING AND COUNCILMEN GORMLEY, KAPPAS, McKINLEY, SCHLOTHAUER, SCHMITZ AND SORRELL PRESENT.

The minutes of the February 14, 1977 meeting were approved as submitted.

#### OLD BUSINESS

- 1. Public Liability for the Rescue Squad Chief Dreyer informed Council that he was in the process of completing the application, which he would give to the Clerk for transmittal to the agent supplying this insurance.
- 2. The Mayor reported that the Board of Adjustment had granted the variance requested by the Covington Catholic High School for the purpose of a multi-purpose recreational field and the project was under way.

#### NEW BUSINESS

- 1. The Clerk reminded Council of the necessity of the passage of a resolution setting forth those streets to be resurfaced under the State Aid Road Fund. The Mayor and the City Engineer agreed to prepare the papers for presentation to the State Highway Dept.
- 2. The Clerk presented a report to Council on the collection of the Park Hills Sanitation Charge. To date \$3,638.43 has been collected, with \$139.63 unpaid.

#### COMMITTEE REPORTS

Public Works Dept.

1. The Mayor reported that he had contacted a contractor, Hartberger Enterprises, relative to the patching of the holes in the streets as a result of the bad winter weather. This was declared to be an emergency situation which could not wait for the receipt of bids and it appeared that the cost of this project could not be paid out of the State Aid Road Fund. The City Clerk-Treasurer was directed to pay the cost, estimated to be approximately \$1100.00, from such funds as he might find available.

### Police Department

- Mr. McKinley presented the report of the Park Hills Police Dept. for the month of February, 1977, which was received and filed.
- Upon the request of the Mayor, the City Clerk read a letter from the Regional Enforcement Narcotics Unit expressing high commendation for the activity of Chief Ostendorf in the enforcement of the Narcotic Laws. A copy of the letter was given to the Chief for his file.
- Chief Ostendorf reported that the LEEA Grant requested by the City of Park Hills for the installation of a portable alarm system had been approved by the State of Kentucky authorities. Final approval must be made by the Federal authorities before the grant is made. The City will contribute approximately 6% of the total grant.

### Fire Department

- Mr. Sorrell presented the report of the Park Hills Volunteer Fire Dept. for the month of February, 1977, which was received and filed.
- Fire Chief Dreyer reported that air masks, cylinders and brackets, for which had been awarded at the last meeting, had been received and installed on the salwage unit. He indicated that the following bid items had not yet been received:

3. The City Clerk issued to Council a memo suggesting that in the light of the increased Homestead Exemption allowance, that in the tax year 1978 the tax rate be increased from \$3.45 per thousand to \$3.60 per thousand to make up the revenue loss to the City as the result of Homestead Exemptions.

#### Rescue Squad

- 1. Mr. Kappas presented the reports of the Rescue Squad for the months of January and February, 1977, which were received and filed.
- 2. Rescue Squad Chief Mark Dreyer gave a resume of the training of the present members of the Rescue Squad. THE CITY COUNCIL OF THE CITY OF PARK HILLS MET IN REGULAR SESSION AT THE PARK HILLS CITY BUILDING ON MONDAY, APRIL 11, 1977, AT 8:00 P.M. WITH MAYOR NIEHAUS PRESIDING AND COUNCILMEN GORMLEY, KAPPAS, McKINLEY, SCHLOTHAUER, AND SCHMITZ PRESENT.

COUNCILMAN SORRELL ABSENT BEING OUT OF THE CITY.

A motion was made by Mr. McKinley and seconded by Mr. Gormley that the minutes of the March lith meeting be approved as submitted. Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs. Schmitz, aye, and the motion carried.

#### OLD BUSINESS

- 1. Covington Catholic High School Recreational Facility The Mayor reported that no work had been done on this
  project for several weeks. His inquiry to the Park Hills
  City Engineer revealed that Mr. Paul had been informed
  that due to the inclement weather the project had been
  temporarily halted. The Mayor and Councilmen discussed
  the run-off of water during the recent heavy rains, the
  result of the denuding of the area. Mud and water had
  washed into certain properties on the Dixie Highway,
  largely as the fault of erosion. Council requested that
  the City Attorney write the project developers, indicating
  the dissatisfaction of the City with the project in its
  current stage and requesting that work be started as soon
  as possible to provide protection for the abutting area.
- 2. The City Clerk announced that the mal-practice insurance covering the Park Hills Rescue Squad was now in full force and effect at a cost of \$375.00 per year.
- 3. The Clerk read Resolution No. 4, "A RESOLUTION FOR PARTICIPATION IN THE KENTUCKY LAW ENFORCEMENT FOUNDATION PROGRAM". A motion was made by Mr. McKinley and seconded by Mr. Schlothauer that Resolution No. 4, 1977, be adopted as read. Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs. Schmitz, aye, and the motion carried.
- 4. The Clerk informed Council that the application to the Ky. State Hwy. Dept. for State Aid Road Improvement Funds must be completed no later than June 1. The Mayor, Councilman Schlothauer and the City Engineer were designated to provide the names of those streets to be improved under this program so that the formal application might be prepared in time and the necessary resolution adopted.

- 5. Street Patching Program As a result of the very bad weather the program of repairing chuck holes in the City streets had been given to the Hartberger Enterprises since the task, due to the weather, was beyond the capabilities of our own Public Works Dept. employees. The Mayor reported that the project was virtually completed and members of Council were of the opinion that the job had been well done.
- 6. LEEA Grant Police Chief Ostendorf reported that the application for a grant for the purchase of a Tactical Alarm System had been approved by the proper authorities and that the equipment under the grant was being ordered to make this system operative.

#### NEW BUSINESS

- The City Clerk presented Resolution No. 3, 1977, "A RESOLUTION APPOINTING CALVIN KUMMER AS A MEMBER OF THE BOARD OF ADJUSTMENT OF THE CITY OF PARK HILLS FOR A FOUR YEAR TERM ENDING JUNE 30, 1981". A motion was made by Mr. McKinley and seconded by Mr. Gormley that Resolution No. 3, 1977, be adopted as read. Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs. Schmitz, aye, and the motion carried.
- 2. Following the passage of the resolution, City Attorney Gettys suggested that consideration be given to providing for regular monthly meetings of the Park Hills Board of Adjustment, at which time persons seeking dimensional or conditional variances would have the opportunity of making a preliminary appearance before the Board. He felt, from recent experience, that this would implement the work of the Board in meeting the needs of petitioners. Lengthy discussion followed and the Mayor agreed to bring the matter to the attention of the Chairman and Secretary of the Board of Adjustment.
- 3. Mr. McKinley suggested that an "Information Card", setting forth vital City numbers be printed and distributed to all Park Hills residents. This policy had been in effect within this City, but had been abandoned when the commercial firm, providing funds for same, had withdrawn its offer. Mr. McKinley agreed to bare the expense of such card in return for advertising on same for his place of business. Following discussion, Mr. McKinley was directed to prepare a sample of such card for presentation at the May meeting of Council.

- 4. A motion was made by Mr. Schlothauer and seconded by Mr. McKinley that the Park Hills Civic Association be granted permission to hold a Memorial Day Parade within the City on May 30, 1977. Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mr. Scholthauer, aye; Mrs. Schmitz, aye, and the motion carried.
- The Clerk read the bid of Scott Knochelman and Tom Hellmann, who offered to paint the exterior of the City Building, including trim, doors, gutters, etc., but excluding the stucco portion of the building, for a price of \$800.00. Upon inquiry to the City Attorney, he suggested that a contract be drawn up, making Messrs. Knochelman and Hellmann independent contractors, this being done to relieve the City of any personal liability that might result in the operation. A motion was made by Mr. McKinley and seconded by Mr. Schlothauer that the City enter into such contract with the contract to be prepared by the City Attorney, including all items to be furnished and all work to be done by the bidders. - 1. Mr. Robert Ruh of 1014 Rose Circle appeared before Council seeking permission to install a retaining wall along his front yard and driveway. Following discussion as to the width of the City right-of-way, the matter was referred to Mr. Earl Paul, as the Building Inspector. Mr. Ruh, being present, was directed to contact Mr. Paul.
- 2. Mr. Joseph King, one of the owners of Poppa's Familee Tree Restaurant of 1504 Dixie Highway, appeared before Council concerning the deletion, change and/or erection of a new fascade sign. Since this item is covered in the Park Hills Zoning Ordinance, Mr. King was also directed to contact Mr. Earl Paul the City Bldg. Inspector, to secure the necessary permits.

#### COMMITTEE REPORTS

#### Public Works Dept.

1. Mayor Niehaus indicated that the street patching had been the major event within this department within the past month.

#### Police Department

 Chief Ostendorf indicated that due to the pressure of other work, he had not prepared a report of Police activities during the month of March, 1977.

### Fire Department

- l. In the absence of Councilman Sorrell, Fire Chief Frank Freyer presented the report of the Park Hills Vol. Fire Dept. for the month of March, 1977, which was received and filed.
- 2. Chief Dreyer also reported that the following bid items for the benefit of the Fire Dept., had been received:

Portable Radio two-way

3. Ass't. Chief Mark Dreyer gave a brief report of his attendence at the Fire Instructors Conference held in Memphis, Tenn., March 21 through 25.

#### Finance Department

- 1. A motion was made by Mr. McKinley and seconded by Mr. Gormley that the following reports, as prepared by the Clerk-Treasurer, be accepted as submitted:
  - a. Report of the General Fund for the month of March, 1977
  - b. Report of Budget Expenditures for the 9th month of the Fiscal Year 1976-77
  - c. The Budget Report for the Third Qtr. of the Fiscal Year 1976-77

Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs. Schmitz, aye; and the motion carried.

2. The City Clerk informed Council that effective January 1, 1978, all employees of the City must be covered by unemployment insurance, same to be paid for by the City on all employees. The rate set being 2-7/10% of all salaries with a maximum of \$6,000.00 subject to taxation. An alternate plan would provide that in lieu of the payment of the percentage, as indicated, that the City would be responsible for the payment of unemployment compensation at the rate and the limit as provided by law. He indicated that this would be an extra drain on the Park Hills Budget.

- 3. The Clerk also informed Council that a new Federal requirement provided that at the time a budget is prepared for the expenditure of Federal Revenue Sharing Funds, that said meeting shall be open to the Public and that proper advertisement shall be inserted in a daily newspaper in general circulation within the area of Park Hills.
- 4. The Clerk announced that to the present time, 1690 anto stickers had been issued. He also indicated that cards have been sent to all delinquents on record and that a heavy response had been received, indicating either payment, the removal of the recipient from the City of Park Hills or that said car had been disposed of by its former owner. The Clerk was directed to continue his efforts and in due time present to the Police Dept. for its action the names of those persons deemed to be liable for the purchase of said sticker.
- 5. The Clerk also introduced the matter of the required twenty percent increase in the assessed valuation of real estate within the City in keeping with the 100% valuation law enacted by the State Legislature. However, the Clerk indicated that the 1977 bills would not reflect this 20% increase since the law requires the assessment date as of January 1, of the tax year. Again discussion followed, and the Council took no action on this matter at this time.
- 6. The City Clerk-Treasurer introduced the matter of a salary increase for full-time members of the Police Dept., effective July 1, 1977. The approval of the City Council being necessary in order that the 1977-78 Budget might be adequately prepared. The Clerk informed Council that considering the possible revenue of the City for the next Fiscal Year, that he was proposing an increase in the base pay for all full-time policemen of \$480.00 per year. With the added Police Incentive Pay, the annual total increase for each member would be \$552.00. The salaries set were as follows:

Chief of Police - \$13,580.40
Lieutenant - 9,056.40
Full-time Patrolman - 8,780.40

Following discussion, Council gave the opinion that the amounts as set forth by the Clerk-Treasurer were reasonable and a motion was made by Mr. Kappas, seconded by Mr. McKinley that the figures as set forth above be considered in the preparation of the Budget for the Fiscal Year 1977-78. Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs. Schmitz, aye, and the motion carried.

The Clerk pointed out that an ordinance must eventually be adopted before the salaries could be officially set. Discussion as to the possibility of increasing the clothing allowance, as a fringe benefit, was introduced and the Treasurer was directed to determine if such would be economically feasible based upon the City's income.

The treasurer also informed Council that in figuring overtime pay, it would be necessary to include Police Incentive Pay and that such overtime pay would not be based upon the base salary, as provided by the City of Park Hills.

#### Rescue Squad

- 1. Mr. Kappas presented the report of the Park Hills Rescue Squad for the month of March 1977, which was received and filed.
- 2. Rescue Squad Chief Mark Dreyer gave additional information on the training process for members of the Rescue Squad.

#### CITY ENGINEER-ZONING ADMINISTRATOR REPORT

- Informed Council that the Park Hills Board of Adjustment had granted a dimensional variance to Gordon and Jill Wade for the construction of a residence at the corner of Emerson and Breckinridge Roads.
- 2. He discussed with the City Council miscellaneous building applications received during the month of March.

#### BUILDING PERMIT REPORT

The Clerk announced that during the month of March two building permits had been approved by the Bldg. Inspector and that the Clerk had issued the necessary written permits.

The Clerk then presented a series of bills payable.

THE CITY COUNCIL OF THE CITY OF PARK HILLS MET IN REGULAR SESSION AT THE PARK HILLS CITY BUILDING ON MONDAY, MAY 9, 1977, WITH MAYOR NIEHAUS PRESIDING AND COUNCILMEN GORMLEY, KAPPAS, McKINLEY, SCHLOTHAUER, SCHMITZ AND SORRELL PRESENT.

A motion was made by Mr. McKinley and seconded by Mr. Sorrell that the minutes of the April 11, 1977 meeting be approved as submitted.

## OLD BUSINESS

- 1. Covington Catholic H.S. Recreational Facility The Clerk read a letter written by the City Attorney to Mr. Kenneth Gross, Principal of the Covington Catholic H.S., enquiring as to the reason for the delay working toward the completion of this project. Council had become concerned about the unsightly appearance of the area. He told Council that a reply had been received from the Covington Catholic H.S. in which it was indicated that the matter was being implemented toward completion.
- 2. The State Aid Road Program City Engineer Paul indicated that in cooperation with Mayor Niehaus and Councilman Schlothauer that those streets to be included as possibilities for resurfacing under the State Aid Road Program had been determined and the necessary papers filed with the Ky. State Highway Dept., which, in turn, would prepare the necessary resolution for adoption by the City Council in this matter. Mr. Paul indicated that in the list of streets prepared no priority had as yet been established. The City Council, upon receipt of approval of its program by the Ky. State Hwy. Dept., would then establish a priority list dependant upon the need of repair and the amount of money available.
- 3. Mr. McKinley introduced a sample of the information card to be distributed to residents of the City. Mr. McKinley had agreed to furnish same at no cost to the City in return for advertising. The matter of distribution was discussed and the Clerk was directed to prepare the necessary information to be presented to Mr. McKinley for printing. The matter of distribution was discussed and Council decided to make a decision in this matter following the receipt of the information card.
- 4. The City Clerk informed Council that the contract for the painting of the City Building had been prepared by Mr. Gettys, signed by both parties to the contract, and said work was now in progress.

#### PETITIONS AND DELEGATIONS

- Mr. Donald Wilder of 1207 Old State Road appeared before L. Council requesting permission to establish a parking pad for parallel parking on the City right-of-way. Mr. Wilder, who had contacted the City Clerk, had been advised to appear before Council. Upon receipt of the information the Clerk had contacted Mayor Niehaus, who had examined the situation and found that there was no other way in which adequate parking for motor vehicles could be established. In his opinion, this request should be granted, provided same was in keeping with the ordinances of the City of Park Hills. The Mayor then appointed a committee, consisting of himself, Councilwoman Virginia Schmitz and the City Engineer, to review the project. Council empowered said committee to grant permission for the installation of the pad if, in their opinion, no other means of providing parking space was available.
- 2. Mr. Robert Kaelin of Rosemont Avenue told Council that several residents of his area had been given warning tickebs for going through the second red light after making a right turn on the red light at the intersection of So. Arlington Road and the Dixie Highway. Mr. Kaelin expressed the opinion that this was the proper procedure. Chief Ostendorf, in reply, indicated that while the right turn was legal, going through the second red light was an illegal act, not permissible under State law, and that no permission to do so could be granted by the Police authority. If permission were granted, illegally, the City could become a party to a damage suit if an accident occurred as the result of this action. Council concurred with Chief Ostendorf's decision and would ask the Civic Association to publish this item in the next issue of its publication, "The Hub".
- 3. Mrs. Ralph Kunkemoeller, representing the Civic Association of Park Hills, requested permission to use the park area between Hamilton Road and Amsterdam Road for a family picnic to be held under the auspices of the Civic Association on July 4, 1977. She also requested permission to use the Memorial Park on Park Drive as an area for an Arts & Craft Show to be held the same day. In addition, she requested that Hamilton Road, from Park Drive to the Arlington Road crossover, be closed on this day. A motion was made by Mr. Schlothauer and seconded by Mr. Mc inley that the request, as made, be granted. Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion granted.
- 4. Mr. Mike Burch of the P. H. Civic Assn. asked that the Council give consideration to the purchase of the Butler property for the establishment of a recreational facility.

Mr. Schlothauer read a letter from Miss Ruth Klette, President of the Civic Association., asking that a feasibility of said purchase be made by the Park Hills City Council. Councilman Kappas said, that at the request of the Civic Assn., he had contacted the owner of the property plus the No. Ky. Area Development, who had indicated to him that Federal Grant money might be available on a matching basis to purchase this property as a recreational facility. Mr. Kappas proposed that if the City could acquire said property that baseball diamonds, tennis courts, outdoor basketball courts, picnic areas and playground equipment be provided. The price of the area being \$150,000.00, which, if a Grant were available, would make the City's portion \$75,000.00. He indicated that the request must be made by June 1st for the Federal Grant.

Mayor Niehaus, who had been previously informed by Mr. Kappas of this proposal, had, at the time, requested that the City Treasurer provided figures as to the financial feasibility and ability of the City to provide its share of the necessary funding. The City Treasurer then presented the following report:

- 1) That recreational uses of land in this zone was a Conditional Use and would require approval by the Park Hills Bd. of Adjustment, after the holding of the necessary public hearings as required by the Park Hills Zoning Ordinance.
- (2) That to raise the City's share of the funding two courses were open: (a) The matter to be put upon the ballot to be voted upon as a bond issue by the citizens of Park Hills; and (b) That the City borrow from a financial institution its share of the funding to be repaid over a period of 10 years.
- (3) That in the City's share at least \$25,000.00 must be added for the preparation of the area, the creation of the ball field and tennis courts and the purchase of playground equipment.
- (4) That the tax levy, in either case, must be an ad Valorum tax, based upon the assessed value of each piece of Real Estate within the City of Park Hills.
- (5) That it probably would be necessary to demolish the present residence on the acreage.
- (6) That based on an estimated cost to the City of \$100,000.00, amortized over a ten year period at a projected 6% interest rate, that the total cost of the project, including the interest, to be paid by the City would be \$133,000.00. That to pay off the bonds or amortize the loan, that a rate in excess of 55% per \$1,000 valuation must be charged and added to the tax rate.

(7) Pointed out that after the acquisition of the property and the establishment of a recreational facility, that it would become encumbent upon the City to provide funds for operation. He indicated that \$3,000.00 per year would be an absolute minmum. Mr. Kappas, in reply, said that he thought it would be a larger sum.

Lenghty discussion followed by members of Council and members of the divic Association who were present. In view of the fact that a June 1 deadline exists, it was felt imperative to take the preliminary step in filing the necessary application for a Federal Grant, whereupon the following motion was made by Mr. McKinley and seconded by Mr. Sorrell that Mr. Kappas be permitted to file the application for the necessary Federal Grant without committing the City, at this time, to accept the Grant or provide City funding if said Grant were allowed. Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.

### NEW BUSINESS

- 1. Councilman McKinley complained about the unsightly condition of that portion of the Kremer Farm still owned by Glenn Caldwell and Olga Wooten. Debris existed along the Old State Road and the grass needed to be cut. The City Clerk was directed to write a letter to Mr.Caldwell, asking that he clean up the area. In addition, the City Clerk was directed to have the Public Works Dept. erect a "No Dumping" sign at this location.
- 2. Mr. Schlothauer invited members of the Council to participate in the Park Hills Civic Assn. Memorial Day parade and celebration on May 30th.

Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.

- Covington Catholic H. S. Recreational Facility Was reported that work was continuing on the establishment of the play field. The City Clerk reported some concern voiced by residents of St. James Avenue that the normal surface drainage from Old State Road into this area was being obstructed by the earth moving. The City Engineer replied that the drainage pipe required under the permit issued was to be put in after the field was leveled. He was directed by Council to check into the area to determine the extent of possibility of water damage to the residents in the area. The Clerk further reported that as provided for in the Zoning Ordinance for Conditional Use Permits, that he had sent the Covington Catholic H. S. a bill for legal services rendered in connection with this project. This had been sent out on May 26th. To date there has been no response.
- 2. Mr. John Kappas reported that he had contacted Mr. William Butler on the possibility of the City acquiring the Butler property to be turned into a recreational facility by the City of Park Hills. A portion of the cost being met by Federal matching funds on a 50-50 basis. reported that Mr. Butler showed little interest in dealing with the City since the sale would be dependant upon affirmative action by the Council, plus the receipt of Federal grant. The date for filing the Federal grant passed, thus precluding the possibility of the City's acquisition of the property. The entire matter has therefore been laid aside. Mr. Kappas stated that he examined two other areas; one off of Audubon Road, the other off of Exter Drive, but that these areas were not suitable for a multi-purpose recreational facility developed by the City.
- The Clerk presented Resolution No. 5, "RESOLUTION ADOPTING AND APPROVING THE EXECUTION OF A CONTRACT BETWEEN THE INCORPORATED AREA OF PARK HILLS LOCATED IN KENTON COUNTY AND THE BUREAU OF HIGHWAYS, COMMONWEALTH OF KENTUCKY, FOR THE FISCAL YEAR BEGINNING JULY 1, 1977 AS PROVIDED IN THE KENTUCKY REVISED STATUTES AND ACCEPTING ALL STREETS LISTED THEREIN AS BEING STREETS WHICH ARE A PART OF THE INCORPORATED AREA OF PARK HILLS." A motion was made by Mr. Schlothauer and seconded by Mr. McKinley that Res. No. 5 be adopted as read and that the Clerk be directed to file the necessary papers with the State Hwy. Dept. in the implementation of said resolution. Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.
- 4. Mr. McKinley presented to the City for distribution the Emergency Telephone Number Card. Distribution was arranged through Mr. Sorrell, who agreed to take all of the west side of the Dixie Hwy. except the apartment buildings, Mr. McKinley agreed to distribute same in the apartment complexes, Old State Road from Terrace to the corporation limit, Terrace Drive and Altavia Ave.; Mr. Schlothauer to

distribute on Cleveland, Park Drive, Morgan Court, Emerson Road, Breckinridge Road, Jackson Road, upper Montague Road, Rose Circle; Mrs. Schmitz the Dixie Hwy., Arlington to Old State, Old State to Terrace, Aberdeen Road, Alhambra Court, Coram and Harriet Streets; Mr. Mark Dreyer agreed to secure aid for the balance of the streets within the City.

- 5. Mr. Don Wilder of 1207 Old State Road, who had requested permission to establish a parking pad at this address on the City right-of-way, parallel to Old State Road, presented a plot plan showing the location of such proposed plan. This area had been examined by Mrs. Schmitz and Mayor Niehaus, who had been designated as a committee to inspect the site. Each indicated approval of this project and a motion was made by Mr. McKinley and seconded by Mr. Schlothauer that the Council grant approval. Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.
- 6. The matter of the continuation of the contract for dog control with the SPCA was introduced by the Clerk. Chief Ostendorf asked that the service be continued since he thought that the dog problem within the City had been materially reduced, and the Clerk was directed to continue payment without further contract, on a month to month basis.

### NEW BUSINESS

- 1. The Clerk introduced the adoption of the Federal Revenue Sharing Budget for the Fiscal Year 1977-78, beginning July 1, 1977. This Council meeting had been selected as the required public hearing meeting on the Federal Revenue Sharing Budget, the required legal notification having been inserted in the Kentucky Post. Following a study of the allocations of money to the various departments, this Budget, as prepared by the Clerk-Treasurer was up for adoption, and a motion was made by Mr. Sorrell and seconded by Mr. Kappas that this Federal Revenue Sharing Budget be adopted as prepared. Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.
- 2. The Clerk had been requested by Council to provide personal accident insurance for members of the Park Hills Rescue Squad. He told Council he had been successful in securing same through an agent of the United States Fidelity and Guaranty Co. at a cost of \$649.00 a year. The terms of the policy were read to Council and a motion was made by Mr. Schlothauer and seconded by Mrs. Schmitz that the recommendation of the Clerk be adopted and the policy continued in full force. Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.

- 3. The Clerk informed Council that the agent for the Fire Dept. personal liability policy had informed him that the premium had been increased greatly. This policy having been written by the Reliance Insurance Co. The agent had suggested that the policy be rewritten in another company. The provisions of this policy would provide a \$20,000 Death Benefit for accidental death and a disability payment of \$100.00 per week for 260 weeks at an annual premium of \$570.00. A motion was made by Mr. Schlothauer and seconded by Mrs. Schmitz that the Clerk be directed to implement this policy. Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs. Schmitz, aye; Mrs. Schmitz, aye; Mrs. Sorrell, aye, and the motion carried.
- 4. The Clerk announced that bids had been advertised for surveillance equipment under an LEAA Grant for the benefit of the Park Hills Police Dept. No bids were received, which permits the Park Hills Police Dept. to purchase such equipment on the most favorable terms without additional competitive bidding. The Clerk announced that a check from the Federal Gov't. in the amount of \$5,288.00 had been received, leaving the City's portion \$584.45, to be paid out of the total estimated cost of \$5,872.45.
- Mr. McKinley introduced the question of Fire Safety in various places of assembly within the City. He proposed that each such establishment be examined and that a sign be posted in each assembly room, indicating the maximum number of persons allowed in the area. State Statute requires the posting of such signs. Council requested the Chief of the Fire Dept. to investigate the matter, and a motion was made by Mr. Schlothauer and seconded by Mr. McKinley that this program be followed through. Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried. Mr. McKinley also requested that steps be taken to prevent the Covington Catholic H. S. from chain-padlocking the exit doors while classes were in session and while the area was being used for recreational purposes. Council directed the City Attorney to write the principal of the Covington Catholic H. S., setting forth the facts.

#### COMMITTEE REPORTS

#### Public Works Dept.

1. The Mayor reported that the Hahn riding mower needed extensive repair, beyond the actual value of such mower. The Mayor and members of the Public Works Dept. had been investigating the possibility of a tractor-type mower. It appeared that the approximate cost of such equipment would be between \$1800 and \$1850 dollars. A motion was made by Mr. Sorrell and seconded by Mr. Schlothauer that a committee consisting of Mayor Niehaus, Councilman Schlothauer and the employees of the Public Works Dept. be directed to purchase a tractor-type mower and that payment for such be made by the City Treasurer at his

discretion from such funds as might be available. Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs. Schmitz, aye: Mr. Sorrell, aye, and the motion carried.

2. Mr. Sorrell also brought up the question of the unsightly condition along the Dixie Hwy. due to uncut weeds and the parking of automobiles being repaired at the Ft. Mitchell Garage. Mr. Schlothauer volunteered to contact the owners of the Ft. Mitchell Garage, requesting them to take necessary steps to eliminate this eyesore.

### Police Department

- Mr. McKinley presented the monthly report for May, 1977, of the Park Hills Police Dept., which was received and filed.
- Chief Ostendorf pointed out the need to secure additional 2. part-time patrolmen, particularly to fill in vacation and school periods. He indicated to Council that he would have a report on this matter at a later date.
- A motion was made by Mr. McKinley and seconded by Mr. Schlothauer that the Chief of Police enter into an agreement with the Ky. State Purchasing Dept. to secure one 1977 Ford automobile to be used as a replacement for the present marked cruiser. Specifications to be provided by the Chief of Police and payment for some to be made from Federal Revenue Sharing Funds. Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried. The plan to convert the present 1976 cruiser into an unmarked car and to dispose of the present unmarked car to the highest bidder was approved by Council.
- The Chief was directed to purchase a hand-held radar with 40 payment to be made from the Federal Revenue Sharing Fund.
- 5. The Chief was to present to the Clerk a list of the traffic control signs required within the City.

## Fire Department

Mr. Sorrell presented the report for May, 1977, of the Park Hills Vol. Fire. Dept., which was received and filed.

The Clerk-Treasurer presented for study an adoption the l. proposed budgets for the Fiscal Year 1977-78, effective July 1, 1977.

#### OLD BUSINESS

- Dixie Highway unsightly conditions The Clerk and/or Mayor had contacted several of the owners in an effort to get the area cleaned up, only partial success was apparent and the matter was referred to the Chief of Police to determine if the matter could be resolved.
- 2. Chief of the Fire Dept., Frank Dreyer, reported that on his last inspection cards which had been furnished to the Town & Country Restaurant, setting forth the limit of occupancy in each room, had not as yet been displayed. Council directed the Chief to pursue the matter in having the cards put up to comply with the law.
  Contact had been made with the State Fire Marshall's Office in this matter.
  Other area places of assembly are to be furnished with the cards by the Fire Dept., who will determine the occupancy limits.
- 3. Covington Catholic H. S. Recreational Facility The Mayor reported that the slide in the earth adjacent to Old State Road was being taken care of by the contractor in this matter. A sprinkler system was being installed in the new field and it was hoped that with this installation grass could be grown in the entire area to prevent further erosion. In the matter of the bill sent to the committee in charge for legal services rendered by the City Attorney, the Clerk reported that he had been contacted by one of its members. but that no payment of the bill had been made to date. The matter of flooding of the Dixie Hwy. area, as a result of the construction of this field, had been investigated by the Mayor who would meet with Mr. & Mrs. Joseph Schmitz. who were the recipients of most of the flooding. At this meeting it would be determined what additional steps could be taken by the City and/or owners to aleviate this problem.

#### NEW BUSINESS

1. The City Clerk presented Ordinance No. 5, 1977, "AN ORDINANCE PROVIDING FOR THE LETTING AT PUBLIC BID OF A CONTRACT FOR THE DOLLECTION AND DISPOSITION OF GARBAGE, ASHES, CINDERS AND OTHER REFUSE IN THE CITY OF PARK HILLS, KENTUCKY." A motion was made by Mr. Sorrell and seconded by Mr. Gormley that Ord. No. 6, 1977 be adopted as read. Mr. Gormley, aye; Mr. Kappas, aye; Mr. Schlothauer, aye; Mr. McKinley, aye; Mrs. Schmitz, aye, Mr. Sorrell, aye, and the motion carried.
- The Clerk presented Ordinance No. 7, 1977, "AN ORDINANCE PROVIDING FOR THE ADVERTISING AND RECEIPT OF BIDS FOR THE PURCHASE OF AIR MASKS AND ACCESSORY EQUIPMENT THERETO TO BE USED BY THE CITY OF PARK HILLS FIRE DEPARTMENT".

  A motion was made by Mr. Sorrell and seconded by Mr. Schlothauer that Ord. No. 7, 1977 be adopted as read. Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.
- 4. The Clerk-Treasurer then introduced to Council the matter of the Statutory Regulations requiring a reappraisal of the property subject to Municipal Taxation to the 100% valuation. He presented a detailed study as follows:
  - 1. The Kenton County Property Evaluator had adopted the following schedule:
    - (a) an increase of 20% of all real estate purchased before 1971
    - (b) an increase of 15% in the valuation for property purchased between 1971 and 1974
    - (c) for property purchased after 1974 no increase

It was indicated that there would be no reduction in the County taxes, thus subjecting many residents to a substantial increase in real estate taxes.

- 2. The Clerk suggested that in view of the great number of single-family dwellings, having Homestead Exemptions, many of whom were on fixed income, that any action taken by the Council take into consideration the ability to pay of this group of citizens.
- 3. The Clerk then made the following suggestions:

  (a) that a blanket increase of 15% be levied against all real property purchased before 1974 and that no increase in valuation be levied against houses purchased after 1974.

  This suggestion being set forth because of the inflated prices of real estate purchased since 1974.

  The Clerk presented to Council a sampling of approximately 10% of the total residential units within the City, which showed that if the increase were made, as provided above, and a compensatory reduction made in the rate to be

levied to the 1978 taxes, that the City would realize approximately the same amount of money as collected from real estate taxation in 1977.

The Clerk further indicated that a study of the substantial sampling submitted indicated that the rate to be reduced from the present 342/2.

per \$100.00 valuation to 32@ per \$100.00 valuation, without decreasing the total tax collection for the year 1978. However, since the tax rate could not be set until January 1, 1978, Council was not bound to any specific reduction in rate.

Lengthy discussion followed, and a motion was made by Mr. McKinley and seconded by Mr. Gormley that the Clerk-Treasurer be directed, in his capacity as City Assessor, to make a flat increase of 15% in the value of all real estate purchased before 1974 and that Council, when the 1978 rate was set, would consider a compensatory reduction in the rate. Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.

- 5. The Clerk informed Council that it was the plan of the Sanitation District to install major sewer line from the present Park Hills Disposal Plant to the interceptor collector sewer now serving most of the County. When this project was completed the present Park Hills Disposal Plant, currently leased to the Sanitation District and built on property of easement from the City of Covington, would revert to the City of Park Hills and that some plans for its disposition or demolition must be made. Since the new sewer line was still in the engineering stage, Council felt that no action need to be taken immediately and the matter was tabled.
- 6. The Treasurer informed Council that after consultation with the Mayor, the pledge made for the continuation of TANK, amounting to \$2,562.08, had been paid from the General Fund. Originally, Council had agreed to pay this sum from the Federal Revenue Sharing Fund, but a Federal Grant received by TANK made this step impossible, since under the regulations the City may not use its Federal Revenue Sharing Funds to match other Federal grants. Payment was made and charged to the Public Works Dpt. Road Fund, with the understanding that if additional funds were required for major road repair that such sums would be taken from the Federal Rgvenue Sharing Fund.

The Clerk announced that no bids had been received, and following discussion and upon the advice of the City Attorney, the City Clerk was directed to run an advertisement in the "Used Cars for Sale" of local papers and to accept, at his option, the best bid.

#### PETITIONS AND DELEGATIONS

1. Mr. Tom Johnson of 1008 Altavia Avenue requested permission to install a Parking Pad on the City right-of-way in front of his residence. Following the provisions laid down by the City Council, this matter was referred to the Mayor and the City Engineer for their investigation and recommendations.

#### OLD BUS INESS

- 1. The condition of the parking area adjacent to the Dixie Hwy. at various business locations was discussed. Contact had been made with the State Hwy. Dept. to repave these areas, but it had denied responsibility for same. The matter was referred to the City Engineer and Mayor, who were to contact the premises in question and require that the repairs necessary be made by their owners. In the matter of the unsightly condition of certain vacant property along the Dixie Hwy., the Clerk introduced the idea that under K.R.S. 381.770 the City could cite an offender to Court and/or have the work done in cutting weeds and bill the owner. The Clerk was then directed to write a letter to Mr. Ben Castleman, asking that he take immediate action to have the weeds cut on his property adjacent to the Dixie Hwy.
- 2. Upon the suggestion of Councilman McKinley, the Mayor appointed a committee consisting of Councilmen McKinley and Schlothauer who were to investigate the possibility of securing developers for undeveloped property within the City. This might eliminate unsightly conditions and increase the tax duplicate of the City. The Clerk was requested to provide Mr. McKinley with a list of such property.
- 3. In the matter of the fire inspections of the Town & Country Restaurant; the Inspection Division of the Park Hills Fire Dept. was in the process of checking for the corrections of certain violations of the Fire and/or Safety Codes at the above location. A letter had been sent by said division to the owners of the T & C on September 7, 1977, setting forth certain violations. Chief Dreyer reported that follow-up inspections had revealed that most of the violations had been corrected and that additional inspections would be made to determine that the regulations were fully complied with. Mayor Niehaus requested that thorough examination be made of all places of public assembly within the City to determine if fire and safety codes were being enforced.
- 4. Covington Catholic H.S. Recreational Facility The City Engineer and Mayor reported that work here had progressed rapidly. The cave-in adjacent to Old State Road had been taken care of. Grading is apparently completed, and seeding of the area taking place. The following items were indicated as unfinished:

- (a) A suitable accessroad from the Dixie Hwy. to the Covington Catholic H.S. buildings, for fire protection.
- (b) The catch basin to the rear of 834 St. James had not been constructed.
- (c) No landscaping had been done.
- (d) The fence was not erected.
- (e) Mounds of dirt remained on the property at the rear of 838, 840 and 842 St. James.

All of these items were included in the permit granted for this project by the Park Hills Board of Adjustment. The Clerk was directed to provide the City Engineer with a list of unfinished items.

- 5. Major street resurfacing See Engineer's report.
- 6. The Fire Dept. reported progress in the installation of the new Base Station and Remotes and accessories in the updating of the fire alarm system.
- The Clerk read a letter from the General Manager of 7. Sanitation Dist. No. 1, indicating that by February, 1978, the present Park Hills Sewage Treatment Plant would be bypassed by the addition of sewer line into the Sanitation District's facility in Ludlow and offering to raze the buildings and appurtenances of said plant, which is owned by the City of Park Hills. A motion was made by Mr. Gormley and seconded by Mrs. Schmitz that the offer of the Sanitation District to demolition the buildings and appurtenances and to level the area be accepted and that the Clerk be directed to so notify the Sanitation District. Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried. Following the passage of this motion, the Clerk introduced the original easement between the City of Covington and the City of Park Hills providing for the placement of the Sewage Treatment Plant upon property owned by the City of Covington and a copy of the 1954 Agreement between the City of Park Hills and Sanitation Dist. No. 1, providing for the operation of the Sewage Treatment Plant by the Sanitation District and the eventual discontinuation of the use of this plant. The City Engineer pointed out that it might be necessary to continue the easement granted since it was possible that some of Park Hills collector and/or interceptor sewer lines ran through this area. Clerk was directed to provide the City Engineer with a copy of the easement and the agreement with the Sanitation District to determine what action should be taken in the matter of the continuation of the easement. Contact was to be made by the City Engineer with the City Attorney for any legal questions which might arise.

#### NEW BUSINESS

- 1. The Clerk read Ordinance No. 8, 1977, "AN ORDINANCE UPDATING THE ADOPTION OF FIRE, BUILDING AND/OR SAFETY CODES TO MEET THE MINIMUM STATE STANDARDS AS APPROVED BY THE KENTUCKY STATE FIRE MARSHALL'S OFFICE". A motion was made by Mr. Sorrell and seconded by Mr. McKinley that Ordinance No. 8, 1977 be adopted as read. Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.
- 2. The Clerk introduced the matter of the possible regulation of so-called garage sales within the City, since it appeared that some persons were conducting frequent sales which appeared to be a violation of the zoning ordinances prohibiting the conducting of business in residential zones.

  Lengthy discussion followed and Council requested that the City Attorney prepare an ordinance for presentation at the November meeting regulating such sales and providing for such items as the requirement of a permit, frequency of sales, duration of sales, advertising of sales, and the display of merchandise.
- 3. The Mayor and City Clerk reported to Council on their attendance at the Covington meeting of the State of Kentucky State Statute revision committee, indicating that most of the opposition to the proposal was based upon the easing of requirements for annexation of one City by another. Council agreed to keep in touch with this development.
- 4. The Clerk announced that effective January 1, 1978, the minimum wage paid to employees would be raised by Federal statutes to \$2.65 per hour. Only three employees of the City are affected by this increase.
- 5. The Clerk announced that he had been successful in securing insurance coverage for volunteer member, of the Park Hills Police Dept., same being included in the policy covering volunteer firemen. The rate being \$25.00 per year for Police volunteer.
- 6. The City Council set October 31, 1977, between 6:00 and 9:00 P.M. for Halloween Trick or Treat.

#### COMMITTEE REPORTS

### Public Works Dept.

1. A motion was made by Mr. Schlothauer and seconded by Mr. McKinley that the City purchase from the Crescent Lawn & Garden Center a 42-inch snow plow and hitch to be used on the new Allis-Chalmer tractor, at a price of \$145.00. Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.

### Police Department

- 1. Mr. McKinley presented the report of the Park Hills Police Dept. for the month of September, 1977, which was received and filed.
- 2. The City Clerk presented Resolution No. 6, 1977, "A RESOLUTION APPOINTING LARRY HALL AS A PART TIME PATROLMAN OF THE CITY OF PARK HILLS POLICE DEPARTMENT EFFECTIVE OCTOBER 3, 1977". A motion was made by Mr. Sorrell and seconded by Mr. Gormley that Resolution No. 6, 1977 be adopted as read. Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.
- 3. Chief Ostendorf discussed with Council the possibility of securing one additional police person on a full time basis through the Federal program CETA. He indicated to Council that if approved CETA would pay all costs, including but not limited to salary, Workmen's Compensation insurance costs, the City's portion of Social Security costs, medical and hospitalization policy for non-service connected illness or injury, life insurance policy, and the liability policy protecting the policeman and the City against possibility of a suit for actions taken by the policeman, all uniform costs. THE CITY COUNCIL OF THE CITY OF PARK HILLS MET IN REGULAR SESSION AT THE PARK HILLS CITY BUILDING ON MONDAY, NOVEMBER 14, 1977, AT 8:00 P.M. WITH MAYOR NIEHAUS PRESIDING AND COUNCILMEN GORMLEY, KAPPAS, McKINLEY, SCHLOTHAUER, SCHMITZ AND SORRELL PRESENT.

A motion was made by Mr. McKinley and seconded by Mr. Gormley that the minutes of the October 10, 1977 meeting be approved as submitted. Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.

The regular order of business was waived to permit the appearance of Mr. Kenneth Gross, Principal of the Covington Catholic High School, Dixie Highway, to discuss the progress of the new Covington Catholic H.S. Recreational Facility. Mr. Gross requested that the office of the City Clerk furnish him with a list of names of abutting property owners to the project in order that a letter might be sent to such persons. He told Council that Mr. James Berling, the Engineer of the project, would be present at the December meeting to answer specific questions as to the progress of this facility in keeping with the requirements laid down by the Park Hills Board of Adjustment in granting a Conditional Use Permit.

Mayor Niehaus then posed a series of questions concerning the development:

(a) The surface water hook-up at the rear of 834 St. James (b) The rebuilding of the fence of Mr. Henry Freckman

The rebuilding of the fence of Mr. Henry Freckman removed in the process of development

(c) The failure to construct the required roadway or pathway from Old State Road to the Covington Catholic H.S. buildings, providing access for Fire Dept. and other emergency equipment

Councilman Kappas then inquired as to the rumor of the erection of permanent seating at the newly constructed field. Mr. Gross replied that at the present time the committee in charge had no plans for permanent seating.

Fire Chief Dreyer indicated that a request had been received from the office of the Ky. State Fire Marshall, which indicated that the approval of this office must be secured before any type of seating, permanent or temporary, is considered.

Mr. Kappas also inquired about the availability of parking, if "Home" football games were played at this site. The City Engineer told Council that he had discussed several of these problems, including the road installation and the surface hook-up, and had been assured by Mr. Berling that same would be taken care of.

Mr. McKinley inquired about permanent seating and was informed by the Mayor that any such action would require further consideration by the Park Hills Board of Adjustment. The Mayor indicated that the committee in charge of the development of the facility must be bound by the agreement with the Board of Adjustment.

### OLD BUSINESS

- l. The Dixie Highway clean-up -
  - (a) The area of the former White Horse Tavern had been cleaned up under the direction of Mr. Frank Dreyer and the cost of same paid by Mr. Castleman.
  - Letters written by the City Attorney to Poppa's Familee Tree Restaurant and U-Totem convenience store were introduced. It developed that the letter to Poppa's Familee Tree should have been sent to either the person buying same on contract, Evangelos Levas of Lexington, Ky., or to Roberta Callahan, the owner of record. Council directed that the City Clerk send a copy of the letter addressed to Poppa's Familee Tree Restaurant to Mr. Levas. At this time, Mr. Earl Paul, the City Engineer, produced a copy of the agreement between the City of Park Hills and the Ky. State Hwy. Dept. on maintenance of State and/or Federal Highways. Mr. Paul said that the agreement provided that the State would maintain the road, including its shoulder, which was usually presumed to be 6 to 10 feet from the edge of the paving. It appears that if the 10-foot limit were used the repair of the parking aprons at both U-Totem and Poppa's Familee Tree would be the responsibility of the State Hwy. Dept. Since this was in a "gray" area, the Mayor and the City Engineer agreed to contact the Head of the local State Hwy. district office to determine the facts in the case.
- 2. Fire Chief Frank Dreyer reported that the Town & Country Restuarant was in the process of making the necessary adjustments and corrections to meet all requirements of the Fire and Safety and Life Codes. Frequent inspection was being made to implement compliance.
- 3. Chief Dreyer told Council that the other places of assembly within the City had been inspected and were generally in compliance with the required codes.
- 4. The Clerk told Council that in compliance with its request the 1972 Ford, used as an unmarked car by the Police Dept., had been sold for \$650.00.
- 5. The Clerk announced that the bills for major street improvement had been paid after acceptance of the project by the State Hwy. Dept., which provided the funds, the Park Hills City Engineer and the Mayor. The curb on Lawton Rd. was discussed and it appeared that much of the objection to such curb was brought about by the difficulty of parking on the right-of-way and/or sidewalk during inclement weather. The Mayor was to continue an inspection of this curb and make recommendation as to its possible removal, where said removal would not create any other hazard.

- 6. In regard to the demolition of the Park Hills Sewage
  Disposal Plant, which demolition had been agreed to by
  the Kenton & Campbell Sanitation District at its
  expense, the Clerk informed Council that a copy of the
  original agreement with the City of Covington relative
  to the location of the plant in Devou Park, and a copy
  of the agreement made with the Kenton-Campbell Sanitation
  District No. 1 in 1954, at which time the District
  assumed operation of the sewage plant, had been sent to
  the City Engineer and the City Attorney to determine if
  any legal action was necessary.
- 7. After some discussion relative to the application of Mr. Tom Johnson of 1008 Altavia Avenue, to erect a parking pad in front of his residence on the City right-of-way, a motion was made by Mr. Sorrell and seconded by Mr. Gormley that said application be approved. Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs.Schmitz, aye; Mr. Sorrell, aye, and the motion carried.

  This approval was granted upon the recommendation of the City Engineer and the Mayor, who had acted as a committee in inspecting the proposal.
- 8. The Clerk read a draft of a resolution or ordinance, which had been prepared by the City Attorney, regulating so-called "garage" sales within the City. Lengthy discussion revealed that the Council members wished to make certain changes in the proposed ordinance, particularly as to the number of sales that could be held at one location during any calendar year, and the number of days' duration of such sales. The Clerk was directed to send a copy of such proposed ordinance to each member of Council for additional study and to inform the City Attorney of the requested changes in same.
- 9. Mr. McKinley, a member of the committee appointed to secure suitable business enterprises on the Dixie Hwy., reported that he had made preliminary contact with the Real Estate firm handling the sale of the former White Horse property, but reported no other progress to date.
- 10. The Clerk told Council that the proposal made by Chief Ostendorf to secure an additional full-time patrolman under CETA had been investigated and the City informed that the funds were not available.
- ll. In the matter of insurance covering the full replacement cost of fire-fighting vehicles, the Clerk informed Council that the present insurance policies covering these vehicles did not include replacement costs. This following a study of the policies by the City Attorney, who had so informed the City Clerk. Council directed the Clerk to contact its insuror to determine if such coverage was available and the cost feasibility of same.

THE CITY COUNCIL OF THE CITY OF PARK HILLS MET IN REGULAR SESSION AT THE PARK HILLS CITY BUILDING ON MONDAY, DECEMBER 12, 1977, AT 8:00 P.M., WITH MAYOR NIEHAUS PRESIDING AND COUNCILMEN GORMLEY, KAPPAS, McKINLEY, SCHLOTHAUER, SCHMITZ AND SORRELL PRESENT.

A motion was made by Mr. Gormley and seconded by Mr. Sorrell that the minutes of the November 14th meeting be approved as submitted. Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.

## OLD BUSINESS

- 1. City Engineer Paul discussed the possibility of the State Highway Dept. making repairs to the shoulder and rights-of-way along the Dixie Hwy. where damage had been done by surface water flow. He indicated that the State had accepted partial responsibility for such repairs, dependent upon the location of the repair to be made. Following discussion, the City Engineer was directed to take the following steps: First, to write the State Hwy. Dept., describing the location of the repairs to be made to determine if same lie in the area of its accepted responsibility and Secondly, to secure from the same a plat showing the rights-of-way along the Dixie Hwy. within the City.
- 2. Following complaints the Public Works Dept. was directed to remove the curbing in front of the Caudill residence at 1063 Lawton Road.
- 3. There was no further news on the demolition of the Park Hills Sewage Disposal Plant by the Sanitation District.
- 4. The City Clerk read Ord. No. 9, 1977, "AN ORDINANCE TO REGULATE GARAGE SALES, ATTIC SALES, FLEA MARKET SALES OR OTHER CASUAL SALES, TO REQUIRE LICENSES THEREFOR, AND TO PROVIDE PENALTIES FOR THE VIOLATION OF SAID ORDINANCE". Lengthy discussion followed as to the contents of the ordinance, particularly as to the fee to be charged, the duration of the sales under the ordinance and the penalties to be applied for violation thereof. Amendments were made to the ordinance by various members of Council, which was then considered in its amended form. A motion was made by Mr. McKinley and seconded by Mr. Schlothauer that Ord. No. 9, 1977 be adopted as amended. Mr. McKinley, aye; Mr. Schlothauer, aye; Mr. Kappas, aye; Mrs. Schmitz, No; Mr. Gormley, aye; Mr. Sorrell, No, and the motion passed by the vote of four to two.

## Old Business (continued)

- 5. The Clerk reported that he had contacted the Bilz Agency, the carrier of the Park Hills vehicular insurance, concerning the possibility of securing replacement cost insurance on the vehicles of the Fire Dept. To date there has been no response to the inquiry and he was directed to continue his efforts in this matter.
- 6. Mr. McKinley informed Council that he had contacted the agent in charge of the sale of the former White Horse property on the Dixie Hwy. and had been informed that some interest had been shown in the purchase of the territory for the construction of a center housing medical services. Council encouraged him to continue his efforts.
- 7. Fire Chief Dreyer presented to Council a list of repairs and/or changes that should be made within the City Building to bring it into full compliance with the fire and safety code. These were as follows:
  - (a) Replace the following doors with a l-hour fire resistant door; Door between Police office & Fire Dept. garage Door between Fire Dept. office & Fire Dept. garage Door between Fire Dept. garage & main stairway Door between Fire Dept. garage and Rescue and Public Works garage.
    - The door between the Police office and the main stairway is not required to have a 1 hour fire resistant dorr, but we feel if we installed a 1 hour fire resistant door at this location, it would protect the stairway from a fast spreading . fire.
  - (b) Remove fan and fill hole in wall between Fire Dept. garage and Rescue and Public Works garage.
  - (c) Remove all storage from under both stairways.
  - (d) Install wire glass or plexiglass in window of Fire Dept. office (between Fire Dept. garage and Fire Dept. office.)
  - (e) Install 1 Fire extinguisher in upstairs hall.

Following discussion, the Fire Chief and the City Clerk were directed to contact Mr. Carl Votel to make the necessary changes, under motion made by Mr. Schlothauer and seconded by Mr. McKinley. Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.

(e) A discussion of a newspaper item concerning the erection of seating at the new facility was discounted by Mr. Berling. It was further pointed out that any installation of seating and/or lights would again be subject to action by the Park Hills Board of Adjustment. Chief Ostendorf questioned the availability of parking space if the number of seats suggested were installed.

A motion was made by Mr. Sorrell and seconded by Mr. Schlothauer that Res. No. 7, 1977 be adopted as read. Mr. Gormley, aye; Mr. Kappas, aye; Mr. McKinley, aye; Mr. Schlothauer, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.
- 2. Mr. Mal Malone of Lawton Road, present as an observor, inquired if any contact had been made with the new owner of the former Butler property as to the use to be made of this area. The City Attorney indicated that the City had no legal or moral responsibility to take any steps regulating the possible use since the new owner had not contacted the City as to such use and that the original agreement made with Wm. P. and Martha Butler covered the use of the property as provided by action taken by the Park Hills Bd. of Adjustment in this matter.

  Mr. Schlothauer volunteered to make an informal inquiry without committing the City to any action.
- 3. Mr. Robert. Gettys told Council that in view of another position he contemplated taking he could not serve as the City Attorney for the period beginning January 1, 1978.

## New Business (continued)

- 4. The Clerk introduced the matter of a possible problem in the matter of the construction of private driveways as regulated under the Park Hills Zoning Ordinance. Many driveways within the City were at the property line, the Zoning Ordinance required a five-foot setback for driveway construction. This provision would apparently make it illogical to continue a present driveway at its same plane if additional parking space was to be provided. Following discussion, the Mayor agreed to contact the No. Ky. Area Planning Commission for a further interpretation of this portion of the Zoning Code.
- 5. The Mayor requested that Messrs. Vocke and Dreyer make a survey of the sidewalk conditions on Rose Circle to determine which sidewalks were in need of repair and/or replacement and to provide the City Clerk with a list of addresses where repairs were deemed to be needed.
