The regular order of business was then resumed.

### OLD BUSINESS

- 1. Mr. Kenneth Gross, Principal of Covington Catholic H.S., again appeared as a representative of the group developing the Covington Catholic H.S. Recreational Facility. reported as follows: The base coat of the track was laid; that the Committee was working on the parking problem to provide adequate parking at athletic events on their own facility. The question of the emergency road from Old State Road to the buildings of the Covington Catholic H.S. was a matter of considerable discussion. Under the permit granted by the Park Hills Bd. of Adjustment, the creation of said road was a requirement. Mayor Nieheus and City Engineer Paul discussed this with Mr. Gross and the Covington Catholic H.S. Committee was directed to contact its own engineer and the City of Park Hills engineer regarding the construction and type of such emergency road.
- 2. City Engineer Paul stated that due to the holidays, a change in the District Engineer for this Hwy. District, and the inclement weather, that he had been unable to make any progress regarding the State's responsibility of repairing shoulders and rights-of-way along the Dixie Hwy.
- 3. The City Clerk indicated that he had written to the American Fire Engine Company relative to securing their figures on the actual replacement costs of the two fire engine pumpers now in service by the Fire Dept. of the City of Park Hills. He stated that he received a brief reply stating that after the first of the year this information would be provided, but that to date no further communication had been received.

### Old Business (continued)

- 4. Mr. McKinley reported for the committee appointed to attempt to secure new business along the Dixie Hwy. with particular reference to the land owned by Mr. Ben Castleman. He had directed Mr. Toelke, a representative of the West Schell Co., who had a prospective client, to contact the City Clerk as to zoning and building requirements. The Clerk informed Council that Mr. Toelke had called at the City Building, secured some information, and made a drawing of the area in question. The Clerk had informed Mr. Toelke that he should contact the Zoning Administrator for any further delineation of the required code.
- 5. In the matter of the action to be taken to bring the City Building in compliance with the required safety regulations, Mayor Niehaus reported that two contractors had been contacted to give an estimate of the cost on the specified items. Chief Dreyer reported that representatives of the contractors had looked at the job, but that no bids had been received as of this date. Mayor Niehaus said he would contact the prospective bidders in an effort to implement this matter.
- 6. Mayor Niehaus, reporting for the Bldg. Permit Committee, relative to the construction of a driveway by an owner adjacent to the Schilling property on Emerson Road, reported that he had contacted the No. Ky. Area Planning Committee, who had advised that the owner desiring to construct said driveway should contact the Park Hills Bd. of Adjustment to set up a meeting in an effort to secure a dimensional variance of the driveway. Mayor Niehaus agreed to take the necessary steps in this matter.
- Mr. Ralph Grieme, the present owner of the Butler property, appeared before Council to present a plan for the use of this area. He proposed to erect, under the Planned Urban Development section of the Park Hills Zoning Ord., a combination of single family dwellings, sometimes described as "cluster" single family dwellings. He presented a topographical map, preliminary in nature, a plat showing the construction of the dwellings on the acreage and pictures and slides of a similar development in Hamilton County. The preliminary plan would provide for approximately 36 homes. Lengthy discussion followed as to the environmental effect of such development and such matters as the adequate provision for sewage and surface water disposal. Mr. Grieme then requested of Council the permission to use the City Bldg. on January 18, 1978, for an unofficial meeting of the residents on Amsterdam Road, Hillcrest, Lawton and Altavia Ave., whose property lie adjacent to the proposed project. Council agreed with the distinct understanding that this was to be an unofficial meeting and one not called by the City Council. The progress plan would involve approval of the project by the Kenton Co. & Municipal Planning & Zoning Commission, the No. Ky. Area Planning Commission and the

### Old Business (continued)

- City Council of the City of Park Hills, including public hearings wherever required by the Park Hills Zoning Ordinance and the Statutes of the State of Kentucky.
- 8. Mayor Niehaus reported that due to the weather no action had been taken in investigating the necessity for sidewalk repairs on Rose Circle.

### NEW BUSINESS

- 1. The City Clerk and Mayor Niehaus reported that they had gone to Frankfort on Friday, January 6, 1978, for the purpose of protesting the allotment granted to the City of Park Hills from fines levied under the new District Court system. They reported little hope of a substantial increase in the allotment since same was figured on the net Court revenues for a three-year period, ending June 30, 1976. Some small increase is anticipated.
- 2. Mayor Niehaus introduced the matter of the purchase of a metal building to be erected adjacent to the Public Works Dept. of the City Bldg. The City Engineer had suggested to the Mayor the necessity of a survey to determine the exact limits of the property owned by the City of Park Hills. The price quoted was a minimum of \$1500.00 or a maximum of \$1750.00, dependant upon the amount of time necessarily consumed in said survey. Council considered the price to be exorbitant and requested that substantiating or competitive figures be secured from another source, other than Kral, Zepf & Freitag, who had provided the estimate. It also developed in the discussion that in the purchase and erection of said building that since it exceeded \$2500.00, that under the State statutes it would be necessary to advertise for and accept hids for the purchase and/or erection of said building, which was to be used as headquarters for the Park Hills Rescue Squad. Three items would be considered:

(a) The necessity for a survey

(b) The preparation of the land site and installation of slab

(c) The purchase and erection of the metal building

Other items to be considered would be the heating and lighting of this struction. With all these problems arising, any action on this project was delayed, pending working out details on the items specified above, plus property financing of the expenditure.

It was suggested to Mr. Berling that to prevent a glut of traffic on Park Hills streets during athletic events that arrangements be made with the Notre Dame Academy and the St. Agnes Parish to permit parking on their facilities.

- 2. With the absence of the City Engineer, there was no report on his contact with the State Hwy. Dept. concerning the responsibility for repair along the rights-of-way on the Dixie Hwy.
- with the American Fire Pump Co. concerning the replacement costs of the two Park Hills fire engine pumpers. The letter from the American Fire Pump Co. estimated the reproduction cost of the present equipment between forty and forty-five thousand dollars each. The Clerk had then contacted the Chas. Bilz Agency, enclosing a copy of the letter establishing the reproduction costs for the purpose of securing insurance based on same. To date, there has been no reply from the insurance agent.
- 4. Mr. McKinley reported no further progress on an attempt to find clients to develop the Castleman property on the Dixie Hwy.
- 5. In the matter of certain repairs in door replacements within the City building necessary to bring the building into compliance with the Safety Code, Mayor Niehaus had secured two bids for the work to be done. Since the amount was less than the required amount for public bidding, Council considered the two bids and agreed to permit Mr. Herb Spille to do the work at a maximum price of \$626.75. A motion to so do was made by Mr. McKinley, seconded by Mr. Gormley. Mr. Ehrman, aye; Mr. Gormley, aye; Mr. McKinley, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.
- The bad weather was continuing to prevent a sidewalk survey on Rose Circle.
- 7. Mr. Ralph Grieme was not present at the meeting so there was no discussion on his proposed use of the Butler property under PUD cluster housing.
- 8. In the matter of the erection of a metal garage adjacent to the Public Works Dept. of the City Bldg., the Clerk told Council that a portion of the money, which it was proposed to use in this construction, was to be taken from Federal Anti-recession Funds, supplied to the City of Park Hills. But investigation revealed that such use of the money was prohibited and therefore that funds for the construction must be secured elsewhere. The matter was therefore laid over to permit the possibility of securing funds from some other source.

### PETITIONS AND DELEGATIONS

Mr. Glen Caldwell, a co-owner of three lots along Old State Rd., being a part of the Kremer subdivision, appeared before Council, seeking to have the City abandon the rightof-way dedicated to public use adjacent to his lots on Old State Rd., and designated as Kremer Ave. on the dedication plot. The City Clerk, having been made aware of this proposal, had requested that the City Attorney brief Council on its responsibility in the matter of the abandonment of the dedicated right-of-way. This right-of-way being 50 feet wide. City Attorney Howard then outlined for Council the steps and procedure necessary:

(1) The City must pass an ord nance proposing to abandon

the right-of-way

(2) The City Attorney file suit in the Kenton Co. Circuit Court to have the road closed.

(3) The defendants in the case would be the abutting property owners. In the case, Mr. Glen Caldwell, Mr. Ronald Coldiron and the Covington Catholic Diocese.

(h) That if no objections were entered to its closing, the

Court would enter a decree closing the roadway.

(5) In the matter of the distribution of the land area of the abandoned right-of-way, Mr. Howard thought that it probably would revert, on a 50-50 basis, to the property owners on either side of the right-of-way. but that this would be subject to a study of the dedication of the street.

Since a cost of several hundred dollars would be involved, Council was of the opinion that the entire cost should be borne by the abutting property owners, who would benefit by the acquisition of the area. A motion was then made by Mrs. Schmitz and seconded by Mr. McKinley that the City Attoeney be directed to pursue the matter of the closing of Kremer Ave., with the understanding that all costs be defrayed by those benefitting by land acquisition and to take such steps as necessary to determine to whom the land would revert. Mr. Ehrmand, aye; Mr. Gormley, aye; Mr. McKinley, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.

2. Mr. Mike Burch of St. Joseph Lane, headed a delegation of residents of that street, who protested the leaving of garbage cans in front of an apartment building and the failure of the Folice to enforce certain parking ordinances. Mr. Burch had written letters to the Mayor and each member of Council, setting forth his complaint re garbage can conditions at the apartment located at 704 St. Joseph Lane. In answer, Chief Ostendorf told Council that he had contacted the owner of the property, an absentee landlord, who each time had agreed to have the matter remedied. The complaintants stated that there was no appreciable improvement in the situation. The City Clerk, having previously been advised of the situation, had contacted sister cities to determine their policy regarding the setting out and retrieving of trash receptacles, and that following conversations with the Mayor and several Councilpersons, he had requested that the City Attorney draw up an

ordinance regulating this practice. Whereupon, the City Attorney read Ordinance No. 7, "AN ORDINANCE RELATING TO THE REGULATION OF PLACEMENT OF GARBAGE AND REFUSE FOR COLLECTION IN THE CITY OF PARK HILLS AND FSTABLISHING PENALTY FOR VIOLATION THEREOF". A motion was made by Mr. Gormley and seconded by Mr. Sorrell that Ord. No. 7, 1978 be adopted as read. Mr. Ehrman, aye; Mr. Gormley, aye; Mr. McKinley, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried. In the matter of the parking complaint, Chief Ostendorf indicated that due to the very inclement weather, the Police had overlooked violations concerning overnight parking and the whole matter was referred to the Police Dept. for adequate enforement under the conditions.

3. A complaint was registered concerning the unsightly condition being the result of automobiles parked along the Dixie Hwy. by the owners of the Park Hills Service Center and the Ft. Mitchell Garage. The Clerk reminded Council that this had been a matter of discussion previously and that it had been informed by its previous City Attorney that the erection of fences, etc. to hide the blight, reated by these cars, would be subject to consideration by the State of Kentucky, since the property in question adjourned U.S. 25 and 42. The City Attorney was directed to investigate the matter to determine the limit of the City and State's responsibility in this matter.

#### NEW BUSINESS

- 1. The Mayor requested that the matter of the appointment of a new Assit. Bldg. Inspector be postponed as he had some thoughts on the matter that would require additional time.
- 2. Mr. McKinley asked the Mayor about the meeting concerning TANK, which had been attended by Mayors of several Kenton County cities. This group had tentatively approved the idea of the imposition of a payroll within the County to provide funds for the operation of TANK. Mr. McKinley expressed his opposition to such a plan, while a majority of the members felt that this might be the only method available to continue the operation of a public transit system.
- 3. Snow removal Mr. McKinley asked that the Public Works Dept., in plowing snow, plow a wider area so as not to create a one-lane situation on streets within the City.
- 4. Chief Ostendorf brought up the matter of the necessity of revising citation tickets for auto sticker violations and parking violations. Following discussion, it was agreed that such necessary revision should be made in consultation with the City Attorney.

### Public Works Dept.

1. Expressed the thanks of the City Council to all the members of the Fire Dept. and the Rescue Squad who had worked on a paid basis in the snow removal job.

### Police Dept.

- 1. Mr. McKinley presented the report of the Park Hills Police Dept. for the month of January, 1978, which was received and filed.
- 2. The Clerk presented Resolution No. 5, 1978, "A RESOLUTION APPOINTING DENNIS DALE ROBERTS A MEMBER OF THE VOLUNTEER DIVISION OF THE POLICE DEPARTMENT OF THE CITY OF PARK HILLS, KENTUCKY". A motion was made by Mr. McKinley and seconded by Mr. Sorrel that Resolution No. 5, 1978 be adopted as read. Mr. Ehrman, aye; Mr. Gormley, aye; Mr. Knochelman, aye; Mr. McKinley, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.
- 3. Chief Ostendorf reported that Anita Patton had been indicted by the Grand Jury for First Degree Murder, allegedly committed within the City of Park Hills.

### Fire Dept.

1. Mr. Sorrell presented the report of the Park Hills Volunteer Fire Dept. for the month of January, 1978, which was received and filed.

# Finance Dept.

- 1. The Clerk submitted the following financial reports:
  - (a) The Report of the General Fund for the month ending January 31, 1978
  - (b) The Budget Report of Expenditures for the 7th Month of the Fiscal Year 1977-78

A motion was made by Mr. Gormley and seconded by Mr. Ehrman that the above reports be accepted as submitted. Mr. Ehrman, aye; Mr. Gormley, aye; Mr. Knochelman, aye; Mr. McKinley, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.

The Clerk then reported on the financial condition of the City, pointing out that the costs of snow removal far exceeded the amount budgeted. The cost of the Police Dept., due to the Patton case, was exceeding its budget, and that there would be a loss of \$800.00 in collection of liquor licenses due to the closing of one establishment.

He further pointed out that these expenditures made it very necessary that expenditures be strictly limited in order that the City could operate without creating a deficit.

- 2. The Clerk told Council that he was in the process of investigating personal liability for the members of Coincil, which would protect them against suits directed for misaction by the Council. A policy, which had been in effect, had not been renewed due to the unwillingness of the underwriter to write this type of insurance. The Clerk was directed by Council to continue his investigation into this matter.
- 3. The insurance on the ambulance Rescue Squad will be up for renewal on March 30th. The application for renewal had been given to the Chief of the Rescue Squad for compeltion, but to date, had not been received from him.

#### COMMUNICATIONS

- 1. The Clerk had been mistakenly advised that State funds were available to help defray the cost of snow removal. He had contacted the proper agency, who had then informed him that this was in error. That all funds had been given to counties and none to cities. This was later confirmed by letter from the Ky. Municipal League, who had first furnished the mistaken information.
- 2. From the City of Wilder concerning the annexation proposal before the State legislature.
- 3. A letter had been dispatched to the owners of the Bridge-Gate Apts., indicating that Park Vale Lane had never been officially accepted by the City of maintenance purposes since the former owners of the property had failed to comply with the necessary steps to secure acceptance of the street by the City.
- 4. A letter from Mr. & Mrs. Page of Exter Dr. expressing thanks for the efforts of the Public Works Dept. on snow removal.

THE CITY COUNCIL OF THE CITY OF PARK HILLS MET IN REGULAR SESSION AT THE PARK HILLS CITY BUILDING ON MONDAY, MARCH 13, 1978, AT 8:00 P.M. WITH MAYOR NIEHAUS PRESIDING AND COUNCILMEN EHRMAN, GORMLEY, KNOCHELMAN, McKINLEY, SCHMITZ AND SORRELL PRESENT.

A motion was made by Mr. McKinley and seconded by Mr. Sorrell to accept the minutes of February 13, 1978 meeting as submitted. Mr. Ehrman, aye; Mr. Gormley, aye; Mr. Knochelman, aye; Mr. McKinley, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.

### OLD BUSINESS

- 1. The City Clerk informed Council that he had a telephone call from Mr. James Berling, the Engineer on the Covington Catholic H.S. Recreational Project, stating that the inclement weather had prevented the completion of the unfinished items under Phase I of this project, and that a meeting had been arranged with the Park Hills Board of Adjustment for Thursday, March 16th, at the ParkHills City Building for the consideration of the items which were listed as Phase II of the Project, including, but not limited to, the erection of bleacher seating and a building of an auxiliary nature on the site.
- 2. The City Engineer reported that due to changes in the personnel of the Ky. State Hwy. Dept. in this district they had been unable to complete arrangements to discuss with that authority the responsibility for the repair of the rights-of-way along the Dixie Hwy.
- 3. The City Clerk reported that there had been no further communication from its insurer relative to securing replacement cost insurance on the vehicles of the Park Hills Fire Dept. The Clerk was directed to continue his efforts to secure same.
- 4. The Clerk reported on his contact with the Charles Bilz Agency re its offer to provide public officials and employees liability insurance, pointing out that the Police, Fire and Rescue Squads were covered under such policy by other insurers. Considering the financial condition of the City, Council decided to pursue this matter no further.
  - 5. The Mayor reported that he had been in contact with Mr. Ralph Grieme concerning the development of the Butler property. Mr. Grieme had informed the Mayor that a survey and study was being conducted in the matter of adequate disposition of the storm and surface waters, which study would be submitted to the Mayor and the ParkHills City Engineer for their study and consideration.

### Old Business (continued)

- 6. Mr. McKinley reported that there had been no further contact with the agent of the West Shell Realty Co. concerning the sale and use of the former White Horse property on the Dixie Hwy. The Clerk, likewise added, that no additional information had been requested from his office.
- 7. City Attorney Howard reported that he was preparing the necessary papers for suit to abandon Kremer Avenue. discussed, in detail, for Council the legal steps which were necessary in such procedure and suggested that before any legal action be taken, which would incur a considerable expense that a contract be made with the party or parties interested in the abandonment of Kremer Avenue to pay in their entirety all costs incurred in this action. Whereupon, a motion was made by Mr. McKinley and seconded by Mr. Gormley that the City Attorney proceed with the necessary action for the abandonment of Kremer Avenue, first securing from the interested party or parties a contractual agreement in which they would pay all costs, legal and otherwise, incurred in such procedure. Mr. Fhrman, aye; Mr. Gormley, aye; Mr. Knochelman, aye; Mr. McKinley, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.
- 8. The Mayor announced that due to the snow cover the sidewalks on Rose Circle deemed in need of replacement had not been surveyed for such replacement.
- 9. The City Attorney reported that he was studying the question of legally improving the esthetic condition along the Dixie Hwy. in securing the cooperation of the owners of the Park Hills Service Center and the Ft. Mitchell Garage in removing unsightly wrecked and partially dismantled automobiles, which were an eyesore on the landscape. The Mayor agreed to meet with Mr. Howard and the owners in question in an effort to implement the removal of such vehicles.
- 10. Chief Ostendorf reported to Council that since violations involving the failure to purchase a City automobile sticker and violations against the parking ordinances of the City of Park Hills were not subject to trial in the new District Court system, that new citation tickets, covering these two violations, were being prepared permitting such violations to be handled directly by the Police Dept. of the City of Park Hills. The City Attorney gave an opinion that there seemed to be no legal obstacle to this procedure.
- 11. Due to the inability of the City to secure an Ass't. Bldg. Inspector, the Mayor had discussed the question with the Park Hills City Engineer, who also serves as Zoning Administrator and Bldg. Inspector, stating that when it was impossible for the Bldg. Insp. to make on-site inspections, that he would do so without charge. Council concurred in this disposition.

#### Old Business (continued)

- 12. The Mayor informed Council in the matter of TANK financing that this matter was still before the Ky. State Legislature and that no definite information was available at this time.
- 13. The Mayor reported to Council that the project to bring the City Building into compliance with the required Fire Safety Standards was almost completed.

#### NEW BUSINESS

1. Mr. McKinley suggested that the City Attorney prepare resolutions to be mailed to the affected parties sic "Congratulations to the Covington Catholic H.S. for winning the State Swim Meet and Congratulations to the Notre Dame Academy for placing second in the girls' State Swim Meet."

#### COMMITTEE REPORTS

### Public Works Dept.

- 1. The Clerk reported on the cost of snow removal from the streets.
- 2. The Mayor announced that he had made an agreement with Eaton Asphalt Co. to repair the potholes, the result of the bad winter. Same to be done on a time and material basis.
- 3. The Clerk reported that the City was in receipt of a check in the amount of \$1,399.65, provided by action of the Ky. State Legislature to partially reimburse the City for money expended in snow removal during the winter. Clerk was directed by Council to deposit same in the General Fund and to comply with the requirement of providing the Legislative Research Council of the manner and purpose for which the money was dispersed. The Clerk further announced that in response to a request from the Kenton County Fiscal Court, he had provided it with a list of monies actually expended for snow emergency between January 26 and 30, 1978. It was indicated by a letter from the Fiscal Court that a possibility existed that a portion of this money spent would be repaid to the City from allocation of monies granted by the State Legislature to the Fiscal Courts of the State.

### Police Department

- 1. Mr. McKinley presented the report of the Park Hills Police Dept. for the month of February, 1978, which was received and filed.
- 2. Chief Ostendorf reported that the Mayor's permission had been secured for attendance by the Chief and Lt. Heideman

- at a seminar on hostage control, with the City assuming the responsibility for the payment of replacements for the officers while in attendance at said seminar.
- 3. The Clerk introduced the matter of Park Hills continued participation in the No. Ky. Information Network, pointing out that the cost had steadily risen from approximately \$1,050.00 two years ago to \$1250.00 last year and a current billing of \$1855.00 per year. Chief Ostendorf stated the reason for continuance of the participation and a motion was made by Mr. Sorrell and seconded by Mrs. Schmitz that Park Hills continue to participate in this project at an annual cost of \$1855.00 per year. Mr. Ehrman, aye; Mr. Gormley, aye; Mr. Knochelman, aye; Mr. McKinley, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.

### Fire Department

- 1. Mr. Sorrell presented the report of the Park Hills Vol. Fire Dept. for the month of February, 1978, which was received and filed.
- 2. Chief Dreyer gave a brief report on his attendance at a Hamilton County, Ohio meeting, in which steps were discussed to be taken if brown-out conditions came into existence due to the energy shortage.

# Finance Department

- 1. A motion was made by Mr. Gormley and seconded by Mr. Ehrman that the following financial reports as submitted by the City Clerk-Treasurer be accepted:
  - a. The Report of the General Fund for the month of February, 1978
  - b. The Report of Budget Expenditures for the 8th Month of the Fiscal Year 1977-78
  - Mr. Ehrman, aye; Mr. Gormley, aye; Mr. Knochelman, aye; Mr. McKinley, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.
- 2. Some objection was voiced by several Council members to the charge made for overtime by employee of the Public Works Dept. in aiding the carpenter in bringing the City Bldg. into compliance with the Fire Safety Standards, claiming that this should have been done on regular time or by the carpenter himself.

### Finance Dept. (continued)

3. Mr. McKinleygsquestioned expenditures by the Fire Dept. for tools listed equipment. He questioned the necessity of such purchases. The Clerk informed Mr. McKinley that such purchases had been requested and okayed by the Chief of the FireDept.

### Rescue Squad

- 2. Mr. Gene Connell of 601 So. Arlington Road appeared before Council seeking permission to establish an automobile parking pad on the City right-of-way on Cecelia Avenue.   legal documents had been drawn up, but not signed, and
  an ordinance to be passed by the City, agreeing to the
  abandonment, prepared. Any action on the matter was

- 2. There was no development on the Grieme property project.
- 3. The Mayor reported that in the matter of the Covington Catholic H.S. Recreational Facility, all phases of part I were in the process of being completed and that on April 4th a second hearing had been held by the Park Hills Board of Adjustment for consideration of phase 2, which involved the erection of a structure, including concession stand, toilet facilities, storage area and pressbox. Letters had been sent to all affected parties and no objection was raised by those present to the erection of said structure.
- 4. The City Engineer reported that his contact with the engineer of the State Hwy. Dept. had revealed that the highway held itself responsible only for the repair and maintenance of the paved travelled surface and that the rights-of-way were the responsibility of the abutting property owners, except where drainage problems inherent to the paved surface might be responsible for damage elsewhere.
- 5. The City Clerk reported that the insurance company, after exhaustive research, could find no underwriter who would approve insuring the Fire. Dept. vehicles at their replacement cost.
- 6. Diwie Hwy. blight condition The City Attorney presented to Council a copy of a letter to be sent to the owners of the Fort Mitchell Garage and the Park Hills Service Center requiring that they clean up, remove and/or shield from view the unrepaired automobiles visible at both locations. The attorney had researched the State, Federal and local statutes which required the area to be cleaned up. Council approved the letters and directed their transmission. Council would be presented with a plat showing the exact location on the streets where the resurfacing would be done. The City Clerk told Council that the State Hwy. Dept. had allotted the sum of \$16,346.00 for resurfacing. ### PETITIONS AND DELEGATIONS

- 1. Mr. James Hartberger, owner of property at 1522 Dixie Hwy., inquired as to the responsibility of the clean-up of water and mud apparently diverted toward his property by the C.C.H.S. Recreational Facility improvement. Mr. James Berling, the Engineer on this project, who was here on another matter, and said he would conduct an investigation to determine any liability due to the construction of the recreational field. The Mayor also reminded Mr. Berling that the fence to be erected adjacent to the Freckman property, being a part of Part 1 of the Facility Program, had not been completed. No other comment was made re the C.C.H.S. Recreational Facility.
- Attorney Ruth Klette, representing Glenn Caldwell, presented a preliminary request to the Park Hills Council for the rezoning of the property secured by Caldwell from the Covington Catholic Diocese. Presently this area is zoned RI-FF and Miss Klette requested a change to Highway Commercial. The property in question lies along the Dixie Hwy. 100 feet and back at approximate right angles to said frontage 340 feet, being property adjacent to that recently rezoned, on Caldwell's request, from zone R1-FF to Highway Commercial. Miss Klette intended to present the request to the "enton Co. Municipal Planning & Zoning Comm. and the No. Ky. Area Planning Comm. for preliminary approval, returning to the Park Hills Council on Monday. June 12, 1978, for its approval. The Clerk questioned Miss Klette as to the use to be made of this area, pointing out that if any office building was to be built upon same it would require a change not to Hwy. Comm. zone, but to the Professional Office Zone as required by the Park Hills Zoning ordinance. Miss Klette informed Council that before any decision was made she would consult her client as to the use the new land was to be put.
- 3. A motion was made by Mr. McKinley and seconded by Mr. Sorrell that permission be granted Mrs. Mary Vetter of 511 Rosemont Avenue, at her request, to extend and widen her driveway within one foot of an adjoining property line, the abutting property owner having given his written consent. Mr. Ehrman, aye; Mr. Gormley, aye; Mr. McKinley, aye; Mr. Knochelman, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.

4. The Grieme Development - This matter was the result of lengthy discussion by the Council and various citizens and representatives of the developers being present.

Among the matters discussed:

(a) Mr. Stanley Simmons of Altavia Ave. was assured by the project engineer that the sanitary sewer tap-in from a portion of the proposed development would not be made

upon Simmons' property.

(b) Mr. Knochelman inquired of Mr. Schuh if arrangements had been made by the developer to use any portion of a private sewer line which had been installed by Dr. Schuh. Mr. Schuh indicated that he did not wish to assume the liability of additional water being dumped into and out of his line, but that he had been assured by Mr. Berling that the flow of water from the development would be no greater than the present flow, since the downspout in the area would be directed into the holding pond to be constructed as a portion of the development.

(c) Mayor Niehaus stated to the persons present that a public hearing on the development had been held as required by law on Wednesday, April 26th, at the Park Hills City

Building.

(d) The Mayor also introduced the necessity of an agreement to be drawn up between the City and the developers, covering certain points of importance not evident in the drawing of the area as presented. The City Council, with the aid of the City Attorney and the City Clerk, then had lengthy discussion as to what should be included in such agreement. The points finally agreed upon were as follows: that the responsibility for street maintenance remains with the developer and its heirs or successors; the City would assume responsibility for all sewer lines except the laterals built as part of the development; that all laterals to individual residences, the ponding area and all common property remain subject to maintenance by the de velopers, the owners of the real estate or the Home Owners Association at the time the developer leaves; that the developer will be responsible for all common property until the entire completion of the project; that the contract be made with the Park Crest Associates, representing the developers, Ralph Grieme and the Chelsea Moore Corp.; that taxes on the common property remain the responsibility of the developer until the completion of the project, at which time such responsibility is to be assumed by the home owners and that an agreement would be worked out between the developer and the City Engineer of the City of Park Hills as the charges to be made by the latter for supervision in determining that the interests of the City were protected.

Following this lengthy discussion, a motion was made by Mr. McKinley and seconded by Mrs. Schmitz that the City approve the project of the Park Crest Associates development of the Grieme property, subject to the terms of an agreement as indicated above, drawn by the City and approved by the City and the developer(s). #### OLD BUSINESS

- The Closing of Kremer Avenue The City Attorney reported L. that he had discussed the matter of the closing of Kremer Ave. with Mr. Glenn Caldwell, an owner of the abutting property, who had requested said closing, and that Mr. Caldwell indicated a willingness to assume all costs. legal and otherwise, incident to the filing of the necessary suit to abandon the street. An agreement had been drawn up, which Mr. Caldwell indicated he would sign, setting forth the above facts, whereupon the City Clerk read Ord. No. 9, 1978, "AN ORDINANCE CLOSING THE PUBLIC WAY KNOWN AND DEDICATED AS KREMER AVENUE". A motion was made by Mr. Ehrman and seconded by Mr. Gormley that Ord. No. 9, 1978 be adopted as read. Mr. Ehrman, aye; Mr. Gormley, aye; Mr. Knochelman, aye; Mr. McKinley, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.
- 2. Report on the blight conditions on the Dixie Hwy. The City Attorney reported that he had written the owners of the Ft. Mitchell Garage and Mr. John Toebben about the conditions resulting from the parking of wrecked and/or used cars in areas on, abutting to, or in the neighborhood of their property, that he had received no response in writing from either party, but there had been some visual evidence of compliance. The City Attorney was again directed to write the offenders, setting forth the City and/or State laws regulating such conditions and pointing out the legal remedies open to the City in securing compliance with the various statutes of the City and/or State regarding blight and/or nuisance conditions.
- 3. Rose Circle sidewalks The Clerk announced there had been no major response to his letters requesting the repair of various sidewalks on this street.
- 4. The development of the White Horse property Mr. McKinley, Chairman of this Committee, had been ill and unable to pursue said matter with vigor. He did indicate that a public ad appeared offering the property for sale en toto. Mayor Niehaus reported that he and the Clerk had been contacted by an individual who wished to erect a plumbing establishment upon a portion of the property. The Mayor had invited the applicant to appear before Council with plans of his proposal, but same failed to appear.
- 5. Major street repairs The City Engineer reported to Council that the necessary applications and forms for the 1978 Major Street Improvement Program, as approved by Council at its previous meetings, had been forwarded to the State Hwy. Dept. for its approval under the State Aid Road Plan.

A motion was made by Mr. Ehrman and seconded by Mr. Sorrell that Ord. No. 10, 1978 be adopted as read. Mr. Ehrman, aye; Mr. Gormley, aye; Mr. Knochelman, aye; Mr. McKinley, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.
- 4. Mr. Ehrman asked, and received Council's permission, to have the City Attorney write Mr. James Hartberger about the dilapidated condition of residences owned by him on lower Montague and Amsterdam Roads.
- 5. The Public Works employee present was directed to contact Messrs. Read and Fangman of Park Drive relative to trimming of shrubbery on their property close to the public rights-of-way.
- 6. Mrs. Schmitz relayed the request of the Leisure Timers, a Senior Citizens group, for a contribution of funds to operate their organization. In view of the fact that no funds were available, the request had to be refused.

#### COMMITTEE REPORTS

Public Works Dept.

1. Mr. Knochelman protested the appearance of the area to the rear of the Public Works garage. He said his efforts to get same cleaned up were to no avail, and that he had contacted the Ky. Post who had taken a picture of same, which would be run if the matter were not cleaned up. The Mayor agreed to implement the clean-up with members of the Public Works Dept.

## Police Department

#### Rescue Squad

- 1. Mr. Ehrman presented the report of the Rescue Squad which was received and filed.
- 2. Mr. Knochelman spoke to Council about an article appearing in the Park Hills Civic Assn. publication, The Hub, in which Rescue Chief Dreyer had appealed for funds to be used for the benefit of the Rescue Squad. He voiced objection to said statement, fearing that same might cause a decline in the sum collected in the annual Park Hills Civic Assn. Community Fund Drive, which funds are divided equally among the Fire Dept. Police Dept. and Rescue Squad. In the discussion which followed, various

- members of Council expressed the same opinion. Chief Ostendorf, speaking in behalf of the Vol. group of the Police Dept., said that he felt that all funds raised should be a Community project and not diverted to any one organization. No decision was reached on the matter.
- 3. Upon the request of the Chief of the Rescue Squad, a motion was made by Mr. Ehrman and seconded by Mr. McKinley that the Rescue Squad be allowed to participate in the Covington Memorial Day Parade on May 29th. - 4. - Rescue Squad Chief Dryer had presented to each member of Council a letter in which he expressed his disappointment in Council not having followed through in providing funds for more adequate service by the Rescue Squad. This involved among other things, the failure to continue the investigation of the possibility of the erection of a building to house the Rescue Squad. The Mayor pointed out that the seed money originally earmarked for this project was to come from the federal anti-recession fund, but that a survey of the use of the funds prohibited expenditures for building construction. Mr. Ehrman expressed the wish that funds be diverted from other departments to the Rescue Squad. This brought heated discussion from certain other departments. The letter which Chief Mark Dreyer had prepared had requested a meeting with Council to be held on May 11th for a further discussion of these matters and Council agreed that upon the closing of this meeting the meeting would be recessed to May 11th at 7:30 P.M.

THE CITY COUNCIL OF THE CITY OF PARK HILLS MET AT THE PARK HILLS CITY BUILDING ON THURSDAY, MAY 11, 1978, IN SESSION RECESSED FROM MAY 8, 1978, WITH MAYOR NIEHAUS PRESIDING AND COUNCILMEN EHRMAN, GORMLEY, KNOCHELMAN, McKINLEY, AND SORRELL PRESENT. ABSENT COUNCILPERSON SCHMITZ.

The purpose of this meeting was to discuss with members of the Park Hills Rescue Squad the possibility of providing additional financing to upgrade the operation of the department. During the discussion between Council and the Squad members, including the Rescue Squad Chief, Mark Dreyer, it developed that two items were of paramount interest to the Squad members:

(a) the remodeling of that portion of the City Bldg. now occupied by the ambulance vehicle or the providing of new space by the erection of an additional building and

(b) the possibility of financing the purchase of a new ambulance vehicle which would meet all Federal specifications.

Chief Dreyer and the Mayor discussed for the assemblage the tentative offer of Federal aid in the purchase of a new vehicle, pointing out that only \$10,000.00 of the total cost would be a Federal contribution with the City assuming the cost of the balance of the vehicle with the City's share being a minimum of \$15,000.00, but probably higher. The City Clerk-Treasurer, at the request of the Council, discussed with the Rescue Squad members the possibility of raising sufficient funds for a start on one of the major projects. It was pointed out that with all the funds that might be available for either project, the total amount which the City could possibly attribute would be approximately \$5600.00, said funds not being available until the start of the new Fiscal Year, July 1st. It was suggested that the Squad attempt to raise additional monies through some Community project and Mr. Dave Schlothauer, the President of the Park Hills Civic Assn., who was present, proffered the assistance of that organization in such activity as the Squad might select. Chief Dreyer felt that it might be possible to secure funds from several large donors, but the general concensus of opinion was that no fund drive per se should be conducted that might endanger the success of the annual Park Hills Community Fund Drive in which the funds were divided equally among the Park Hills Vol. Fire Dept., the Vol. Div. of the Park Hills Police Dept. and the Park Hills Rescue Squad.

After lengthy discussion, Squad Chief Dreyer said he wished to keep the option for action open until the matter was further discussed with the entire membership of the Rescue Squad.

With this matter concluded, a motion to adjourn was made by Mr. McKinley and seconded by Mr. Gormley. Mr. Ehrman, aye; Mr. Gormley, aye; Mr. Knochelman, aye; Mr. McKinley, aye; Mr. Sorrell, aye, and the motion carried.

THE CITY COUNCIL OF THE CITY OF PARK HILLS MET IN REGULAR SESSION AT THE PARK HILLS CITY BUILDING ON MONDAY, JUNE 12, 1978, AT 8:00 P.M., WITH MAYOR NIEHAUS PRESIDING AND COUNCILMEN EHRMAN, KNOCHELMAN, McKINLEY, SCHMITZ AND SORRELL PRESENT. COUNCILMAN GORMLEY ON VACATION.

A motion was made by Mr. McKinley and seconded by Mr. Ehrman that the minutes of the May 8th and May 11th meetings be approved as submitted. Mr. Ehrman, aye; Mr. Knochelman, aye; Mr. McKinley, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.

## PETITIONS AND DELEGATIONS

- The Rev. O. W. May of 1002 Rose Circle again appeared 1. before Council seeking permission to install a parking pad in front of his residence on the City right-of-way. Mayor Niehaus reported that he had investigated the request some time ago and was of the opinion that the occupant had sufficient ground adjacent to his present driveway to widen same, thus keeping the vehicles on his own property. The petitioner indicated that he thought the expense would be too great if sufficient room existed, which he doubted. The Mayor then suggested that Rev. May secure accurate sketches of his proposal and of the area on his own property, showing dimensions in the latter case. Rev. May left the Council and returned before the end of the meeting with the necessary drawings, at which time the Mayor accepted same and said that the matter would be further investigated by the Parking Pad Committee, consisting of the Mayor and Councilperson Virginia Schmitz, and that he would contact Rev. May following the inspection.
- 2. Mr. Fangman, owner of the Ed C. Kelly Plumbing Co., talked to Council about erecting a plumbing establishment and show room on a portion of the Castleman property on the Dixie Hwy., being lots 754 and 755 of the Mt. Allen subdivision, having a frontage of 144.65 feet along the Dixie Hwy. Mr. Fangman showed Council drawings of the proposed structure and Council agreed to permit the construction of said building pending approval by the Bldg. Insp./Zoning Administrator. Mayor Niehaus reported that he had contacted the No. Ky. Area Planning Commission, which had approved such structure although "plumbing establishments" was not listed among the allowable uses in the Neighborhood Commerical Zone of which this property is a part. The City Clerk had pointed out to the Mayor that no listing for "plumbing establishments" was provided for in either of the Commercial Zones and it was upon this basis that the No. Ky. Area Planning Commission had extended its permission.

- 3. Mrs. Henry Freckman, Sr. of Old State Road appeared before Council to inquire as to the reason for the failure of the Covington Catholic High School Assn. to replace a fence on property owned by her adjacent to the Covington Catholic H.S. Recreational Facility, sail fence having been removed during the construction of this facility. Mayor Niehaus had no answer from Mrs. Freckman and pointed out to the Council that the association in charge of the development of the facility had been negligent in performing those operations required by the Park Hills Board of Adjustment at the time the Non-conforming Use was permitted. Mayor Niehaus pointed out that in addition to Mrs. Freckman's fence the association had:
  - a. failed to complete the required access road into the C.C.H.S. property from Old State Rd.
  - b. failed to install the required catch basin at the rear of the residence located at 834 St. James

Mayor Niehaus assured Mrs. Freckman that he would follow up on her complaint and directed the Police Dept. to prevent any further implementation of Plan 3 of the project until all the requirements of Plan 1 and 2 had been completed, the Chief to contact Mr. Clem Hellmann, Secretary of the Park Hills Bd. of Adjustment, to determine said items.

Mr. Sorrell informed the Council that there was a meeting of the Association to be held at the school on June 21st

at 8:00 P.M. and that he would attend. The Mayor also indicated his intention to attend to discuss with the planners the incompleted portion of the project.

#### OLD BUSINESS

1. Attorney Ruth Klette appeared before Council relative to action to be taken by Council on approving the zoning change of property adjacent to the Town & Country Restaurant from Zone R1-FF to Highway Commercial, property being owned by Mrs. Olga Wooten and Mr. Glenn Caldwell. The Clerk read a letter from the No. Ky. Area Planning Commission, which had voted to approve said zone change. Miss Klette indicated that approval of the change had also been granted by the Kenton Co. Municipal Planning & Zoning Commission. The Clerk indicated that no written approval had been received from the latter body. The Engineer then discussed with Miss Klette and the Mayor the matter of the boundaries of the area to be rezoned. A motion was made by Mr. McKinley and seconded by Mr. Sorrell that an appropriate ordinance, authorizing the requested zone change be drawn up for presentation for passage to the City Council. Mr. Ehrman, aye; Mr. Knochelman, aye; Mr. McKinley, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.

- Closing of Kremer Avenue City Attorney Howard discussed, in detail, this action with members of Council. He saidthat in his investigation he found that in addition to Kremer Avenue, there existed on the property a passway of record that no longer was used as a public passway, but indicated that the presence of such made the problem more complex. It also appeared that one of the owners of property abutting Kremer Avenue, Mr. Coldiron, had not been contacted by the City relative to the closing. Mr. Howard indicated that the agreement which had been made with Glenn Caldwell, in which he agreed to pay all costs for the closing of Kremer Avenue, had presupposed that he would purchase from Mr. Coldiron that portion of the right-of-way which would become his upon the closing of the street. After lengthy discussion, it appeared that in any suit to close Kremer Avenue that all abutting and affected property owners. lessors and/or those having rights-of-way in and over the property must be considered in filing the required suit. This would include, but not necessarily limited to, Glenn Caldwell, Ronald Coldiron, the Covington Catholic Diocese representing Covington Catholic H.S., the U.L.H & P. Co. and the Cincinnati Bell, the latter two for possible easement rights. Council directed the City Attorney to pursue the matter with the understanding that agreement must be made with those indicated above, that the City would absorb none of the costs in the closing.
- 3. Receipt of fire hose bids The Clerk announced that in response to fire hose bids for the benefit of the Park Hills Vol. Fire Dept. that only two bids had been received:

The bids were referred for study to the Chief of the Fire Dept., who reported back to Council that he recommended the purchase of the alternate bid of the Webco Fire Equipment Co. at \$1108.00, whereupon a motion was made by Mr. Sorrell and seconded by Mr. McKinley that the alternate bid of the Webco Fire Equipment Co. be accepted at a

total of \$1108.00. Mr. Ehrman, aye; Mr. Knochelman, aye; Mr. McKinley, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.

- 4. The Grieme development of the former Butler property No additional information available and no one representing the developer was present.
- 5. Covington Catholic H.S. Recreational Facility no additional information other than that is contained in that portion of these minutes indicated as Petitions and Delegations.
- The cleanup of the Stamm and Toebben properties City Attorney Howard reported that following his letter, the Stamm Bros. had partially cleaned up that portion of the property they rent on the north side of the Dixie Hwy., but that little was done on the parking areas adjacent to the Ft. Mitchell Garage on the Dixie Hwy. He further told Council that he had contacted the property State authority about such action as the State could take in cleaning up the area. He indicated that the State must conduct an investigation before it could take any action. The City, however, Mr. Howard said, could file a suit against the owners for the violation of the nuisance and litter ordinances of the City of Park Hills. He further indicated that action by the State could be taken only if parked damaged cars could be adjudged to simulate "junk fard" conditions. Mr. Sorrell stated, and the City Attorney agreed, that the presence of as few as five cars badly damaged would constitute a violation of the State law. Mr. Howard was directed by Council to continue his contact with the State. It was further stated that in the case of John Toebben, that he seemed to be making some effort to clear up the blighted conditions.
- 7. Rose Circle sidewalk repair It appeared that no owners, who had received letters requiring the repair of side-walks in front of residences, had taken steps to have said done. The Mayor and the City Attorney pointed out that by sending letters to the residents the City was on record as having given warning and any liability would be that of the residents.

#### NEWBUSINESS

1. Mr. McKinley discussed the status of activities of festivals conducted by religious and/or educational institutions. The City Atty. indicated that such activites were controlled by State statutes and that the City was not in a position to take any steps to eleviate the situation.

1. Mr. Knochelman stated that he had taken steps to get rid of the trash at the rear of the City Bldg.

## Police Department

- 1. Mr. McKinley presented the report of the Park Hills Police Dept. for the month of May, which was received and filed.
- 2. Chief Ostendorf's request to recess this meeting at its end until June 15th at 8:00 P.M. for the purpose of discussing with the Council certain budgetary requests of the Police Dept. was confirmed by Council.

## Fire Department

 Mr. Sorrell presented the report of the Park Hills Vol. Fire Dept. for the month of May, which was received and filed.

- A motion was made by Mr. Ehrman and seconded by Mr. McKinley that the following reports submitted by the City Treasurer be accepted.

PROPERTY, PARK HILLS, KENTUCKY". A motion was made by Mr. McKinley and seconded by Mr. Sorrell that Ord. No. 11, 1978, be adopted as read. Mr. Ehrman, aye; Mr. McKinley, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.

Police Chief Ostendorf addressed Council on a number of subjects relating to the operation of the Police Dept.

- a. He expressed a desire to have the City Council pass an ordinance providing for rank structural changes in the table of organization of the Police Dept. Such table of organization would include a Chief, Captain, Lieutenant, Police Specialist and patrolmen of three grades. After lengthy explanation of this item Council took the following action: A motion was made by Mr. McKinley and seconded by Mr. Ehrman that the Chief of Police, with the cooperation of the City Attorney, prepare such ordinance for presentation to the Council at its next meeting.   - 2. Suggested, that when possible, Council give consideration to the hiring of another full-time patrolman.
  - 3. Suggested that the City look into the matter of providing pensions to full-time members of the Police Dept. in addition to maintaining the Social Security. Payment into a pension fund to be made jointly by the employee and the employer.

4. That the medical and hospitalization plan be changed to permit coverage of dependants with the cost being borne by the City.

Lengthy discussion on these matters followed with the members of Council and the Treasurer pointing out the lack of money in the present Budget to provide these additional fringe benefits. Upon the Chief's suggestion, Council agreed to look into the legality of asking the voters to approve a special tax to be levied for the benefit of the Safety Dept. of the City of Park Hills, said tax proposal to be put on the November 1978 ballot, if feasible.

c. The Clerk-Treasurer brought before Council a bill for professional liability insurance for all members of the Park Hills Police Dept. With the addition of new part-time and volunteer members, including the full-time police employees, the number of employees to be covered being 14. The bill is in the amount of \$2,457.00 or \$175.50 for each person covered. This bill represented an increase of \$1,773.00 over last year's coverage for fewer people. A motion was made by Mr. Ehrman and seconded by Mr. McKinley that the City accept said coverage and the Clerk be directed to pay same in the 1978-79 Budget.

#### COMMITTEE REPORTS

## Public Works Dept.

- 1. The Mayor and City Engineer are to check the water problem on Hamilton Road in connection with the property owned by Mr. Alvin Appel at 1165 Hamilton. Because of road conditions the rushing water is passing by the sewer and entering the basement at the above address. Steps will be taken to correct this problem.
- A new hand-rolled curb is to be installed near 615 Arlington Road.
- 3. Chief Ostendorf was informed by Rev. Wagner that a severe washing of water over his property located at Mt. Allen and Rosemont is eroding part of the lot.
- 4. The realtor handling the White Horse property will contact Mr. Castleman regarding the cutting of weeds, etc.

#### Police Department

- 1. Mr. McKinley presented the report of the Park Hills Police Department for the month of July, 1978, which was received and filed.
- 2. Chief Ostendorf informed Council that he has received several complaints regarding the unsightly and unsanitary conditions at the bus stop located at Hamilton and Amsterdam. Steps are to be taken to clean up the area and possibly stone-up the windows to offer better protection to residents during inclement weather.
- 3. The Crime Council meeting is to be held in September at Owensboro, Ky. Chief Ostendorf and Officer Smith will attend. Federal grants applied for by the cities will be discussed and approved at this meeting. Chief Ostendorf informed Council that matching funds from the cities can now be taken out of the Federal Revenue Sharing Fund.
- 4. Northern Kentuccky University is offering law enforcement classes for part-time patrolmen. The fee is \$40.00 per person. Three or four members of the department are interested in attending. Council was also informed by Chief Ostendorf that Officer Gloria Webster, a member of the Volunteer Div. of the Department, is currently attending law enforcement classes at Eastern Kentucky University, at her own expense.
- 5. Chief Ostendorf has looked into group hospitalization insurance for the department. He was informed by Blue Cross/Blue Shield that the City must have five or more employees for such insurance, which would cost \$72.50 per month, per family. An individual contract for such insurance would be much more costly, with less benefits.
- 6. Pension Plan The Chief is still checking into more information regarding this plan. In regard to a special tax for police or safety services here in Park Hills, the department is still waiting for word from the Attorney General's Office as to the legal means of doing this.
- 7. Chief Ostendorf informed Council of the need for a taping device on the police phone in the office. After checking with the phone company, he was told they could install two terminals on the phone, plus a speaker. A tape deck would also be connected to the phone for recording incoming calls. This equipment would cost approximately \$150.00 \$175.00, plus installation fee. Monthly charges for the terminals and speaker would be approximately \$5.00 per month. The \$69.00 cost of the tape deck could be paid for out of Federal Revenue Sharing Funds. Information was also received from the phone company on "call waiting".

# PETITIONS AND DELEGATIONS

- 1. Mr. Curt Bahr of 1028 Rose Circle appeared before Council for permission to widen his driveway approximately 20 feet, a portion of which would extend onto the City right-of-way. He presented a plot showing the contemplated improvement and following the usual procedure in such cases the Mayor is to investigate for approval or disapproval of the project, informing Mr. Bahr of the decision.
- 2. Mr. Bernie Wehrmeyer, representing the Park Hills Civic Association, requested that the grass in the entire Veterans Park area on Park Drive be cut, claiming that a portion of it had been neglected.
- 3. Speaking for himself, Mr. Wehrmeyer asked if it was possible that the siren not be sounded on fire calls after 11:00 P.M., claiming it was a nuisance. #### OLD BUSINESS

- 1. Mr. McKinley moved that the Monthly Report of the Pærk
  Hills Police Dept. for August, 1978, be approved as submitted,
  and seconded by Mr. Gormley. Mr. Gormley, aye; Mr. Ehrman,
  aye; Mr. Knochelman, aye; Mr. McKinley, aye; Mrs. Schmitz,
  aye; Mr. Sorrell, aye, and the motion carried.
- 2. Chief Ostendorf reported that the telephone equipment to be added to the police phones had not been delivered.
- 3. Council discussed again the possibility of providing money for a pension plan for the Police Dept. City Atty. Howard felt that Council could enact a special levy for this purpose, not to exceed 3¢ per \$100.00 evaluation, but that before any action was taken he requested additional time to check the legality of such procedure.
- 4. A changeover from the present hospitalization plan for the paid policemen was discussed, with membership in Blue Cross/Blue Shield, including Major Medical, proposed on a family-plan basis. It would require five applicants or contract holders. The Chief being imsured under his wife's policy, would not be chargable against the City of Park hills. It was proposed that the family plan be taken for Lt. Heideman, Patrolmen Smith and Hellmann, with the City assuming the total cost thereof. In order to have a sufficient number it would be necessary that Barbara Slukich and the Ass't. City Clerk, Evelyn Fogarty. opt to take this plan with the cost to be borne by themselves. The City Clerk pointed out that based on the current rate there would be an additional expenditure of \$1337.00 to cover the three in the Police Dept. Lengthy discussion followed and the Mayor appointed a committee, consisting of himself, Councilman McKinley and the City Clerk, to work with the Chief of Police in this matter.
- 5. The Chief reported in the matter of the grant from the LEAA for addition to the alarm system that the authorities wanted to grant this on a continuing basis while the City wished said grant to be on an initial basis. The reason for such action being that the cost to the City would be much greater under the continuing basis.

#### P.D. continued

- 6. The City Clerk read the resignation of Mr. Larry Hall as a parttime member of the Police Dept. and of Mr. Steve Hellmann as a member of the volunteer division of the Police Dept. A motion was made by Mr. Sorrell and seconded by Mr. Ehrman that the resignations be accepted. Mr. Gormley, aye; Mr. Ehrman, aye; Mr. Knochelman, aye; Mr. McKinley, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.
- 7. The City Clerk reported to Council on his contact with the Ky. Municipal League concerning participation in "The Self Insured Workman's Compensation Plan". He pointed out that our present Workmen's compensation did not expire until 12/31/78 and that while the new plan would offer a savings of 10% he wished further time to investigate the plan before making a recommendation to Council.

## Fire Department

- 1. Mr. Sorrell presented the report of the Park Hills Vol. Fire Dept. for the month of August, 1978, which was received and filed.
- 2. The City Clerk read a letter from the Park Hills Fire Dept. signed by Robert Kaelin, Captain, making the following request:

"The Park Hills Fire Dept. requests that when the station wagon that is presently the Life Squad vehicle is replaced, that the station wagon be assigned to the FireDept. to be used by its members to attend meetings, perform inspections and other work that might be Fire Dept. related."

The Fire Dept. agreed that if the City would pay the insurance on the vehicle that the Fire Dept., from its own funds, would pay all other expenses, including gasoline, maintenance and repair.

Discussion followed and Council agreed to the request with the understanding that no other expense than the insurance be paid by the City and that the Fire Dept. establish a list of persons eligible to use said vehicle and that a log be kept showing the date of the use, by whom used and the purpose for which the use was made, with said log subject to study by the City Council. A motion was therefore made by Mr. Knochelman and seconded by Mr. McKinley that the transfer of the vehicle be made subject to the conditions listed above. Mr. Gormley, aye; Mr. Ehrman, aye; Mr. Knochelman, aye; Mr. McKinley, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.

#### Finance Department

- 1. A motion was made by Mr. Gormley and seconded by Mr. Ehrman that the following financial reports be approved as submitted:

- 2. The City Clerk gave Council the report of the expenditure of sums from the Federal Revenue Sharing Fund re the newly acquired ambulance.

#### Building Inspector Report

- 1. Mr. Earl Paul, Zoning Administrator, said he had the plot plan of the Fangman project on Dixie Hwy.
- 2. The City Clerk reported that during the month of August 8 building permits had been issued.

#### COMMUNICATIONS

1. From Dorothy Ostendorf, thanking Council for flowers sent while she was in the hospital.

#### SPECIAL

Mr. Ralph Grieme, a resident of Park Hills, representing the organization "The Friends of Devou Park" appeared before Council to request its cooperation as one of the cities abutting Devou Park in providing support, not financial, for the efforts of the organization to upgrade the facilities and use of the Park. He felt this support was necessary in order that adequate nonpolitical support could be secured, partially through Federal and State grants. He requested that the Mayor write a letter supportive of the Friends of Devou Park and that a member of Council be appointed to serve on a committee of abutting cities. A motion to so do was made by Mr. Ehrman, seconded by Mr. McKinley. Mr. Gormley, aye; Mr. Ehrman, aye; Mr. Knochelman, aye; Mr. McKinley, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried. THE CITY COUNCIL OF THE CITY OF PARK HILLS MET IN REGULAR SESSION AT THE PARK HILLS CITY BUILDING AT 8:00 P.M. ON MONDAY, OCTOBER 9, 1978, WITH MAYOR NEIHAUS PRESIDING AND COUNCILMEN GORMLEY, EHRMAN, KNOCHELMAN, MCKINLEY, SCHMITZ AND SORRELL PRESENT.

A motion was made by Mr. McKinley and seconded by Mr. Ehrman that the minutes of the meeting of September 11, 1978, be approved as submitted. Mr. Ehrman, aye; Mr. Gormley, aye; Mr. Knochelman, aye; Mr. McKinley, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.

The regular order of business was waived to permit the consideration of new business.

#### NEW BUSINESS

- The Clerk presented Ordinance No. 14, 1978, "AN ORDINANCE AMENDING ORDINANCE NO. 9, 1976, DEALING WITH THE FRINGE BENEFITS FOR THE EMPLOYEES OF THE PARK HILLS POLICE DEPARTMENT". A motion was made by Mr. McKinley and seconded by Mr. Ehrman that Ord. No. 14, 1978, be adopted as read, and that employees, Barbara Slukich and Evelyn Fogarty, be included in the same coverage on the basis that the City will assume the cost of a single person contract.

  Mr. Erhman, aye; Mr. Gormley, aye; Mr. Knochelman, aye; Mr. McKinley, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.
- 2. The Clerk presented for Council consideration the unemployment insurance requirement mandated to become effective for employees of Municipalities on January 1, 1979. A detailed explanation of the provisions of the law effecting Municipalities was given by the Clerk, who indicated to Council that it was uncertain if parttime employees had to be covered under the provisions of the law. Conflicting statements had been given by various State employees on this point and the Clerk was directed to further pursue the matter to determine the total coverage required. The Clerk also indicated that each City had two options in qualifying for this co wrage. Option A - direct contribution, being 2.7 of the first \$6000.00 of any covered employee's salary or Option B - the reimbursement plan wherein the City contributed a lump sum of 2% of the first \$6,000.00 of all covered employees and would be liable for additional payments if amounts paid out of this fund to eligible employees exceeded the amount funded. The Clerk further indicated that he had been advised by the Dept. of Human Resources, the Ky. agency handling this fund for cities, that it would be necessary that the City draw up apolicy of what constituted full time employment, since one of the explanations was that only full time employees needed to be covered.

# New Business (continued)

Following lengthy and detailed discussion, a motion was made by Mr. Ehrman and seconded by Mr. McKinley that for purposes of unemployment insurance coverage that an employee be deemed to be full time only if regularly employed for a period of 40 hours per week during the term of his employment and that coverage be extended only to such persons unless, after further investigation. it developed that the State and/or Federal statutes required that all employees, both full and part time be covered. Mr. Ehrman, aye; Mr. Gormley, aye; Mr. Knochelman, aye; Mr. McKinley, aye; Mrs. Schmitz, aye; Mr. Sorrell, ave. and the motion carried. A motion was then made by Mr. Gormley and seconded by Mr. Ehrman that the City elect "the direct contribution" method of contributing to the mandated unemployment insurance program. Mr. Ehrman, aye; Mr. Gormley, aye; Mr. Knochelman, aye; Mr. McKinley, aye; Mrs. Schmits, aye; Mr. Sorrell, aye, and the motion carried. The Clerk further pointed out that there was a conflict of opinion as to the insurance coverage for persons drawing Social Security, past the age of 65, who had previously been employed in other occupations and who were technically described, because of their age, as "unemployable". Council directed the Clerk to attempt to secure adequate answers to all of these existant problems.

- The Clerk submitted to each member of Council a study on the effect of the Homestead Exemption on the tax collection of the City, pointing out that from 1972 to 1978 the number of exemptions had increased from 135 to 227 and that the exempted amount from \$6500.00 for eligible participants to \$8900.00. The figures, as presented by the Clerk, showed the amount of lost revenue due to the increase in the Homestead Exemptions and further presented a schedule showing what portion of the revenue lost could be recovered at slight varying increases in the tax rate. The Clerk reminded Council that the Park Hills tax rate was frozen under existing State statutes, but that a provision of this law provided for increases to cover the loss of revenue through Homestead Exemption. The Clerk stated that no action was necessary on the tax rate at this meeting, but that final consideration of the tax rate for the year 1979 should be given in December of 1978. Council members were requested to study the explanation as provided for action at a later date.
- 4. The Clerk then informed Council that the five-year Franchise, which had been awarded to the Union Light, Heat & Power Co. for street lighting units within the City, had expired in May of 1974, but that said corporation had taken no steps until today to provide a new contract.

The Clerk explained the salient features of the proposed new Franchise to the members of Council, pointing out three major changes from the expired contract. These were: (1) The new Franchise contract would run for a period of three years only; (2) The perpetual monthly charge on poles erected for the installation of additional street lights had been increased from \$1.00 to \$3.00 per month; (3) That there was a substantial increase in the cost of most of the lighting units presently in service within the City. The net result of the proposed contract Franchise would be to increase the monthly street lighting bill to \$485.00 per month, an increase of \$95.35 a month over the present cost, this being an increase of 24%. At the same time the Clerk advised Council that the cost of providing service with 2500 lumen mercury vapor lamps would be the same as the charge for 7000 lumen mercury vapor lamps. Lengthy discussion followed, the Clerk pointing out the only way to maintain the present cost would be through the elimination of 20 residential site 2500 mercury lumen lights, but that this was inadvisable as such elimination would constitute additional hazard. Having no other option, in the lack of competitive bids, it was determined to accept the contract as presented. The Clerk then read Ord. No. 15, 1978, " CONTRACTING WITH THE UNION LIGHT, HEAT & POWER COMPANY FOR LIGHTING BY ELECTRICITY THE STREETS AND OTHER PUBLIC WAYS OF THE CITY OF PARK HILLS, KENTON COUNTY, KENTUCKY, FOR A PHRIOD OF THREE (3) YEARS AND FIXING THE PRICE THEREOF". A motion was made by Mr. Ehrman and seconded by Mr. McKinley that Ord. No. 15, 1978, be adopted as read and that as a part of this motion the Clerk be directed to notify the successful bidder that the City desired the replacement of all 2500 lumen mercury vapor lamps with 7000 lumen mercury vapor lamps at no installation cost to the City. Mr. Ehrman, aye; Mr. Gormley, aye; Mr. Knochelman, aye; Mr. McKinley, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.

#### OLD BUSINESS

- 1. Dr. Carl Brueggemann of the Covington Catholic H.S. SCORE committee was present to make a report and answer questions as to the development of the C.C.H.S. Recreational Facility. The results were as follows:
  - (a) Freckman fence was completely erected
  - (b) Sanitary sewer from the Concession-Press Box stand had, as yet, not been completed
  - (c) The connection of the surface drain at the rear of 834 St. James had not been completed due to what were called engineering problems

    In this matter the Mayor requested the opinion of the Park Hills City Engineer, who said that if the specifications were followed, he felt that there would be no difficulty in the completion of this part of the project.

# Old Business (continued)

The Mayor then directed that the Park Hills City Engineer contact the engineer of the C.C.H.S. Recreational Facility to set up a meeting of the two engineers and the Mayor to implement this matter.

- (d) Dr. Brueggemann was unable to provide any information as to the completion of the drainage program of the area.
- 2. The closing of Kremer Avenue City Attorney Howard said that the matter had been referred to the proper Court for disposition, but that no date had been set for the hearing, but that he expected same to occur within two months.
- 3. City Attorney Howard reported that on the matter of cleaning up the Dixie Hwy. through Court proceedings that a test suit filed against a similar ordinance in Campbell County, Ky. had been docketed, but had never come up for a hearing and until ajudgment was rendered in this case that it would be unwise to proceed further. The Clerk informed Council that in a conversation with Mr. Toebben, the latter had indicated that he was going to approach Council relative to the construction of a building on a part of the site in question.
- 4. City Attorney Howard also reported that in the matter of the condemnation of the structure at the rear of 1504 Dixie Hwy., that it would be necessary under the law for the attorney to contact the Kenton County Fiscal Court, which is the only authority under whose aegis such proceedings may be conducted and that it would be necessary, as provided by the Park Hills ordinances, that a written statement, provided by the Park Hills Police Chief and the Park Hills, Fire Chief, setting forth the reasons for the action be made a portion of this plea. Whereupon, the City Attorney presented Resolution No. 9, 1978, "A RESOLUTION IMPLORING THE KENTON COUNTY FISCAL COURT TO TAKE ACTION TO ENFORCE THE REPAIR AND/OR DEMOLITION OF THE PROPERTY LOCATED AT THE REAR OF 1504 DIXIE HIGHWAY. PARK HILLS, KENTUCKY". A motion was made by Mr. McKinley and seconded by Mr. Gormley that Res. No. 9, 1978, be adopted as read. Mr. Ehrman, aye; Mr. Gormley, aye; Mr. Knochelman, aye; Mr. McKinley, aye; Mrs. Schmitz, aye; Mr. Sorrell, aye, and the motion carried.
- 5. Major Street Improvement The City Engineer informed Council that he had contacted the Interstate Asphalt Co., which has the contract for major street improvement, and had been informed that the work would be started and completed before inclement weather sets in.

#### COMMITTEE REPORTS

Public Works Dept.

- 1. Mr. Knochelman outlined for Council the basic routes to be taken by the snow plow on a basis of a worked out priority when such service was required.
- 2. That the Public Works Dept. secure for placement at strategic locations, which locations would be indicated by the Public Works Dept., barrels for salt and/or sand to facilitate traffic movement during the bad weather.
- 3. Outlined a proposal to be drafted into an ordinance providing "No Parking Snow Emergency" lanes and a series of streets to be declared One Way during such emergency. Council showed some hesitancy in adopting this plan without a more definite knowledge of its detail and the Mayor requested that Mr. Knochelman provide to the City Clerk for distribution to the Council members detailed items, as reflected in his report, and that no action be taken pending a study of same.

#### Police Dept.

- 1. A motion was made by Mr. Knochelman and seconded by Mr. Gormley that the report of the Police Dept. for the month of September, 1978, be approved as submitted. Mr. Ehrman, aye; Mr. Gormley, aye; Mr. Knochelman, aye; Mr. McKinley, aye; Mrs. Schmitz, aye; Mrs. Sorrell, aye, and the motion carried.

  Note: At this juncture, Mayor Niehaus excused Councilwoman Schmitz.
- 2. Chief Ostendorf described, in detail, the plan promulgated by a committee of the Police departments of Kenton County, whose territory included or abutted I-75 to provide traffic coverage and control in an effort to reduce accidents in the area.

#### Fire Dept.

- 1. A motion was made by Mr. McKinley and seconded by Mr. Ehrman that the report of the P.H. Fire Dept. for the month of September, 1978, be approved as submitted. Mr. Ehrman, aye; Mr. Gormley, aye; Mr. Knochelman, aye; Mr. McKinley, aye; Mr. Sorrell, aye, and the motion carried.
- 2. Chief Dreyer announced that the P.M. Vol. Fire Dept. would be host to the November, 1978, meeting of the No. Ky. Firemen's Assn. to be held at Notre Dame Academy on November 21st.
- 3. Chief Dreyer spoke briefly of the new requirement in the State law which would require that all two or more family dwellings newly erected or remodeled must have a smoke detector and, in some cases, all plans must be approved by the State Fire Marshall's office.

The Clerk discussed with Council the advantages of participating in the Unemployment Insurance Program. coverage for Municipal employees being mandated by Federal Statute, effective January 1, 1979. He reminded Council that the City had previously filed an application for this coverage with the Dept. of Human Resources of the State of Kentucky, but that since this filing it appeared advantageous to consider participation in the program offered by the Ky. Municipal League by the adoption of the above resolution and that the action taken by the Council at its meeting on October 9, 1978, in participation with the plan for unemployment insurance sponsored by the Dept. of Human Resources of the State of Kentucky be voided. - 3. The Clerk then presented a detailed study to members of Council on the tax rate situation proposed for the year 1979. He indicated that since the rate had been set for the year 1979 at \$3.60 per one thousand dollar valuation, that a substantial change had been made in the amount of the Homestead Exemption allowed eligible participants. The Ky. Dept. of Revenue had increased the Homestead Allowance from \$8900.00 to \$10200.00 and that this had resulted in additional substantial reduction from the assessed valuation of property within the City, reducing said valuation \$308,100.00, with a resultant tax loss. The study indicated that in order to recover the losses to the City in the granting of Homestead Exemptions since 1973, when the last adjustment was made, to compensate for Homestead Exemptions, that it would be necessary to further increase the tax rate over the tax rate approved by motion at the November 13th meeting. Councilman McKinley suggested an increase in the trash collection fee in lieu of an increase in the tax rate, compensating for Homestead Exemptions. Following lengthy discussion the Clerk then introduced

Following lengthy discussion the Clerk then introduced Ordinance No. 17, 1978, "AN ORDINANCE FIXING THE TAX RATE OF THE CITY OF PARK HILLS FOR THE YEAR 1979 LEVYING A TAX ON ALL REAL AND PERSONAL PROPERTY SUBJECT TO TAXATION FOR GENERAL PURPOSES: FIXING THE DATE OF PAYMENT, AND PROVIDING

A PENALTY FOR FAILURE TO PAY SAME AT SUCH TIME."

A motion was made by Mr. Gormley and seconded by Mr. Ehrman that Ord. No. 17, 1978, be adopted as read. Mr. Gormley, aye; Mr. Ehrman, aye; Mrs. Schmitz, aye; Mr. Knochelman, aye; Mr. McKinley, no, and a motion was carried by a vote of four ayes and one nay.

- 4. A motion was made by Mr. Knochelman and seconded by Mr. Gormley that the action taken by Council at its regular meeting on November 13, 1978, setting the tax rate at \$3.60 per thousand be rescinded. Mr. Knochelman, aye; Mr. Gormley, aye; Mr. Ehrman, aye; Mr. McKinley, aye; Mrs. Schmitz. aye, and the motion carried.
- 5. The Clerk then presented each Council member with a detailed study comparing the salaries paid and fringe benefits available to paid member of Police departments among 15 cities in the No. Ky. counties of Boone, Kenton and Campbell. This study was the result of a questionnaire sent to the Clerk-Treasurer of the various cities by the Clerk upon the direction of Mayor Niehaus. Council members compared the status of Park Hills paid Police personnel in all phases of the Study as submitted and after lengthy discussion, the Mayor requested that each Council member study at length and in detail the contents of the results of the questionnaires and be prepared to make suggestions as to the desirability of upgrading the benefits and/or wage salaries of full-time members of the Park Hills Police Dept.

As a part of this discussion the matter of a creation of a Pension Plan was again discussed and the Clerk was designated to secure information as to the various types of pension plans available for the Police personnel.

There being no further business to appear before the Council, a motion to adjourn was made by Mr. Knochelman and seconded by Mr. Gormley. Mr. Ehrman, aye; Mr. Gormley, aye; Mr. Knochelman, aye; Mr. McKinley, aye; Mrs. Schmitz, aye, and the motion carried.

THE CITY COUNCIL OF THE CITY OF PARK HILLS MET IN REGULAR SESSION AT THE PARK HILLS CITY BUILDING AT 8:00 P.M. ON MONDAY, DECEMBER 11, 1978, WITH MAYOR NIEHAUS PRESIDING AND COUNCILMEN EHRMAN, GORMLEY, KNOCHELMAN, McKINLEY, SORRELL AND SCHMITZ PRESENT.

A motion was made by Mr. Gormley and seconded by Mr. McKinley to accept the minutes of November 13th and 20th as submitted. Mr. Ehrman, aye; Mr. Gormley, aye; Mr. McKinley, aye; Mr. Knochelman, aye, and the motion carried.

#### OLD BUSINESS

- 1. Consideration of Police pension Mr. Castle of the Kentucky State Retirement System was present at the invitation of Chief Ostendorf. He outlined the pension plan as provided by the Kentucky State Retirement System as to contributions, vesting and benefits available under this plan.

  Numerous questions were directed to Mr. Castle by the Mayor and members of the Council and the City Clerk-Treasurer. The Clerk-Treasurer informed the Council that under the direction of the Mayor he had instituted inquiries concerning several pension plans available to city employees. Following Mr. Castle's presentation the Clerk was directed to continue his efforts to secure additional information from other pension plans.
- 2. Covington Catholic H.S. Recreational Facility -Mr. McKinley, speaking both as a Councilman and a resident of the City, informed Council that there had been a land slippage at the rear of a number of lots facing Old State Road and abutting the new recreational facility of the Covington Catholic H.S. He indicated that he had suffered considerable damage to a swimming pool and a pavilion as a result of the slide. The City Engineer had visited the site and gave the opinion that the slippage was entirely due to the creation of the recreational field. Mr. Knochelman stated, that in discussion with the SCORE committee, they had instructed their engineer, Mr. James Berling, to investigate. He had so done, and the Carlisle Construction Co., the major contractor of this project, was to take the necessary steps to repair and prevent further loss through slippage. Members of Council advised Mr. McKinley that they felt he should secure from the developers of the facility a statement of responsibility for his damage. The Clerk indicated that the damage done to the rear yard at 834 St. James by the developers of the facility had not been repaired. Mayor Niehaus agreed to contact the facility engineer in an effort to implement work on both of the above-referred projects.

# Old Business (continued)

- 3. Kremer Avenue Closing Mr. Crigler, substituting for Mr. James Howard as City Attorney, was present and said that the closing of Kremer Avenue had been referred to the Master Commissioner, who was awaiting a survey of the area before final action was taken in this matter.
- 4. Condemnation of 1504 Dixie Highway Mr. Crigler presented letters sent by Mr. Howard to the Kenton County Fiscal Court, requesting that it use its statutory powers to proceed with condemnation of the property, being a brick residence, presently unoccupied, at the rear of the lot. He also presented a letter to Mr. Evangelos Levas, who was buying the area on a contract from its present owner of record, Mrs. Roberta Callahan, informing him of the request made to the Fiscal Court and asking either that the property in question be restored to habitable use or be demolished by the owner(s) to provide any Court action.
- 5. Major street repair City Engineer Paul indicated that it appears that the contract awarded during the summer of 1978 to the Interstate Asphalt Company for the 1978 improvements would not be carried out until the spring of 1979. In the matter of the 1979 major improvements, through funds provided by the Department of Transportation of the Kentucky State Highway Dept., the City Engineer was directed to prepare the necessary plans and designations for such improvement for presentation to the State Hwy. Dept. for their acceptance and approval.
- 6. Snow Parking Emergency Mayor Niehaus requested that Mr. Knochelman, the Chairman of the Public Works Committee, arrange a meeting, including the Mayor, Mr. Knochelman and the Chief of the Park Hills Police Dept., to make a final review of the snow emergency plan, as previously presented to Council.
- 7. Rosemont Avenue repair The Clerk and Councilman Sorrell reminded Council that a portion of this street needed to be investigated due to a sinking of a portion of the roadway. The Mayor agreed to meet with the City Engineer to investigate this matter and recommend steps to be taken to repair same.
