THE CITY COUNCIL OF THE CITY OF PARK HILLS MET IN REGULAR SESSION AT THE PARK HILLS CITY BUILDING ON MONDAY, JANUARY 12, 1987, WITH MAYOR FANGMAN PRESIDING AND COUNCILMEN KAELIN, OSTERHAGE, SOMMERKAMP, SORG, SORRELL, AND WEHRMEYER PRESENT.

Pledge of Allegiance

Roll Call

A motion was made by Mr. Osterhage and seconded by Mr. Sommerkamp that minutes of the December 8, 1986, meeting be approved. Before roll call was taken an error in paragraph 5, (P.D.) page 2, was corrected as follows: The amount of \$40,00000 was changed to \$40,000.00. Mayor Fangman then amended the motion to include the corrected error. Mr. Osterhage, aye; Mr. Sommerkamp, aye; Mr. Sorg, aye; Mr. Wehrmeyer, aye; Mr. Sorrell, aye; Mr. Kaelin, aye; and the motion carried.

A letter of resignation, effective immediately, was read by Councilman Wehrmeyer. A motion was made by Mr. Osterhage not to accept such resignation, but when asked, Mr. Wehrmeyer replied the resignation still stands. Discussion followed concerning the length of time allowed for replacement, which is 30 days or such appointment would be made by the Governor of the State. A second to Mr. Osterhage's motion not to accept the resignation was made by Mr. Sorrell. Mr. Osterhage, aye; Mr. Sorrell, aye; Mr. Sorg, aye; Mr. Wehrmeyer, aye; Mr. Sommerkamp, aye; Mr. Kaelin, aye; and the motion carried. Mayor Fangman, on behalf of the City of Park Hills, thanked Mr. Wehrmeyer for his excellent work and dedication while on Council. All Council members and employees wished him well. Mr. Wehrmeyer then left Council Chambers.

Mayor Fangman informed Council the appointment is effective until the end of 1987 only. All residents wishing to run for Council seat for the 1988-1989 term must have petition on file by February 25th, which is 90 days before the May 26th primary.

News notes of an opening on Council will be inserted in The Kenton County Recorder and Kentucky Post, with applications being accepted until January 29th. Council will meet in special session to consider all applications received, with written notification given $2l_4$ hours previously to the media concerning such meeting. This meeting will be held February 2nd or February 9th, at 7:00 PM depending on the number of applications received.

PETITIONS & DELEGATIONS - None

COMMITTEE REPORTS

Public Works Department

- 1. All members of Council received a copy of the daily log sheet to be filled out by the P.W. employee, Mr. Budde. After studying the form, Mr. Osterhage questioned the use of rental equipment. This is done when authorized by the Mayor. Such daily log will be reviewed by the Mayor and committee.
- 2. The drain and paving work at Amsterdam and Terrace has been corrected and completed. The Mayor requested Mr. Bieger, BI/ZA, prepare a bid for the curb section of Amsterdam, with such bid let for the month of March. Bids would then be let for the resurfacing of Amsterdam in April or May. All bids will be advertised since they will be over \$7500.00. Mr. Carey, City Attorney, reminded Council the work covered by the bids must be the same as contained in the original bid.

3. The City Clerk informed Council that many complaints have been received from residents concerning trash not being picked up and personnel attitude. A letter will be sent out over the Mayor's signature, informing the collector, Rumpke of Ky., they will not be considered for the new contract if the situation is not remedied.

Councilman Sorrell told Council that many residents do not use proper containers, etc., which was confirmed by Chief Ostendorf. Council discussed the contents of the ordinance concerning amount and type of trash that can be put out; times for setting out and removing cans from the street, which are the responsibility of the residents. Information concerning such responsibility will be included in the Mayor's report in the next issue of the Hub.

Police Department

- 1. A motion was made by Mr. Sorg and seconded by Mr. Osterhage that report of the Park Hills Police Dept. for the month of December, 1986, be accepted as submitted. Before Roll Call was taken Mayor Fangman questioned Chief Ostendorf on use of Council Chambers during a week in November for a criminology class to be given by the FBI. There will be no cost to the City for this class.
- 2. The Chief informed Mayor Fangman that two officers will be attending a Firearms Instructor Course to be ehld in the Covington area. It is expected these classes will cover yearly certification schooling for police officers in the Police Incentive Program.
- 3. Mayor Fangman told Chief Ostendorf that a letter will be sent to Kenton Co. Executive Judge Aldemeyer, requesting change of the new Traffic Citation System concerning dispositions.
- 4. Chief Ostendorf explained to Council the possibility of a grant being obtained through the N.K.A.D.D. for a computer system to be used by several departments in the area, which will given access to all Police information to departments participating in same. The Chief told Council that 30,000 names are on file in the Police Dept. office.

Roll Call for the motion to accept report was then taken: Mr. Sorg, aye; Mr. Osterhage, aye; Mr. Kaelin, aye; Mr. Sommerkamp, aye; Mr. Sorrell, aye; and the motion carried.

Fire Department

- 1. A motion was made by Mr. Sorrell and seconded by Mr. Sommerkamp that report of the Park Hills Vol. Fire Dept. for the month of December, 1986, be accepted as submitted. Mr. Sorrell, aye; Mr. Sommerkamp, aye; Mr. Sorg, aye; Mr. Osterhage, aye; Mr. Kaelin, aye; and the motion carried.
- 2. Chief Finke told Council the department was on back-up call for the Covington Fire Dept. when several fires broke out at once in that area.
- 3. Roof leaks have been noted: one in the area housing fire equipment and one in the area between the P.W. building and Rescue Squad. A new roof will be needed in the near future.

Rescue Squad

- 1. A motion was made by Mr. Sorg and seconded by Mr. Osterhage that report of the Park Hills Rescue Squad for the month of December, 1986, be accepted as submitted. Mr. Sorg aye; Mr. Osterhage, aye; Mr. Kaelin, aye; Mr. Sommerkamp, aye; Mr. Sorrell, aye; and the motion carried. Mayor Fangman asked Chief Dreyer to try and have the report ready for Council prior to the night of the meeting.
- 2. The electrical inspector will be contacted by Mayor Fangman so a meeting can be set up with the Fire Chief for inspection of electrical wiring in the Fire Dept. area. Chief Dreyer also told Council that Rescue Squad personnel will need to get into the Fire Chief's office to finish electrical wiring for the Rescue Squad building.
- 3. Chief Dreyer requested the City Attorney obtain copies of current driving regulations and any passed laws pertaining yo emergency vehicles. This information will help the squad update their drivers' training course.
- 4. Councilman Kaelin informed Chief Dreyer that Rescue Squat personnel will be cove ed under the same State Workers Compensation as Vol. Fire Dept. members.
- 5. Mayor Fangman informed Chief Dreyer he received a letter from the Division of Health, Policy & Resource development concerning equipment funding application received from the City of Park Hills. Chief Dreyer was aware of this application.

Finance Dept.

- 1. A motion was made by Mr. Osterhage and seconded by Mr. Kaelin that financial reports for the month of December, 1986, be accepted as submitted. Mr. Osterhage, aye; Mr. Kaelin, aye; Mr. Sommerkamp, aye; Mr. Sorg, aye; Mr. Sorrell, aye; and the motion carried.
- 2. Duplication of insurance policies will be checked into. The various departments have insurance policies paid out of their own funds, which may be covered by policies owned by the City. Consolidation of all policies will be studied. Chief Ostendorf suggested bids be solicited from brokers for all insurance coverage, asking for a complete survey of hazards. Mayor Fangman concurred with this suggestion. The Clerk was directed to call KML and the N.K.A.D.D. requesting assistance in consolidating all the insurance coverage now held by the City.
- 3. The City Clerk presented to Council an occupational license transfer from Bernard Medical Resources to James Barton, PSC, dba Park Hills Animal Hospital, for their approval. Discussion followed concerning prior violation by the former owner, such violation being the sale of refurbished medical equipment, which is not allowed under the occupational license issued. The City Attorney informed Council the transfer of the occupational license to do business as an animal hospital should be approved. If any violation of such license is noted in the future the new owner would then be notified of his violation. Mr. Barton has bought the hospital, with an apartment therein. Dr. Bernard did not sell his personal living quarters. The property cannot be used for anything but an animal hospital, which has been grandfathered in.
- 4. The City Clerk presented to Council the audit prepared by Robert Hofacre, CPA, of the City of Park Hills financial records for the fiscal year ending June 30, 1986.

Discussion followed re contents of the audit, amounts left in special funds, etc. Following same, a motion was made by Mr. Sorrell and seconded by Mr. Osterhage to accept the audit report of financial statements for the year ending 6/30/86, as submitted. Mr. Sorrell, aye; Mrl Osterhage, aye; Mr. Kaelin, Mr. Sommerkamp, aye; Mr. Sorg, aye; and the motion carried.

Personnel Policy Committee

1. Mr. Sommerkamp, member of the committee, told Council further study has been given to chapter 13 of the proposed Personnel Policy. The chapter has not been completed. The Mayor informed Council the committee will meet again on February 2nd if the date does not conflict with a special meeting of Council which may have to be called to consider appointment of a new council person to fill a vacanct.

BUILDING & ZONING MATTERS

- 1. Mayor Fangman told Council a building permit application from Matth. Toebben to erect a building for A-1 Electric Supply has been received. Mr. Bieger, the BI/ZA, had submitted a list of questions to the Mayor concerning setback, parking, etc., which will have to be studied.
 - 2. Three building permits had been issued during the month of December.
- 3. Request to erect pole sign for Szechuan Gardens Restaurant denied by the Bldg. Inspc. it does not comply with zoning ordinance. Mayor Fangman told Council the sign at the Park Hills Auto Bath is now a non-conforming sign since gasoline is not longer sold at that location. The Bldg. Insp. will inform the property owner of this violation.
- 4. Trailer illegally parked on the property of Dealer Publications has been removed.
- 5. A letter has been sent to Cinn. Blacktop concerning correction and completion of project at Amsterdam & Terrace. Also notifying that plans and specs for additional work will be changed before let out for bid.
- 6. Letter written to Mr. McDowell concerning construction of another condo unit in the Park Place complex.
- 7. City survey has been completed. Stakes have been laid out indicating boundary lines.
- 8. John Toebben violations Both trailers in violation have been removed. Contents of same have been left on the property, plus a door and a sink. Trash still has to be cleaned up. The Bldg. Insp. will again inspect the property for violations. Violations on Matth. Toebben property will be indicated by the Bldg. Insp. A temporary inside wall on property owned by John Toebben is to be checked by the Bldg. Insp.
- 9. Chief Ostendorf will contact the new owner of the Hoffman Motel concerning removal of damaged sign. The property will be inspected by Mr. Bieger.

OLD BUSINESS

1. Second reading of Ordinance No. 13, 1986 - Mr. Carey, City Attorney, informed Council a signed deed, containing property restrictions requested by Council. had been received.

Copy of a letter from the No. Ky. Area Planning Commission had been given to the Mayor, Attorney and all councilmen. This letter states such action of Council is illegal for the reason Mr. Kummer has not followed the rules and regulations of the Commission to permit the zoning change. Mr. Carey told Council the City will fulfill its responsibility by reading the ordinance twice and passing it, but the property may not be effectively rezoned. He further stated he has to assume Mr. Kummer, attorney for the Castleman estate, is aware of the above-mentioned letter from the No. Ky. Area Planning Comm., has researched it and is satisfied that if Ord. No. 13, 1986, has its second reading at tonight's Council meeting, sign it, and publish it, that he is clear, because that is the understanding between both parties, when the rezoning question was first brought before Council — the attorney has done everything necessary.

Following lengthy discussion, a motion was made by Mr. Kaelin and seconded by Mr. Osterhage that Mr. Carey, City Attorney, be directed to clear up all legal problems before Council take a vote on the second reading of Ord. 2. Home Businesses - The Police Department will supply a list of known home businesses to the City Clerk. This list will then be given to Council for study.

Mr. Sorrell, aye; Mr. Osterhage, aye; Mr. Kaelin, aye; Mr. Sommerkamp, aye; Mr. Sorg, aye; and the motion carried.
- 3. Mayor Fangman presented Resolution No. 2, 1987, "A RESOLUTION PROMOTING MICHAEL T. JANSING TO PATROLMAN, GRADE 2". A motion was made by Mr. Sorg and seconded by Mr. Sommerkamp that Res. No. 2, 1987, be accepted as read. Mr. Sorg, aye; Mr. Sommerkamp, aye; Mr. Kaelin, aye; Mr. Osterhage, aye; Mr. Sorrell, aye; and the motion carried.

Pledge of Allegiance

Roll Call

A motion was made by Mr. Osterhage and seconded by Mr. Sorg that minutes of the January 12, 1987, meeting be accepted with the following corrections: Page 2, Police Dept., paragraph 1 - December, 1986, inserted; Fire Dept., paragraph 1 - December, 1986, inserted. Mr. Osterhage, aye; Mr. Sorg, aye; Mr. Sommerkamp, aye; Mr. Kaelin, aye; Mr. Sorrell, aye; and the motion carried.

PETITIONS & DELEGATIONS

1. Mr. Michael Eastlake, representing Berlake Enterprises, appeared before Council to explain in detail the work being done and construction started on the former Jakeway property at 1018 Amsterdam Road. Site plans were submitted and pictures of the proposed dwelling were shown.

Mr. Bieger, BI/ZA, told Council drainage in the area has been improved by the contractor. Weakness of Amsterdam Road in that area and future repair of same was discussed.

- 2. Mr. Larry Pohlgeers, 1211 Hilltop, scheduled to appear before Council re parking violations, was absent. Chief Finke told Council the parking of cars makes it impossible to get a fire truck to the area; plus snow removal is very difficult.
- 3. Mr. John Kummer, attorney for the Castleman estate, appeared before Council concerning violation of Ky. statutes re procedures to be followed for hearings before the No. Ky. Area Planning Commission. He reviewed for Council the steps taken by his firm in requesting zone change for the property located at Dixie Highway and Arlington Road. Mr. Kummer requested assurance from Council that ordinance for zone change would be forthcoming if, once again, his firm went before the N.K.A.P.C. for such change, knowing the commission will not approve it.

Following discussion it was noted Council will have two options: Upon notification from Mr. Kummer, the City Council will (1) have a second reading of Ordinance No. 13, 1986, and passage of same; or (2) have a first and second reading of an ordinance, which would necessitate a special meeting be held for the second reading and passage of this ordinance prior to April 1, 1987.

COMMITTEE REPORTS

Public Works Department

- 1. Mayor Fangman informed Council that daily work sheets prepared by Mr. Budde are available for their study.
- 2. Two separate bids will be prepared for further work to be done on Amsterdam Road. (1) Curb work and related repaving, (2) resurfacing. The curb work will be done in the Fiscal Year 1986-87 and resurfacing during 1987-88 F.Y.

Drainage for Amsterdam and Terrace working very well; sidewalk repair to be done. The City Engineer suggested the sidewalk repair be included with specs and plans for curbing of Amsterdam.

3. Paul Michels Co. has been contacted to proceed with repair work to be done behind property at 1113 through 1123 Amsterdam Road. This area is flooded during heavy rain, which flows from Terrace, behind the buildings. There is no storm sewer available to take this water, which will have to be corrected.

- 4. Mr. Sorrell asked if Ray Budde was directed to clear the streets and gutters. Gutters were not specified and Mr. Sorrell indicated that several needed cleaning. Catch basins, sewers and drains are beginning to fill up again and must be cleaned of debris. Mr. Budde will be told of this. Rosemont, Mt. Allen and Arlington were mentioned.
- 5. Mr. Bieger suggested that three permanent monuments be set into the ground indicating boundary lines of City property. Survey of City property was done by a certified surveyor.

Police Department

- 1. A motion was made by Mr. Sorg and seconded by Mr. Sommerkamp that report of the Park Hills Police Dept. for the month of January, 1987, be accepted as submitted. Mr. Sorg, aye; Mr. Sommerkamp, aye; Mr. Kaelin, aye; Mr. Osterhage, aye; Mr. Sorrell, aye; and the motion carried.
- 2. Chief Ostendorf supplied a list of home businesses to the City Clerk. Businesses operated by Gene Connell were discussed. Mr. Connell had been sent an application for a Home Business license, but has not responded. The Clerk was directed to contact Mr. Connell, via certified mail, requesting his response. Applications and copy of the ordinance covering same will be sent to all parties listed as operating home businesses.
- 3. Mayor Fangman asked Chief Ostendorf to check into the possibility of changing directions on some of the City's streets to one-way. Cleveland and Jackson were two streets indicated. Passing is difficult in spots because traffic moves to the left to avoid overhanging trees on many of the streets. A study will be made as to the feasibility of such a project.
- Hills and Ft. Wright concerning purchase of a computer system. An application must be submitted by February 13th for a grant thru the NKADD with no cost to the City. Chief Ostendorf is not too hopeful. If the grant does not come through the department may look into purchasing one with their own funds. Programming of the computer is a problem not yet solved. It will be time consuming. Financial help from the City in purchasing this computer will be discussed at the Finance Committee meeting for the new Fiscal Year budget.
- 5. Chief Ostendorf suggested use of a special sticker for residents with a legitimate reason for overnight parking on City streets. Mr. Carey, City Attorney, suggested an ordinance be composed covering the special sticker. The Chief and Mr. Carey will meet concerning wording of the ordinance.
- 6. The Chief contacted Mr. Kenneth Wolfe, owner of 1522 Dixie Highway (Hoffman Motel) asking him to remove the damaged sign. The owner was not too cooperative. The property is still being run as previously noted on City records, but the new owner intends to put offices in the small buildings. The Building Inspector was directed to check into the zoning ordinance covering permissable signs.

Mr. Sensel was told by the Mayor that parking pads must be approved by Council and with neighbors' consent before construction. Mr. Sensel also informed Council his recreational vehicle is used as a second vehicle, which is used daily. He also received permission from neighbors. Following discussion, Mayor Fangman informed the owner that all aspects of the matter will be checked out and resolved, and he will contact Mr. Sensel by the end of the week.

Public Works Department

The Clerk was directed to have the engineer contact the Mayor concerning same.

It was noted Park Hills has an ordinance in effect at present concerning habitual barking by dogs. Police Chief Ostendorf informed Mr. Flick a written complaint must be submitted concerning the nuisance of barking dogs.

City Attorney Marcus Carey informed Mr. Flick he could file a complaint concerning the barking dogs at the In-take Office located in the Kenton County Courthouse building.

Mayor Fangman tried to contact Ms. Hoober, but has been unsuccessful.
 - 2. Additional complaints have been received on City sewers.
- 3. Councilman Kaelin asked if a time limit could be inserted on bids for curbing or paving projects. Mr. Bieger, City Engineer, replied it could be done, but a clause is normally added stating if the work is done ahead of time additional monies would be paid the contractor.
- 4. Mayor Fangman informed Council the price quote for extra curbing on Terrace and Altavia had been requested from the contractor. Prices have not been received as yet.

Police Department

- 1. A motion was made by Mr. Sorg and seconded by Mr. Osterhage that report of the Park Hills Police Dept. for the month of June, 1987, be received as submitted. Motion carried as follows: Yes--5; No--0.
- 2. Chief Ostendorf informed Council the department is short a fifth fulltime officer and have very few parttime personnel. One officer, Michael McGuffey, has finished training, and is doing an excellent job for the department, but he does have applications in several police departments for fulltime work. If the fifth fulltime is not replaced the department must get additional parttime officers to cover vacations, sick leave, schooling, etc. The Chief requested permission to hire additional parttime personnel. Mayor Fangman suggested the possibility of retired qualified police officers being available for parttime work on the department. The Chief will check further into this.
- 3. Chief Ostendorf informed Council he has completed the FBI Firearms Certification Course.
- 4. The Chief informed Council the department is preparing to contract with Mobilcomm for maintenance on Police Dept. radio equipment. The proposed contract is approximately \$900.00 annually.
- 5. The department received another complaint concerning the unkempt condition of the property located at 1068 Emerson Road. Two letters of complaint have been written by the Clerk's office. If the property is not cleaned up a letter will be written by the Mayor, indicating any further complaint received concerning uncut grass and weeds, City personnel will cut them and the property owner billed.

THE CITY COUNCIL OF THE CITY OF PARK HILLS MET IN REGULAR SESSION AT THE PARK HILLS CITY BUILDING ON MONDAY, OCTOBER 12, 1987, AT 8:00P.M., WITH MAYOR FANGMAN PRESIDING AND COUNCILMEN KAELIN, McKINLEY, OSTERHAGE, SOMMERKAMP, SORG AND SORRELL PRESENT.

Pledge of Allegiance

Roll Call

Before motion to approve the minutes of September 14th was made Mr. McKinley questioned the purchase of the copier without approval of Council. Mayor Fangman stated it was not an official approval, but all did agree to the purchase. All Councilmen were in agreement with the Mayor.

Councilman McKinley also questioned the City paying for glasses lost by a fireman while fighting a fire. Mayor Fangman questioned whether we carry insurance that would cover this expense. Chief Finke explained the policy has a \$500.00 deductible clause. The Chief stated taking the money from City funds was a mistake and he would be replacing the money with a check from the Fund Drive account.

A motion was then made by Mr. McKinley and seconded by Mr. Sorg that minutes of the September 14, 1987 meeting be accepted as received. Mr. McKinley, aye; Mr. Sog, aye; Mr. Sorrell, aye; Mr. Osterhage, aye; Mr. Kaelin, aye; Mr. Sommerkamp, aye; and the motion carried.

PETITIONS AND DELEGATIONS

- 1. Mayor Fangman stated he worked out Mr. Sullivan's problem with water on his property at 1050 Lawton Road, before Council meeting.
- 2. Councilan Osterhage questioned why there was no one in attendance concerning the sign violations. Mayor Fangman explained he wrote a letter to all businesses, informing them the Sign Committee will arrange to meet with Bob Coburn, Leo Stamm, John Popp and their attorney, Dave Snyder. If possibe, our Bldg.Insp./Zoning Admin., along with the City Attorney, will be at this meeting. The meeting will take place at 8:00 P.M. on October 26th in Council Chambers. Some signs perhaps can be grandfathered in, but others may not. The City Attorney will be looking into this, and study of the ordinance with the possibility of a change in same being necesary. It was decided the Sign Committee will meet on Saturday, October 24th, at 8:00 A.M., at Finn's Restaurant to prepare for the October 26th meeting.

COMMITTEE REPORTS

Public Works Department

- 1. Sullivan Property Solution could possibly be a roll bump to redirect the flow of water. Mayor Fangman is handling the problem.
- 2. Council was advised the Board of Adjustment held a hearing at the request of Leo Scalf for a five foot variance on Jackson Road. Dennis Finke mentioned in this same area there is a sewer leak, but it has not been determined where the leak is coming from.
- 3. Mr. Finke requested approval to award bid for striping to TruLine Striping Company. The bid was \$687.60, same as last year, and the company will do the work on a Sunday. All Council agreed to accept the bid, but to hold off with work until patching is completed.

- 4. Council discussed spot patching throughout the City. This will be completed by Paul Michels Co. and Dennis Finke of the P.W. Dept. Mr. McKinley asked if Dixie Hwy. resurfacing will extend into Park Hills. Mayor Fangman stated this was negative. The Mayor advised Council of the sinking pavement in front of Covington Catholic High School. The City will be looking into the cause and repair.
- 5. Mr. McKinley stated a stop sign was down at Amsterdam and Sleepy Hollow Roads. He asked if this was the City's rsponsibility. Mr. Finke stated it belonged to the County, but he took care of it because of the hazardous location and the possibility of accidents.
- 6. Officer Heidman brought up water leaking from a pipe alongside of the Circle K property. Mayor Fangman stated this was looked into before, but it was never determined where the water is coming from. The area was dye tested in the past with no results, but it will be checked into again.
- 7. Mr. Finke informed Council of the excessive dumping in the area of Mt. Allen Lane and Exter Drive. He questioned whether the City should clean up this area and post "NO DUMPING" signs. Mayor Fangman suggested he get with Mr. Carey, the City Atorney, and determine who it belongs to and if it is the City's property. If so, we will clean it up and post the signs. It was suggested this area may belong to the utility company. The Mayor said if they are not using it then it reverts back to the City. The attorney will be instructed to determine ownership of this area and the area behind Terrace Drive off of Amsterdam Road.

Police Department

- 1. A motion was made by Mr. Sorg and seconded by Mr. McKinley that report of the Park Hills Police Dept. for the month of September, 1987, be received as submitted. Discussion followed on pay for part-time patrolmen. It was noted if we raise the amount for other departments to help, then do we raise our part-time patrolmen's rate? After further discussion it was decided to hold off and discuss this when the Chief is in attendance. There was a question to accept the Police Department's report, but was noted the motion was only to receive the report, with discussion to be held when the Chief was in attendance. The motion was carried as follows: Aye--6; No--0.
- 2. Councilman Osterhage questioned Lt. Heideman on how cruisers are holding up. Lt. Heideman stated one is in for repair now, but they are in fairly good conditioned. It was questioned whether maintenance committee was set up yet for cruisers. Lt. Heideman stated Chief Ostendorf was supposed to meet with Spec. Hellmann on this matter, but he wasn't sure if this did take place. It was decided to also discuss this with the Chief. At this point Lt. Heideman left the meeting since he was the only officer on patrol and there were no further questions.

Fire Department

- 1. A motion was made by Mr. Sorrell and seconded by Mr. Osterhage that report of the Park Hills Vol. Fire Dept. for the month of September, 1987, be received as submitted. The motion was carried as follows: Aye--6; No--0.
- 2. Chief Finke informed Couoncil he called the State Fire Marshall re Covington Catholic H.S. He has talked to school authorities on previous occasions with no results. This involved parking in the rear of the school,

blocking fire hydrants, and the area being non-accessible to fire trucks. This is created mainly by Booster members parking in this area. The Fire Marshall and the Chief met with school officials to discuss the problem areas. The school is now working with Chief Finke to correct these problem areas. "NO PARKING" signs have been purchased and Chief Finke will instruct officials re placement of same. Council was informed Covington Catholic H.S. does not evacuate when a bomb threat is received. The Chief granted the school a burning permit for Friday night. Firemen will be on hand if assistance is needed.

Councilman McKinley stated the possibility of Covington blocking off Audubon Road at the tennis courts and building a road down the hill onto Park Road to divert traffic. Council would have no problem with that being done.

Rescue Squad

- 1.A motion was made by Mr. Osterhage and seconded by Mr. Sommerkamp that reports of the P.H. Rescue Squad for the months of August and September be received as submitted. Motion carried as follows: Aye--6; No--0.
- 2. Chief Dreyer participated as a member of the Governor's Commission to study future emergency services in Kentucky. He was also appointed to Kenton County Emergency Response Committee, which is studying action needed in handling hazardous material incidents in our area. The Chief will also be attending a seminar in Louisville on the 18th of October regarding earthquakes. Council requested they be kept abreast of the results of these meetings.
- 3. Mr. Osterhage questioned the physical plant of the Resuce Squad. Discussion followed concerning inspection of electrical wiring and location of the panel board in this area.

Finance Department

- 1. A motion was made by Mr. Osterhage and seconded by Mr. McKinley that reports of the Finance Dept. for the month of September be received as submitted. Mr. Osterhage, aye; Mr. Sommerkamp, aye; Mr. Sorg, aye; Mr. Sorrell, aye; Mr. Kaelin, aye; Mr. McKinley, aye; and the motion carried.
- 2. Mr. Sommerkamp inquired about the list of bills not being included this month. This was explained because of the Clerk being on vacation. Mr. Sommerkamp also questioned the Police Dept's budget for part-time help, the amount budgeted and the amount used at this point. Again salary for part-time help was discussed, with a decision to wait until the Chief is at the meeting for further decision.

Personnel Policy

1. Mayor Fangman stated the committee has not had another meetig so nothing to report at this time.

City Attorney Carey arrived at the Council meeting at 9:20 P.M.

Sidewalk Committee Report

1. Mr. Sorrell stated he and Mr. Sommerkamp have walked Rose Circle, Audubon, Terrace Dr. and Park Road. Specific problem areas were brought up at 902 and 904 Terrace and also in the area of St. James Avenue. It was decided these areas were in bad enough shae to have the Clerk send letters immediately. Mr. Sorrell will notify the Clerk of the specific addresses when she returns. The City Attorney also suggested copy of the ordinance with these letters.

Insurance Committee

1. Council requested this committee be eliminated from the agenda.

Vicious Animal Report

l. Mr. Osterhage stated he has read the material, but does not have a report to submit at this time. The Clerk is to contact the City of Bellevue for their Vicious Animal Ordinance. Covington also has one. Mr. Sorrell will be responsible for obtaining copies for Council.

BUILDING AND ZONING

- 1. Mr. Bieger was not in attendance.
- 2. Mr. Sorg asked about the problem at Hillcrest and Amsterdam. Mayor Fangman replied the drains are in place with channel to pipe.
- 3. Mr. Kaelin questioned whether a building permit was issued for 1154 Breckenridge. Discussion followed concerning construction, etc. being done within the City with no permit issued. He questioned the City Attorney on the legality of the police stopping them. Mr. Carey replied the police can issue a citation for violation of a City ordinance if they do not have a permit. Mr. Kaelin asked who has the authority to have them take down a job if it does not comply with City laws, the police or the Bldg. Inspector. Mr. Carey stated the Bldg. Inspector, but the police can still cite them for not having a permit. If this done and it is taken to court there will be times when the Clerk and Bldg. Insp. would have to appear concerning this citation. After lengthy discussion it was decided the Mayor will talk to the Police Chief on the issuance of citations for violations.
- 4. Mr. Sorrell stated all violations mentioned last month for Toebben have been removed.

OLD BUSINESS

- 1. Mr. Kaelin requested discussion on the amended auto sticker ordinance be held for the November Council meeting. All agreed.
- 2. Mayor Fangman asked Chief Dreyer if the property at 1116 Amsterdam Rd. has been appraised. Chief Dreyer stated not yet.

At this point it ownership of property in the rear of Terrace Dr., with entrance off Amsterdam Rd., was discussed. Also Mt. Allen Lane to Exter Dr. Mr. Carey will contact Mr. Finke of the P.W. Dept. for a determination of ownership.

3. Mayor Fangman informed Council of the problem with repair or replacement of the boiler. It was suggested the gas valve and safety pilot be replaced for \$650.00, and next year modify other parts of the piping system to create zone areas. The new windows have helped with heat conservation. It was noted if a new boiler is installed it will have to be placed outside, with a fire wall and other safety precautions. All felt replacing the gas valve and safety pilot was the best route to go for now.

NEW BUSINESS

A motion was made by Mr. McKinley and seconded by Mr. Sommerkamp that Res. No. 7, 1987, be accepted as read. Motion carried as follows: Aye--6, No--0.
- 2. Mayor Fangman presented Resolution No. 8, 1987, directing the Clerk to advertise for bids for the collection of trash in the City of Park Hills. A motion was made by Mr. McKinley and seconded by Mr. Sorrell that Res. No. 8, 1987, be accepted as read. Motion carried as follows: Aye--6, No--0.

It was questioned if the specifications should be attached to the Resolution. Mr. Carey stated it was not necessary to attach them to the Resolution, but they will be attached to the actual bid. Mr. Osterhage asked if starting time for pickup will still be 7:00 A.M. This was confirmed by the Mayor. Mr. McKinley questioned increasing the budget for garbage collection, but it was determined this is done six months after the contract is in effect.

4. Halloween Trick or Treat hours will be from 6:00 P.M. to 8:00 P.M., Saturday, October 31, 1987. Open House at the Fire Dept. will be the same date, from 7:00 P.M. to 9:00 P.M. Motion to this effect was made by Mr. Kaelin, seconded by Mr. Sommerkamp. Motion carried as follows: Aye--6; No--0. Mr. McKinley stated Ft. Mitchell celebrates the last Sunday in October, during daylight hours. He would like to see this done statewide. Council felt this should be considered next year.

COMMUNICATIONS

- l. Mayor Fangman read parts of a letter from Mayor Bill Goetz concerning the Kenton County & Municipal Planning & Zoning Commission. The Mayor will see that all of Council get a copy of the letter. The Commission, at present, is back to evening hours.
- 2. A letter of complaint from Mrs. Able was mentioned. Chief Ostendorf wrote a letter of response which Mayor Fangman feels takes of the situation.
 - 3. From Ron Turner thanking the Police Dept. for their help during Riverfest.
- 4. Request for reservations for the No. Ky. Area Development District annual dinner meeting to be held at the Oldenburg Brewery. Three couples will be in attendance. Since this is a regular City function, the City will pay for registration and dinner.

Council discussed appointing someone to take Joe Niehaus' position on the KC&MP&ZC. No decision was made at this time. It was noted that a member of Council cannot serve in this capacity.

Public Works Department

- 3. Paul Michels Co. has been contacted for repair work on the sewer located on Rose Circle near Jackson Road.

Police Department

Of special interest to employees may be the "Deferred Compensation Plan", which is available to all eligible employees. Representative of the Retirement System is available for a meeting with all interested parties on the deferred compensation plan, etc. The Chief will attempt to set a meeting date for same.

Fire Department

- 2. Vicious Animal Study Committee

l. Mr. Osterhage informed Council the committee had met and finalized a rough draft of an ordinance on "Vicious Animals". He gave Council a synopsis of this ordinance, which took into account all information received from several agencies and surrounding city ordinances.

BUILDING AND ZONING MATTERS

- 1. One permit issued during the month of October.
- 2. The Building Inspector was informed that a wall has been erected by the owner of 1154 Breckenridge, partially on Cikty right-of-way, which is in violation of City ordinance. A permit to erect such wall was not obtained. Mr. Bieger was directed to write the property owner, informing him of such violation. Discussion followed during which the City Attorney stated the Bldg. Insp. has the authority to stop any work being done without a permit. Mr. Carey also told Council the

Mr. Osterhage requested any further suggestions be given to the Committee for inclusion in the ordinance before the next Council meeting. Mayor Fangman thanked the Committee for all the work involved in this project.

BUILDING & ZONING MATTERS

- 1. No permits issued during the month of November.
- 2. Dixie Hwy. signs Mayor Fangman informed Mr. Bieger, BI/ZA, that he had been contacted by Mr. Richard Nelson, Attorney, as to whether or not JMDR, owners of the property at 1518 Dixie Hwy., are responsible for the signs or will it be each individual business owner located in the complex. Mr. Bieger replied he did not know any details of the lease arrangements. This will be checked into further. All letters received by the BI/ZA were tabled until a decision was made by the Sign Committee. Very few permits for sign erection were located in the Clerk's files.

The sign pole located in the business complex at 1518 Dixie Hwy. was also discussed. All questions and problems will be handled through the sign committee.

- 3. Corners of the City Building have been laid out one time, but not a second.
- 4. Mr. Bieger will be doing some research on location of the stone wall which had been erected at 1154 Breckenridge. It is in violation since no permit was applied for. Before a letter is written study of City right-of-way will be made.
- 5. Mr. Burton, No. Ky. Voc. School, contacted the Clerk to inform her that permission had been given to the state for erection of the sign on City right-of-way

located near entrance to the school. An electrical outlet had been installed at that time. This information will be checked out.

6. Debris, trash, etc. is once again littering the Hamilton Road hillside. The City Clerk was directed to send letters to all residents on Hamilton Road that such dumping must be stopped.

OLD BUSINESS

- 1. Presentation of proposed amended auto sticker ordinance A copy of this proposed ordinance given to each Councilman. The reciprocity clause in this ordinance was discussed in detail, plus information concerning change of delinquent date. Action on this ordinance tabled until the January meeting.
- 2. 1116 Amsterdam Road Mark Dreyer informed Council that title to property at 1116 Amsterdam is now in his name. Estate will be settled. Mr. Dreyer has several options he can follow. Decision on this property will be sometime in May.
- 3. Terrace Dr. alley/Mt. Allen Lane extension Titles on all properties in these area researched by Mr. Carey, City Attorney. He explained in detail all his findings. The Mt. Allen Lane extension is a 30-foot passway; everyone who lives along it owns from the center in, but the passway itself is dedicated for public use. No official acceptance by the City of Park Hills, agreeing to maintain it, is on file at the Courthouse. Since it is a public passway the property owners are not obligated to keep it clear of weeds, grass, etc. The passway has been in existance for a long enough period that any property owner, along the passway, who has maintained it, could propably petition to have it deeded to them.

Terrace Drive alley is a 15-foot alley. The people along this alley do not own to the mddle of it. This alley is dedicated to public use. The people along the alley who have used it for 3 years that is inconsistant with public use, can, within 15 years time, claim it for themselvs. It is not in the name of the City of Park Hills.

Following discussion Mayor Fangman directed the City Attorney contact all property owners along these passways, advising them the property is not owned by the City of Park Hills; it was dedicated for public use at a point in time when the City did not accept it. We do not claim it. They should either take action or contact the City and assistance will be given in closing the passway and deeding the property in some fashion to each of them.

4. Non-partisan elections - Mr. Carey informed Council he researched the emergency ordinance for non-partisan election for validity and checked into the write-in votes received at the last Nov. election. He was told the names were indecipherable and would have no impact on the election. Mr. Carey did suggest that once the new Council is in place the non-partisan election ordinance should go through a second reading and published.

Discussion then followed concerning two vacant Council seats for the 88-89 term. Notification will be published advising all residents of such vacancy. Mr. Carey advised Council three Councilmen would constitute a quorum if only four were elected. With Mr. McKinley's absence, due to hospitalization, the three Councilmen would appoint the fifth; he would be sworn in; the four would then appoint the sixth Councilman, thereby filling all six Council seats.

Following discussion a motion was made by Mr. Kaelin and seconded by Mr. Sorrell to suspend the action of Municipal Order No. 1, 1987, due to the emergency that exists because of two vacancies occurring at the regular term of office. Mr. Kaelin, aye; Mr. Sorrell, aye; Mr. Osterhage, abstain; Mr. McKinley, aye; Mr. Sommerkamp, aye; Mr. Sorg, aye; and the motion carried.

Mayor Fangman will see that notice of vacancy and requirements are published.

Research on term of office for the two appointees will be done by the City Attorney. Information concerning filing, etc. will be given to the candidates.

3. A temporary carport can be erected for use of the Fire Dept. pickup truck. During discussion covering for the snow plowwas requested by Mr. Finke of the Public Works Dept.

NEW BUSINESS

- 1. Councilman McKinley suggested date of championship win by Pandas and Colonels should be included on signs acknowledging same.
- 2. Mayor Fangman presented Proclamation commending championship win and scholastic achievements of Covington Catholic H.S.
- 3. The Mayor presented Proclamation commending championship win and scholastic acievements of Notre Dame Academy.
- 4. Sewer Proposal Task Force Mr. Kaelin advised Council he received information on the sewer proposal indicating once the legislation is passed, joining by cities will be mandatory. It was noted many cities are against the two county-wide sewer maintenance and replacement. Following discussion Mayor Fangman suggested a representative of the Task Force be invited to Council meeting for presentation of the proposal.
