APPROVAL OF MINUTES: Motion for approval of the December 10, 2007 minutes made by Mr. Brunner; second by Mr. Ryan and motion carried.

#### I. Petitioners

Mr. John Walker, of Van Gorder, Walker & Co., Inc., was present at the meeting to go over the city's audit for the fiscal year 2006-2007. Mr. Walker went over key points of the audit stating the city received a high level of assurance and that the government's accounting standards were fairly presented. Mr. Walker thanked Mayor and Council for the opportunity to once again audit the city's finances. Once the audit is approved, final drafts will be issued.

Many residents of St. Joseph Lane were present at the meeting. Most of the residents were against an ordinance that would ban on street parking from St. Joseph Lane. A petition was presented to Council with about 40 signatures opposing such a ban. Mayor Hellmann stated he expected residents to show up at the meeting on January 28<sup>th</sup>, but residents did not receive notice in time. Mayor Hellmann would like to discuss the issue further with Council before making any decision on the parking issue. Residents will be invited back at a later meeting to hear other alternatives and voice their opinions.

- II. Second Reading; Ordinance No. 13, 2007 permanently changing the speed limit on Montague Road to 15 mph was read by Attorney Robert Winter. Wording in Ordinance to be changed from "eastbound" lane to "downhill" lane. Motion to adopt Ordinance with change was made by Mr. Brunner; second by Mr. Ryan and motion carried.
- III. Second Reading; Ordinance No. 14, 2007 amending Code Enforcement Board Ordinance No. 5, 2005 was read in summary by Attorney Robert Winter. Motion to adopt Ordinance was made by Mr. Ryan; second by Mr. Brunner and motion carried.

# IV. Department Reports

A. Police Department – Motion for approval of December report made by Mr. Ryan; second by Mr. Worland and motion carried. Mr. Brunner asked the difference

between an active and an inactive domestic dispute. Chief Smith stated an active is when both parties are still at the scene; inactive is when one or more party(s) has left the scene. Chief Smith also stated he would need to check the police report to answer Mr. Brunner's question as to what the two drug charges were related to.

- B. Fire Department Motion for approval of December report made by Mr. Ryan; second by Mr. Brunner and motion carried. No report
- C. Public Works Motion for approval of December report made by Mr. Ryan; second by Mr. Brunner and motion carried. Mr. Ryan asked Mr. Finke where the sanitation problem stands on Terrace Drive. The pipe on the north side of Terrace Drive needs to be replaced. Mr. Finke stated there were several options being looked at which could affect curbs, gutters, sidewalks and trees. He will have more information later.
- D. City Engineer Motion for approval of December report made by Mr. Ryan; second by Mr. Brunner and motion carried. Question came up to remove stop sign at the intersection of Hamilton and Short Arlington. Mayor Hellmann stated he would like the sign to remain for the time being to give people time to get used to the change. Mr. Finke also stated a yellow line painted down the middle of Hamilton (opposite the cul-de-sac) may help. Mr. Ryan would like some type of "no outlet" sign placed at the entrance of the Hamilton Road cul-de-sac.

Mayor Hellmann asked if NDA has sent out notices to residents of St. Joseph Lane yet regarding the construction set to begin in the spring. Mr. Bayer is not aware of any public meeting or notices; he suggests residents contact Sr. Bankemper directly with any questions or concerns they may have.

Mr. Bayer stated Mt. Allen Road, St. Joseph Lane and Hamilton Road are all substantially complete. The surface work and driveways on Mt. Allen will be completed in the spring.

Mr. Ryan stated once the Sanitation District approves plans, work on Audubon Road will be ready to begin.

The city received a check from Sanitation District for 50% of the storm sewer costs from the Lawton Road project.

Mr. Bayer stated the sisters of Notre Dame Academy do not want to begin construction while school is still in session. Mayor Hellmann explained that the city needs to get the project out to bid by March so that the grant money can be expensed by the end of fiscal year.

Mr. Bayer recommended the city pay JPS Construction \$371,980.84 for the work done on Mt. Allen Road (1<sup>st</sup> pay request); Michel's Construction Co. \$65,201.40 for Hamilton Road work (1<sup>st</sup> pay request). Motion to pay made by Mr. Ryan; second by Mr. Kleymeyer. Roll Call: All ayes

Mr. Bayer recommended the city pay Michel's Construction Co. \$98,835.30 (1<sup>st</sup> pay request) and \$116,292.15 (2<sup>nd</sup> pay request) for work done on St. Joseph Lane. Mr. Ryan

made a motion to table these payments until additional review is done; second by Mr. Brunner and motion carried.

The Supreme Court ruled in favor of cities for storm water fees. Mr. Winter does not believe the issue will go any further.

Mr. Brunner commented on the letter written by Mrs. Wermeling's letter regarding the Fire Department's fund drive. Mayor Hellmann stated he would speak with Mrs. Wermeling himself.

Mayor Hellmann will have Attorney Robert Winter look into whether a person is able to park in front of their own driveway and if stop signs are able to be used as speed control devices.

#### I. Petitioners

Mayor Hellmann received new bids for the demolition of several buildings owned by the city:

1006 Amsterdam Road - \$10,500; total of \$20,000 vs. first bid of \$32,000;

937 Montague Road - \$14,500 vs. first bid of \$16,000.

Mr. Brunner feels the city may be able to get lower bids if the demolition is delayed. Mayor Hellmann stated that would be fine for the Amsterdam buildings but he would like to have the Montague building demolished as soon as possible due to safety issues.

#### V. Mayor's Group Report

Mayor Hellmann stated Alecia Webb-Edgington was at the meeting. Mayor Hellmann believes she will do a good job as representative for our city.

Mayor Hellmann would like Council to give thought on the direction they would like to see lower Amsterdam take.

# VI. Mayor's Update

- A. Budget requests are due on February 11<sup>th</sup>; this includes budget requests for all boards; Civic Association, Village Green, etc.
- B. The bill to give 4<sup>th</sup> class cities the same power as other cities to enforce nuisance violations has passed in the House 96-0. It will now go before Senate. There is also a push to change the way cities are classified. Right now, cities are classified by population, not by population based on square miles. Mayor Hellmann stated, if needed, he would represent 4<sup>th</sup> class cities in a move to change the way cities are classified.
- C. A meeting will take place at the TBNK on Wednesday, February 13<sup>th</sup> from 4-6 p.m. The purpose of the meeting is for representatives from our city to voice their opinions on what they would like to see cable provide.

Mr. Worland suggested representatives from the boards/committees/delegations for the city attend Council meetings monthly to give a report on their activities. Mr. Worland and Mr. Brunner are both in favor of this so that Council can be kept abreast on what the

committees are doing in the city and keep lines of communication open. A letter will be sent to each Committee/Board requesting they attend future meetings of Council.

Mayor Hellmann has been in contact with Mr. Dennis Gordon of the NKAPC regarding the zoning of Dixie Highway. Mayor Hellmann would like to have the NKAPC do a study. This could help create guidelines and give the best look to Dixie Highway. Mayor Hellmann will have Mr. Gordon give a proposal for the study. The Mayor plans to meet with Mr. Gordon for about 45 minutes to an hour if anyone from Council is interested in attending. He will relay the date and time to Council once it is set.

Mayor Hellmann read Officer Karen Spanyer's resignation letter to Council. Ms. Spanyer is returning to her position with the Taylor Mill Police Department effective February 2<sup>nd</sup>. Karen was a valuable employee on the force and will be missed. Mayor Hellmann would like to schedule an exit interview with Officer Spanyer and invited anyone interested from Council to attend.

Chief Smith stated he has several applications on file, but would like to advertise the position in the paper.

Mayor Hellmann stated that Notre Dame Academy will most likely ask the City of Park Hills to finalize the bond issue. The school has raised much money but may need additional funds in the amount of about 4 million dollars. Notre Dame would like the fire chief to meet with them to discuss the possibility of moving some fire hydrants during the project. Mr. Finke is concerned about the runoff of water from St. Joseph Heights. Mayor Hellmann believes the hillside will be re-worked to separate the flow of water.

#### **CAUCUS MEETING:**

CALL TO ORDER

#### I. Petitioners

Though Mr. Craig Worstell was not present at the meeting, he met with Mayor Hellmann prior to the meeting and stated he would like to see a crosswalk put on Amsterdam Road by Trolley Park. Mayor Hellmann asked Council to consider and will speak with Mr. Finke about it.

II. Residents from St. Joseph Lane were in attendance to share their concerns regarding the possibility of eliminating on street parking. Mr. Mark LaPenna, 519 St. Joseph Lane, was the only resident in attendance that was in favor of the parking elimination. Mr. LaPenna cited safety concerns due to increased traffic from cars and pedestrians as his reason for wanting the no parking. Mr. LaPenna recommended a traffic study be conducted for 30 days on a 24 hour basis. He also encouraged residents to continue using their driveways instead of parking on the street. Mr. LaPenna feels having cars parked on the street hampers the response of emergency vehicles when parked cars have to be maneuvered around. Other ways to eliminate safety problems suggested by Mr. LaPenna, would be to have residents widen their driveways or perhaps divert traffic from Elberta Circle by creating a "dead end" and have vehicles use South Arlington Road instead or St. Joseph Lane. Mayor Hellmann explained Elberta Circle, as well as the other streets that house the apartments, are private drives where the city has no power in making changes. Mr. Ryan also explained to residents that there are no plans to widen St. Joseph Lane in the immediate future. Mr. Ryan relayed to residents that he has traveled the street many times since the parking issue was first mentioned. He states the only area he has concerns with is the "crest" near the mid-way point of the street. This creates a blind spot of oncoming cars.

Most of the residents did not want any changes made to the parking regulations on the street. Most claim they do not believe there is a safety issue and say; on the contrary, eliminating the on street parking would result in more speeding. Others tell Council that widening their driveways is not an option due to money and space. After much discussion, Council agreed to leave the parking as is for now. The only change would be to move the "No Parking" sign near the Animal Hospital further up the street to create a better flow of traffic at the bottom of the street near the traffic light. Mr. Brunner stated he would be interested in observing the "crest" area of the street to see if he, or any one on his committee, believes that having cars parked there creates a safety hazard. The committee will report their findings back to Council.

Millie Fangman was present at the meeting on behalf of the Garden Club and Hospitality Committee to ask Council's permission to close off a portion of Park Road on October 4, 2008 from 9:00 am to 5:00 pm for an art show. Mrs. Fangman stated they would like to set up booths around the "island" portion of Park Drive. She went on to say the committee would put up directional signs to guide traffic around the closed street. Chief Smith stated it would be doable as long as there is a route for emergency vehicles. Mayor Hellmann asked Council to think about it and we would let Mrs. Fangman know of their decision.

## III. Committee Discussions

# A. Community Environmental Committee

Mr. Worland stated that certain portions of the City of Park Hills are now officially on the National Registry of Historic places. Mr. Worland would like to schedule a seminar, perhaps at Covington Catholic High School, to discuss tax credits and how to go about obtaining them. Mr. Worland handed out information to Council which also contained contact names and numbers.

#### B. Public Safety/Personnel Committee

Mr. Brunner wishes to observe the crest on St. Joseph Lane to see if there is a problem with visibility which could pose a safety hazard.

#### C. Infrastructure Committee

Mr. Ryan stated that due to the wet weather, there has not been much activity on the road projects. Mr. Ryan stated he would look into a crosswalk on Amsterdam Road discussed at the start of the meeting. Mr. Ryan went on to say the Dixie Highway Sidewalk encroachment permit was received and will be ready to send out to bid next month.

#### IV. Old Business

Mr. Ryan stated he will be meeting with the Bornsheins' tomorrow regarding the Morgan Court road project. Mr. Ryan will schedule a meeting with residents regarding the project and email Council with the date.

#### V. New Business

- A. Mayor Hellmann relayed NDA's plans to put in a wildflower garden in the large area in front of the Heights. He said the landscaper stated it would take about three years for the garden to grow in and look nice. Mr. Brunner stated he would like for the landscaper to come to a Council Meeting to discuss how the garden will look and the timeline for it. Chief Smith wants to make sure it will not be a "hiding" place for criminals or create a haven for wildlife.
- B. Mayor Hellmann discussed the property rate to Council and how he would like to increase the rate so that the city can collect the extra 4% allowed. Briefly discussed the tangible and franchise taxes with Council.
- C. Discussion regarding hillside development took place. The Mayor's Group has been discussing the idea of creating a tax which would be used to purchase hillsides to prevent them from being further developed. Mayor Hellmann did not have a lot of information at this time for Council.
- D. Mayor Hellmann would like all codes and regulations upheld in rental units whenever an occupational license is obtained. He went on to ask Council to consider an ordinance similar to one that Covington has requiring all rental units to have a permanent heat source for their tenants.

Mayor Hellmann is having Park Hills host the July Mayor's Group Meeting at the Garden's of Park Hills. Mayor Hellmann will be out of town that day and asked Council to please consider attending the meeting.

# VII. Mayor's Update

- A. Mayor Hellmann, along with Mr. Finke and Bayer Becker will meet Friday at 4:00 to discuss the property the city owns at 1004-1006 Amsterdam Road. Thelen will also be there to advise on what would happen if the property is demolished and give cost.
- B. A storm line on Amsterdam Road across from the Wood's Apartments is disintegrate and needs to be repaired. Per Michel's Construction, the cost should be under \$10,000.
- C. HB 119 regarding the Code Enforcement Board is currently at a stand still. HB 524 regarding Municipal Insurance Taxes has passed the House.

Michael Box and Richard Abel were present at the meeting to discuss erosion control and water runoff from the property at 1035 Montague Road. Mr. Box and Mr. Abel claim the water is running into their yards and basements. They laid sandbags and trenches but state it is not helping to alleviate the problem. Mr. Abel believes the new owner put in sewers incorrectly with the manhole covers too high. They would like to see the hillside fixed and the sewer put in correctly. Mr. Donald Blank and Ms. Regina Forster, both of Audubon Road were present at the meeting to discuss the retaining wall erected on the property behind them. The petitioners state during heavy rain, water runs off the property and onto theirs causing erosion and water damage. The wall was approved by the NKAPC. Mr. Bayer had an engineer who specializes in retaining walls look at this particular structure. The engineer felt the wall was properly designed. There is nothing in the codes that requires a single family resident to have drainage retention. Ms. Forster stated holes were beginning to develop in her back yard which she feels is also from the water runoff. Mayor Hellmann stated regulations were not put in place in the past because a retaining wall of this size would not have been foreseen in the city. Mayor Hellmann would like to add regulations for future retaining walls. Mr. Bayer stated he could look at the property and see if he can come up with some "suggestions" to give to the owner of the wall on how to redirect the water flow. Mayor Hellmann stated he had no problem sending the owner a letter containing the suggestions. Mr. Blank and Ms. Forster stated Mr. Bayer could have access to their property.

Mr. Joe Geiger and Ms. Helen Heil were present at the meeting to give Mayor and Council an update on the Park Hills' Civic Association. Mr. Geiger stated the Dicken's Christmas resulted in a slight money loss last year due to the weather. He states the Association has somewhere between \$10,000 and \$11,000 in funds. He went on to say the number of volunteers has decreased over the years and they are always in need of people to help out. This year, the children's Christmas party will be open to all residents not just those that are members. About 100 to 150 children showed up for this years' Easter egg hunt in Trolley Park. This year, if a chairperson is not found for Dicken's Christmas, it may not take place. This years' golf outing is also questionable. The Memorial Day Parade planning is going according to schedule. Ms. Heil stated the Association is looking to have new playground equipment installed in Trolley Park. The existing equipment is worn and in need of replacement. ## ENFORCEMENT OF STORM WATER PROGRAMS

- > Enforcement of the storm water programs for municipal and industrial storm water discharges is currently one of EPA's four national enforcement priorities under the Clean Water Act. The other three are CSOs, SSOs, and Concentrated Animal Feeding Operations. See October 12, 2007 Federal Register.

## ENFORCEMENT OF STORM WATER PROGRAMS - MS4s

On August 14, 2003, EPA published its storm-water compliance and enforcement strategy. It includes its storm water enforcement strategy for Phase II regulations (i.e., SMS4s).

## ENFORCEMENT OF STORM WATER PROGRAMS – MS4s

- Fiscal year 2008 -- Regions should begin assessing compliance with Phase II permits (e.g., conducting inspections, reviewing MS4 annual reports, DMRs, SWPPs, other permit requirements) in order to identify and take action against small MS4s and small construction sites that are not complying with permit requirements.
- Enforcement is very much underway for Phase I MS4s.

## ENFORCEMENT OF STORM WATER PROGRAMS – MS4s

- > Large/Medium MS4 Initiative.
  - November 20, 2006 complaint filed by EPA/KYEPPC, against the Lexington-Fayette Urban County Government ("LFUCG") in the United States District Court for the Eastem District of Kentucky.
  - Complaint alleges failure to comply with KPDES permit for the MS4, and failure to adequately implement SWMPs to reduce pollutants from the MS4 to the maximum extent practicable.
  - Consent Decree signed by LFUCG (February 2008).



### LFUCG CONSENT DECREE

- > \$425,000 Civil Penalty.
- > Multi-Million Dollar SEPs.
- > Storm Water Management Fee to Fund Program.
- > Specific Areas for Upgrades to Ordinances.
- SWQMP Attached to Consent Decree and Developed as Part of Negotiations.

## LFUCG CONSENT DECREE (Cont'd)

- Examples of SWQMP Provisions Included as "Performance Standards"
  - · Map/inventory of MS4
  - Monthly inspections of 90% of active construction sites.
  - Program to maintain public and private control structures.
  - SWPPPs for significant industrial and high-risk commercial sites.
  - · Strengthened enforcement provisions.
  - Urban/Rural area distinctions.

## ENFORCEMENT OF STORM WATER PROGRAMS – MS4s

- Implications of MS4 "Enforcement Initiative"
  - Increased municipal inspection scrutiny of and controls imposed on construction, industrial, and commercial development.
  - Increased community costs to fund MS4 Storm Water Management Programs.
  - · Improved water quality.

### MS4 PROGRAM COSTS

- EPA recently estimated storm water management costs over the next 20 years will cost approximately \$9 billion.
- In promulgating its MS4 regulations, EPA estimated that the per household costs for small communities would range from less than \$1 to approximately \$50 on an annual basis.
- A typical average monthly household storm water management fee for medium to large Municipalities in the United States, however, appears to be in the range of \$2 to \$6 (\$24 to \$72 annually), and such fees are sometimes much higher and/or supplemented with other funding sources.

### CONCLUSIONS

- Storm Water Programs are supposed to be fully developed at this point in time for all MS4s
- MS4 Controls ("MEP") are dynamic; they will be refined over time to become more effective.
- Additional Controls / Programs / Limits may be on the horizon for MS4s and industrial dischargers of storm water to move further toward compliance with water quality standards.
- Enforcement is accelerating, and EPA is forcing Municipalities to play a lead role in that enforcement within their jurisdictions.

Mr. Finke, Bayer Becker, Mayor Hellmann, Mr. Ryan along with the Sanitation District met regarding the Rosemont/Hilltop/Short Cecelia project. The project is expanding in order to include the repaving of South Arlington. The Sanitation District will take care of the pipe work and the city will share in the cost of the storm sewer work.

Mayor Hellmann will meet tomorrow at 3:00 pm with the owner of the property at the corner of Hamilton and Arlington Roads to discuss the upcoming Arlington to Amsterdam Road Connection project.

The contractor who did the Mt. Allen work will credit the city for the trench work they did on South Arlington. The city was not happy with the outcome of the trench and will apply the credit to another project.

#### I. Petitioners

B. Mr. Keith Logston, along with Dennis Gordon and Jenna Haverkos of the NKAPC, were present at the meeting to discuss a small area study (SAS) for the City of Park Hills.

Mr. Gordon began by explaining the reason for the SAS for cities:

- Pursue the update of a comprehensive plan; which is the basis that the Planning Commission must use when giving recommendations. This is updated every 5 years.
- Work with communities on being more proactive with issues that cities are facing.
- Maximize opportunities by planning for things to happen and then to make them happen.

It was determined that the SAS was the best way to accomplish to do what cities need and to put together a new comprehensive plan for each city. The study focuses on one area and makes recommendations for that area.

The NKAPC is working with 4 areas so far doing an SAS; they include:

Ft. Wright, Fiscal Court (area south and west of Independence), Dixie Fix and a plan for downtown Independence.

A study was also just completed for the St. Elizabeth facility and its surrounding area of 12<sup>th</sup> Street in Covington.

The staff and cities work together and use a task force of local citizens. Plans are based on market studies and the final product presented is not where the efforts of the NKAPC end. Mr. Gordon stated that they go on to see how the plan will be implemented into the city and that it is important to get citizens involved.

Mr. Logston went on to say he believes Park Hills has very "doable" projects along Dixie Highway. He stated the importance of the SAS is that:

- Every study becomes part of a comprehensive plan.
- Looking at smaller areas gives better plans for cities.
- There is good citizen input and public involvement
- Includes market study (additional cost) that he believes is important.

Mr. Logston stated Ft. Wright is looking to do an SAS on their portion of Dixie Highway and that perhaps Park Hills could look into sharing the cost of the study. This could save the city about ½ the cost of the market study.

Ms. Haverkos stated the overall project is about ten months.

The city could create a task force which is made up of eight to ten members appointed by Council which could include Mr. Phil Ryan, several residents and business owners, any neighborhood associations and perhaps school officials.

The NKAPC would have key person interviews with the SD1, police and fire departments, Council members, school boards, TANK and the Water District. Usually there are three public hearings held:

- Initial report
- Interim report
- Final report (includes visions and roles, land use to collaborate with the Dixie Fix, and parks and recreation)

The final report would give a twenty year documentation showing the short, mid and long term recommendations of the study.

Mayor Hellmann stated he would like to talk with Ft. Wright regarding the possible shared cost of a market study and will get back to NKAPC as soon as possible.

Mr. Finke showed Council the post covers he intends to use on the posts erected near Trolley Park on Hamilton Road. The posts were put in place to keep cars off the grass. Mr. Finke stated he liked the white posts as they are more visible and he can also add reflectors to them. Council asked Mr. Finke to get prices on the post and get back with them.

Mr. Finke stated he received two bids for the demolition of 937 Montague Road. The high bid was \$16,000 from the Evans Company. The lower bid of \$11,500 was received from Mr. Tim Estes, ITS Company. Mr. Finke is still awaiting one more bid. Mr. Ryan told Mr. Finke if the next bid comes in lower and Mr. Finke is comfortable with the company to go ahead and schedule the demolition.

Mr. Finke also brought up the salt shortage to Council. He states he has 20 tons of salt left over from last year which should last for 4-5 snows. He can stretch that by adding sand to the mixture. Mr. Finke believes the city should be fine for the winter but wanted Council to be aware of the shortage. He will keep Council updated.

#### IV. New Business

Mayor Hellmann stated he is gathering information for the ballot incentive to purchase a fire truck and for land acquisition. He stated the budget to operate the Park Hills Fire Department is around \$150,000 annually. Surrounding cities budget much more to operate their departments making it financially unfeasible to merge with another city's department. Estimated budgets for other local cities are: Ludlow - \$404,750 (Fire and EMS)

Ft. Wright - \$740,000

Ft. Mitchell - \$1.5 million Covington - \$12 million
