From the Mayor



Dear Neighbors,

As the nights grow longer, and the year's end draws close, I'd like to reflect on the paths we have traveled together over our City's 90th anniversary year. We've made substantial progress in a few key areas, which include improved pathways, enhanced strategic planning, economic development, and transparency. Allow me the indulgence of sharing some of our journeys.

Improved Pedestrian Pathways

A walkable City is a livable one. This year we focused on making our City more walkable and accessible to all residents. In late July, we connected our Park Drive sidewalk with the new walkway into Devou Park and installed a sidewalk along Old State Road—from Terrace to North Arlington—expanding a safe pedestrian network across our City. Continuing along that same path, in 2018, we plan to add a sidewalk along North Arlington Road as we completely rebuild the street. The Infrastructure and Public Works Committee is also reviewing plans to add a sidewalk to St. Joseph Lane.

Once these plans are accomplished, every major thoroughfare that connects to the Dixie Highway will have a safe, dedicated pedestrian walkway. I have called for the Infrastructure and Public Works Committee to inventory and assess the conditions of our existing sidewalks and to recommend vital future pedestrian pathway connections. Finally, the Commonwealth of Kentucky is continuing to review the design of sidewalks along Dixie Highway—from North Arlington to Covington—which will complete a safe pathway for pedestrians to walk from the Ohio River south to Boone County.

Enhanced Strategic Planning for Capital Projects

Any path forward must be built on a solid foundation. Working with the Financial Oversight Committee and City Council, we have begun to focus on the City's long-range budget forecasting and reporting processes. With the guidance of our professional financial consultant, David Baker, we plan to develop and publish our long-range capital improvement plan, road improvement plan, and a cash-flow analysis using several years of historical data. These plans will allow us to better predict what we will need to spend in the future.

For example, one of the biggest line items in our City's budget is road construction. Once we assess the streets, we can prioritize the repairs that are needed and predict the costs of these future repairs. With this financial analysis, we can plan our budget to meet the City's needs and better estimate future capital expenditures such as street maintenance, police cars, and snow plows.

Economic Development

Pathways can lead in many directions, and we continue to focus on economic development along the Dixie Corridor. We're working with Kenton County Judge-Executive Knochelmann, Kenton County Economic Development Director Pat Wingo, the Economic Development Committee, and City Council to determine how best to promote responsible growth in our commercial district. Look for another Plan Park Hills forum in the spring when we will again seek public input as we continue to chart the path for healthy long-term economic development in Park Hills.

Transparency

Just as our new walking paths are public, we are committed to the public accessibility of our City's plans and financial data. We have taken substantial action to make everything about City government more transparent. Our new service, OpenGov, allows us to present expanded financial data publicly via the OpenGov website. This site also makes it possible to provide essential data related to our Police and Fire Departments. I want to continue to expand our secure online repository of all public data so that everyone can readily access information from their home computers and mobile devices. Check out what we have now on the OpenGov link via the homepage of our City's website: www.parkhillsky.net.

I hope this overview of our key initiatives is helpful. I am very excited to bring these improvements, changes, and innovations to our City, and I could not do this without the help of the great people who serve our City. I would like to once again thank Council, our City's departments and professional staff, and committee members who have joined with us to lead Park Hills through this past year. I encourage all residents to come out and participate in the many civic events and activities planned for 2018.

We celebrated Park Hills 90th birthday with great flair just a couple of months ago—now I am looking forward to our City's 91st year, and many more to come.

Have a wonderful and safe Christmas and holiday season. I look forward to crossing paths with you around town next year.

Financial Oversight Committee Update

Our general reserves are over \$450,000. We are working toward a goal of a year's worth (approximately \$1,000,000) for general reserves. Our roads are 59% updated with the available Park Hills Road Tax fund. In addition, there is a Municipal Road Aid fund which may be used for road-related items such as repairs. We will continue to be prudent with the City's funds and to best use them for the benefit of the people of our City. Our Mayor has retained Mr. Baker to do a 5-year capital expenditure plan and to assist our City Clerk in monthly account reports and reconciliation.

It is our goal to make our financial statements as readable and available as possible.

The committee will begin work on the capital expenditure program, which will include an analysis of our capital needs such as vehicles, repairs, equipment, and maintenance. All are welcome and encouraged to attend the committee meetings at 7:00 PM every first Monday of the month, at the City Building. Presently, the committee is considering the revision of how the vehicle sticker fee is collected. Various options are being considered with the view toward making the fee more equitable in terms of all residents participating and less cumbersome to pay.

Ninety Years of Minutes

With the City of Park Hills celebrating its 90th birthday this year, we have ninety years worth of preserved history in the



form of archived City Council meeting minutes. Our records are a showcase of the changes in technology—from the handwritten first page of June 30, 1927, to the typewritten pages of the mid-century, and the dot-matrix printed pages of the 1990s to the laser-printed pages of today.

Earlier this year, our City Attorney's office oversaw the daunting task of scanning and digitizing every single page from this archive. The result was a mammoth 873 Megabyte file that contained 7,655 pages! Bob Amott of the Communications Committee extended the effort by dividing the file into separate, searchable files with tables of contents—one file for each year. All of these meeting minutes are now available for viewing on the City website. Park Hills is proud to be the first city in the region that has posted its entire historic archive of Council meeting minutes online.

It is fascinating to read through the old meeting minutes and realize that many of the issues we discuss today were first discussed many years—even decades—ago. For example, in January 1932, City Co-Founder D. Collins Lee made a prophetic statement that "wherever trees were missing, it would be adding beautification to the Town to replace them." A gentleman named Mr. Rich was the first of many petitioners over the years to express concerns about "the speeding of automobiles" on Old State Road in August 1933. In July 1935, Council approved a request by the First Lutheran Church of Park Hills to close Hamilton Road one evening to hold a "Lawn Fête." Wildlife was on residents' minds (and in their noses) in May 1968 with the comment that "Park Hills was infested with skunks and foxes!" A "walking/bike trail" on the old trolley line was first suggested in July 1995.



Additionally, if you are interested in reviewing more recent City Council meetings, the Telecommunications Board of Northern Kentucky (TBNK) has an archive of video recordings of the meetings covering

the past three years. These can be accessed by going to the *City Council* page of the City website. New videos are generally released by TBNK within a week of each meeting's occurrence.

The Park Hills Street Program

In the late 1990s, the City of Park Hills launched a Street Program with the ambitious goal of completely rebuilding all 30+ City streets, about 8.8 miles total. The Street Program calls for a comprehensive "deep fix" approach which includes:

- Replacing the pavement.
- Adding curbs and gutters.
- Removing and upgrading the water and gas lines buried underneath, which may be several decades old and failing.

Because of the age of most of the region's infrastructure, it is now standard procedure to coordinate water, gas, and sewer line upgrades with major road construction projects.

The old sewer lines are of particular interest, as they are an obsolete "combined sewer" design which carries both sanitary wastewater from our homes and stormwater in the same pipe. Heavy rains can overwhelm the old sewer lines, leading to sewer backups in basements and untreated wastewater discharges into the Ohio River—our primary source of drinking water.

The Street Program is funded primarily by two sources:

- 1. Municipal Road Aid (MRA) Fund.
- 2. Park Hills Road Tax Fund.

Municipal Road Aid is received from the state every month. This revenue comes from the gasoline tax and is appropriated to cities based on their population. We are budgeting \$58,000 in MRA for the fiscal year 2017-18.

The Park Hills Road Tax took effect in 1996 at the rate of \$2.35 per \$1,000 of assessed property. It was temporarily reduced by 34% to \$1.55 per \$1,000 in 2008. This reduction was then made permanent in 2012. We are budgeting \$300,000 in Road Tax revenues for this fiscal year.

So far, nineteen streets have been rebuilt using the "deep fix" approach. This includes all the streets south of Amsterdam Road except for parts of North Arlington and Hamilton Roads, and the short segment of Mount Allen Lane where the NKU Chase Law School building was formerly located. North of Amsterdam Road, the list of rebuilt streets includes Rose Circle, Hillcrest Lane, Morgan Court, Altavia Avenue, and part of Lawton Road.

In October 2015, to help expedite some larger street projects, the City took out a \$2.5 million tax-exempt lease for street improvements, also known as the "street loan." To date, \$1.4 million of the loan has been drawn, financing the complete rebuilds of Altavia, Alhambra, Coram, Harriet, and Aberdeen Roads. \$1.1 million remains to be drawn, and this will be used to rebuild North Arlington and lower Jackson Roads over the next year. Once these projects are complete, there will be approximately thirteen streets remaining from the original *Street Program*. Nearly all of these streets are north of Amsterdam Road, plus Amsterdam Road itself.

The City is obligated to continue making loan principal payments of \$50,000 plus interest every quarter for the next 10.5 years. Over this period, the remaining street funds will be used to perform short-term "mill and overlay" payement repairs as needed.

Whether any "deep fix" repairs are performed in the next ten years will be determined by the magnitude of the mill and overlay schedule, which is still being determined.

The Infrastructure Committee is planning to commission a complete inventory and assessment of the City's streets, sidewalks, street signs, and street lighting. This will be used to establish the "mill and overlay" schedule for our streets and to develop a plan for enhancing our walkways and street lighting.

A presentation on the status of our *Street Program* and infrastructure funding was made at the October 23 Caucus Meeting. This can be viewed at the Infrastructure Committee's page on the City's website.

A Friend of Park Hills Remembered: Clem Hellmann

Perhaps you noticed the flag in front of the City Building was at half-staff at the end of October. This was in honor of Clem Hellmann—77, a resident of Phoenix, Arizona with long ties to the City of Park Hills and Northern Kentucky—who died on October 29.

Clem and his wife Mary Jo purchased a house in Park Hills, and like many young couples, when their family expanded, they chose to move to another, bigger house in Park Hills. Together, they raised three children—Jacquie Bauereis, Michael Hellmann, and Jennifer Freiland—while being part of the neighborly fabric of our City.

Clem and Mary Jo served as co-chairs of the Civic Association. Clem served on various boards and was a volunteer fireman and life squad member. For years, every night, he carefully laid out his boots and uniform so he could dress quickly if the firehouse siren went off. In recognition of their service and devotion to Park Hills, Clem and Mary Jo served as grand marshals for one of our Memorial

Day parades.

In 1987, the Hellmanns moved to Arizona and continued to be benefactors of Park Hills. They donated money for a new roof, brick pavers, and the design and installation of the stained glass



window for the upper trolley building. The "BRONK" insignia on the stained glass window stands for Bridge Runners of Northern Kentucky, a group of men—Devinder Mangat, Clem Hellmann, David Schlothauer, and Larry Heil, pictured here—who trained for local races and marathons. Their training routes crisscrossed the bridges over the Ohio River. For twenty years, the group organized a fall BRONK bridge run, inviting other local runners to participate. They always started and ended their runs at the affectionately titled "BRONK office"—the upper trolley building that then housed a payphone so late runners could contact their buddies. Clem won the 1982 race.

A memorial mass and gathering for Clem were held at The Church of St. Agnes on November 18. Those of us who knew him remember him as a kind, generous, and gentle family man who loved telling "little Johnny " jokes. His spirit and character live on here in Park Hills.

At the November City Council caucus meeting, Mayor Mattone announced a City of Park Hills Proclamation declaring November 27, 2017 as Mr. Clemens (Clem) Hellmann Day.

City Sticker Enforcement

After receiving numerous complaints, the Park Hills Police Department is going to step up enforcement of the City sticker ordinance (# 33.055) starting **December 1, 2017**. As everyone knows, all Park Hills residents who own vehicles are required to purchase a City sticker for each vehicle they own. There's been some confusion



amongst the residents whether they're required to purchase this sticker if they don't park on the street, they drive a company car, or their car is registered in another state.

If you live in Park Hills and you drive a vehicle, you must purchase a City sticker for that vehicle.


By definition, a vehicle is every device in, upon, or by which any person or property is or may be transported or drawn upon a highway, except devices moved by human power. This includes any county-registered vehicle, even motorcycles. Think of this as a fee for operating your vehicle on the roads of Park Hills, like a road tax instead of a parking permit.

Stickers can be purchased at the City Building for \$15 per vehicle.

When vehicle owners are cited after this date, we are also going to investigate whether that owner has paid all prior years' taxes. If not, the City will initiate steps to recover any and all prior owed City sticker fees, including the \$20 late fee for each year, for each vehicle.


John Klette Turns 100!



Fire Safety

October was National Fire Prevention Month, and National Fire Prevention Week was observed Sunday to Sunday, the week of October 9th.





horrendous fires—the Great Chicago Fire and the lesser-known but more devastating Peshtigo Fire. The Great Chicago Fire started on October 8th, 1871, but did most of its damage on the 9th, claiming the lives of more than 250 people. It destroyed over 17,000 buildings across 2,000 acres, leaving 100,000 homeless Chicagoans. That very same day, the Peshtigo fire roared in northeast Wisconsin and burned over 1.2 million acres of land, including 16 entire towns. This fire was over four times as lethal as the Chicago fire and killed 1,152 people.

Since the 1920s, the National Fire Protection Association (NFPA) has focused on specific fire prevention and life-saving themes each year during this period. This year's theme was "Every Second Counts: Plan 2 Ways Out!" emphasizing that we always need to have an escape plan with a backup strategy. This is because fires can double every 30 seconds, and in only a few minutes, a small fire can quickly consume multiple rooms or floors of a house.

The NFPA and the Park Hills Fire Chief, John Rigney, recommend the following:

- Draw a map of your home with all members of your household, marking two exits from each room and a path to the outside from each exit.
- **Practice your home fire drill** with everyone in your home twice a year—once at night and once during the day—and practice using different ways out.
- **Teach children how to escape** on their own, in case you can't help them.
- Make sure your home's street number is clear and easy for the fire department to find.
- Close doors behind you as you leave—this may slow the spread of smoke, heat, and fire.
- Once you get outside, stay outside. Go to a pre-selected meeting spot. Never go back inside a burning building.

Additionally, you should also test your smoke alarms on a regular basis (monthly) to make sure they are working. Install smoke alarms in every bedroom, on every level of the home, and outside of each separate sleeping area.

Streetcar Suburb: The Planned Community of Park Hills, Kentucky

On September 7th, Dr. Paul Tenkotte gave a lecture at the Behringer-Crawford Museum entitled *Streetcar Suburb: The Planned Community of Park Hills, Kentucky.* The lecture was very well attended by over 125 people. Dr. Tenkotte presented an interesting and interactive analysis of the foundation of Park Hills and the key persons in its formation. His accompanying PowerPoint was replete with fascinating photos and tidbits from the City's past. The audience was very much engaged by Dr. Tenkotte's questions and the ensuing give-and-take was both enjoyable and edifying.

The lecture covered a wide range of details about key people including City founder D. Collins Lee, leading architects, early businesses, and founding residents. It addressed the motivations for establishing the City and the importance of the streetcar line.

Dr. Tenkotte's lecture closed by stressing the importance of knowing our history in order to guide our future. Park Hills is not just a beautiful setting filled with charming homes. It is a compilation of traditions and a mosaic of residents who have contributed to its unique character. As our founder D. Collins Lee said, "There will never be another Park Hills." Let's treasure it.

A second lecture is planned for February. It will address, in greater detail, the architecture, and the interior design of Park Hills homes, including room layouts, furnishings, and landscape. The date has not yet been finalized. A third lecture is planned for June. It will provide residents the details of how to obtain the state income historic tax credit for home improvements. Local residents will share their success stories and experiences. A substantial reduction of state income tax is available for projects that meet the criteria of KRS 171.397 and 300 KAR 6:010.
