<u>Financial Report</u>

We are refinancing the City's debt to obtain a lower interest rate which will

save money and enable us to pay off our debts more quickly. In fact, we will be able to pay off the fire truck loan a year early. Our budget is on target for the year. There is a summary of the year to date budget information included in the newsletter. That information is also available on the City's website. By being frugal, we have been able to save approximately \$100,000 which has been secured in the City's Operating Reserve Fund. We will continue to accrue savings there to create backup for the City's fiscal needs and operations. Most importantly, we will place on the November ballot the permanent repeal of the Fire Truck/Economic Development Tax which will result in a .80 per \$1,000 of valuation tax reduction, if approved by the voters.

Police Department Report

Our City is being served by an excellent Police Department consisting of: Chief Cody Stanley, Sgt. Dwayne Cox, Detective Richard Webster, Officer Cyrus Harris, Officer Ricky Grigson, Officer Jack Prater, Officer Jeff Hagedorn, Officer Steve Giffords and Police Administrative Assistant Chris Heubner. Street patrols have increased and police have a higher visibility. We continue to upgrade equipment and training has been stepped up. The office exchange between the Police Department and the City Clerk's office was made possible by the Police Department's volunteering to move upstairs for the benefit and convenience residents. our

City Clerk's Office Report

The City Clerk's office has officially moved to the ground floor so that our residents can walk right in without having to use the stairs. A handicapped parking spot located right outside the doorway will also help make it easier to visit the Clerk's office. The City Clerk will be working with a professional archivist from Frankfort (there is no charge for this service) to sort and archive much of our paperwork. This will allow us to make the best use of our limited space. Also, the City Clerk will be maintaining our upgraded city website. The hours remain 8:00am to 6:00pm for the convenience of our residents.

Public Works Department Report

The entire City Building has had the asbestos removed and new carpeting installed. In addition the City Building has been painted, including the Public Works garage and most of the interior. The Public Works Department worked to make the necessary improvements to the new Clerk's office and the new police office. This was accomplished with minimal expense.

Fire Department Report

The new generator obtained by grant through the Fire Department has been installed and is operational. It covers the Fire Department and the entire City Building.

Public Improvements Report

Duke Energy representatives, at the request of council, met with city council and residents to address concerns about excessive power outages. The meeting was productive and resulted in Duke Energy working hard in Park Hills to clear their utility line easements, update

equipment, replace transformers and install squirrel guards in order to minimize and shorten power outages in our city. This investment by Duke Energy was without cost to our city.

Public Properties Report

The property located at 1530 Dixie Highway is officially sold to Charter Oak Investments and the grant for \$124,000 which was used to relocate the sewer lines and

realign the roadway has been completed and we have been fully reimbursed by the State. The property will be used for a commercial purpose.

Finally, the City is in improved financial condition and we will keep working to make it even better. Council and I are working hard to make good decisions for our City. I take my duties as mayor very seriously and will continue to do my best for our City. Thank you.

VEHICLE LICENSE TAGS

The Park Hills Vehicle License Tags were due in the month of February. If you have not already done so, you may purchase

your tag at the City Building, Monday thru Friday from 8:00 am – 6:00 pm. The fee is \$15.00 per vehicle (plus a late fee of \$20.00) and is payable by cash or check. You may also mail your payment to the City Building at 1106 Amsterdam Road. Please include your car's year, make and license plate number along with a self addressed stamped envelope so that we can mail your tag to you. If you have any questions, please contact the City Clerk at 431-6252.

ANIMAL TAGS

Animal licenses are due and payable at the City Building by the end of the month of May. The fee is \$5.00 per dog and/or cat. The city has a limit of five pets per household. Please remember to clean up after your pet during walks and obey the city's leash law by not letting your pets run at large. Also, remember that if your pet is lost the tag is a good source of identification.

*Animal tags are available now at the City Building so that you can purchase them along with your vehicle tag(s)

Concerning your Trash pick-up, we have kept the fees in line and Rumpke also has offered a free large trash can or recycle can. You can call to request they drop this off to your home. If you want both, the cost is \$1.00 per month.

ECONOMIC DEVELOPMENT

The Economic development Committee has been working in conjunction with the Business Association to reevaluate the zoning along the Dixie Highway corridor.

The plan is to come up with a zoning plan that encourages new businesses to locate in Park Hills. We also wish to create an institutional zone for our neighbors Notre Dame Academy and Covington Catholic High School. They are currently operated in a residential zone as a non conforming use. This makes it costly and cumbersome for them to make even minor changes to the schools or grounds.

We would like consider the recommendations made by our recent Small Area Study that was done in 2009. Part of the Small Area Study includes a market study that will help developers determine what types of business will have a high success rate.

HISTORIC PRESERVATION

Kentucky Historic Preservation State Tax Credit

The preservation tax credit is a wonderful resource and is available for all Park Hills homes located within the historic district and certified by the Kentucky Heritage Council as contributing to the historic significance of the district. To determine if your home is within the district you can consult the City Clerk who has a map listing the approved properties

The credit is 30% of qualified rehabilitation expenses and requires a minimum investment of \$20,000, with the total credit not to exceed \$60,000. In order to obtain the credit, a home must be rehabilitated according to standards set by the US Dept. of Interior and must be certified by the Kentucky Heritage Council. The standards are intended to provide guidance to historic restoration and include such requirements as:

- The historic character of a home shall be retained
- Distinctive features of craftsmanship shall be preserved
- Deteriorated features shall be repaired rather than replaced

The Kentucky Heritage Council reviews all tax credit projects for eligibility and standards. Applying for the credit is a three part process:

Part 1 is the preliminary application, evaluation of status

Part 2 is the description of proposed rehabilitation, which outlines in detail the work to be done

Part 3 is the actual request for Certification of completed work

Parts 1 and 2 may be done simultaneously. Photographic documentation of the project prior to the rehabilitation and at each phase of the certification process is required.

While the procedure might be a bit tedious, the Kentucky Heritage Council is very polite and cooperative. The available credit for significant repairs or a new kitchen/bathroom is a financial benefit that should be considered. A Federal tax credit (using the same criteria) might also be available to income producing properties, but not to owner occupied homes.

PARK HILLS FIRE DEPARTMENT

I hope this article finds you in good spirits and thinking of Spring weather. I know the Fire Department members are anxiously awaiting warmer weather to

continue hands-on training outdoors. Sometimes, the thought of training inside the same four walls during cold Tuesday nights can foster complacency. Therefore, anticipation of change is a refreshing boost for morale.

While complacency during the long winter months may surprise the best of us, the Fire Department asks that you keep a few safety tips in mind:

- Make sure your smoke detectors were checked and batteries were replaced during the time change in the Fall. Remember to test them periodically.
- Consider replacing your Carbon Monoxide detector if it's older than ten years. Detectors with digital readouts are most helpful and reliable. Most local retailers carry quality detectors at comparable pricing.
- Please do not bun your leaves. Burning leaves this Spring can cause one of two things; brush fires (which can grow quickly out of your control) or poor relationships with your neighbors (due to all of the smoke annoying them).
- Be cautious while driving during the winter months. Road conditions and frost or ice on the windshield should be an indicator to allow extra commuting time.
- If you have a fireplace, consider having it cleaned and checked before you burn to prevent chimney fires. Also, make sure to monitor the fireplace while in use and keep all guards in place. Never leave a fire unattended.

Finally, the Fire Department will be sending a letter soon seeking feedback. Please remember that the Park Hills Fire Department is a volunteer organization. Any assistance that you can provide in response to the letter will be greatly

appreciated. On behalf of myself and the Fire Department, we hope that you stay safe and healthy in 2012.

The Bad News!

We are losing are trees in Park Hills at a rapid rate! Our tree canopy is aging and we are losing many of our large stately trees each year to storms, disease and insects. We need to collectively act now to protect our community's historical investment and our own property values!

The Good News!

Did you know?



1. Trees increase our quality of life by bringing natural elements and wildlife habitats into urban settings. Our neighborhood is home to many old trees that serve as historic landmarks

and a great source of pride and enjoyment. Tees contribute to their environment by providing oxygen, improving air quality, climate amelioration, conserving water, preserving soil, and supporting wildlife.

Trees are essential to the eco-systems in which they reside, both above and below ground... Far reaching roots hold soil in place and fight erosion. Trees absorb and store rainwater which reduce runoff and sediment deposit after storms. This helps the ground water supply recharge, prevents the transport of chemicals into streams and prevents flooding.

PROPERTY VALUE AND ECONOMIC VALUE

Individual trees and shrubs provide value and contribute to savings, but it is the collective influence of well-maintained landscapes that makes real economic impact and has the greatest effect on property values. Direct economic benefits come from a savings in energy costs. Cooling costs are reduced in a tree-shaded home, and heating costs lowered when a tree serves as a windbreak. According to the USDA Forest Service, "Trees

properly placed around buildings can reduce air conditioning needs by 30% and save 20-50 percent in energy used for heating."

Property values of homes with well-maintained landscapes are up to 20% higher than others.

What can be done!

I am asking each resident of Park Hills to plant at least one tree a year in your yard. If every resident planted a tree we would have over 3,000 trees planted each year. Plant an annual tree for each family member. Your investment will pay off by increased property values, energy reduction and enjoyment. We can catch up. The fall and spring are the best times to plant trees. 
