ORDINANCE NO. 16, 2013

AN ORDINANCE OF THE CITY OF PARK HILLS, IN KENTON COUNTY, KENTUCKY, AMENDING CHAPTER 101 OF THE CITY'S MUNICIPAL CODE OF ORDINANCES BY AMENDING SECTION 101.02 IN ORDER TO INCORPORATE INTER-LOCAL COOPERATION AGREEMENTS BY REFERENCE.

BE IT ORDAINED BY THE CITY OF PARK HILLS, KENTUCKY:

SECTION I: Chapter 101 of the City's Municipal Code of Ordinances is hereby amended by amending Section 101.02 to read as follows:

§ 101.02 Powers.

- (A) The Board shall have all powers, authority and duties granted pursuant to the Act and related statutes, and all powers, authority and duties granted in this Chapter.
- (B) The Board shall have the power to issue remedial orders and impose civil fines as a method of enforcing city ordinances when a violation of the ordinance has been classified as a civil offense.
- (C) The Board shall also have the following powers:
 - (1) To adopt rules and regulations to govern its operations and the conduct of its hearings;
 - (2) To conduct hearings to determine if there has been a violation of an ordinance over which it has jurisdiction to enforce:
 - (3) To subpoena alleged violators, witnesses, and evidence to its hearings (subpoenas issued by the Board may be served by a code enforcement officer or as otherwise provided in the Kentucky Rules of Civil Procedure);
 - (4) To take testimony under oath; and
 - (5) To make findings of fact and issue orders necessary to remedy any violation of a city ordinance or code provision which the Board is authorized to enforce.
- (D) Should the City of Park Hills enter into any Inter-local Cooperation Agreements per KRS 65.210 to 65.300in order to join a multijurisdictional Code Enforcement Board, then:
 - (1) The powers described in this section shall be granted to the multi-jurisdictional board;

- (2) The inter-local cooperation agreement shall be incorporated by reference into the City of Park Hills Code of Ordinances as if fully written herein; and
- (3) Any provision of any ordinances that are in conflict with the inter-local cooperation agreement shall be shall be set aside to the extent of said conflict as long as the inter-local cooperation agreement remains in effect.

SECTION II

Any and all Ordinances in conflict with this Ordinance shall be, and hereby are, repealed to the extent of said conflict.

SECTION III

This Ordinance shall take effect and be in full force from and after its passage, publication, which may be in summary form, and recording, according to law.
