ORDINANCE NO. 3, 2014

AN ORDINANCE OF THE CITY OF PARK HILLS, IN KENTON COUNTY, KENTUCKY, AMENDING CHAPTER 114 OF THE MUNCIPAL CODE.

WHEREAS, the City of Park Hills, hereby discerns the need to amend Chapter 114 of the Park Hills Code of Ordinances to comply with certain provisions of legislation recently enacted by the Kentucky General Assembly regulating alcoholic beverages.

NOW, THEREFORE, BE IT ORDAINED by the City of Park Hills, in Kenton County, Kentucky, as follows:

SECTION I

That §114.03 of the Park Hills Code of Ordinances is hereby amended as follows:

§114.03 CLASSES OF LICENSES. There shall be six classes:

- (A) "Wholesale Liquor License." A "Wholesale Liquore License" (A) Wholesaler's Distilled Spirits and Wine License. A "Wholesaler's Distilled Spirits and Wine License" when issued by the City of Park Hills, under authority of the City Council, shall permit its holders to sell, deal, and traffic in intoxicating liquors only in cases or gallons to persons holding a Quota Retail Package Liquor License or a Quota Retail Liquor Drink License. The fee of such "Wholesale Liquor License" "Wholesaler's Distilled Spirits and Wine License" shall be One Thousand Five Hundred Dollars (\$1,500.00) per year.
- (B) Quota Retail Package Liquor License. A "Quota Retail Liquor Package License" when issued by the City of Park Hills, under authority of the City Council, shall permit its holder to sell at retail vinous wine or spirituous liquors in unbroken packages for consumption off the premises. The fee for such "Quota Retail Package Liquor License" shall be Five Hundred Dollars (\$500.00) per year.
- (C) Quota Retail Liquor Drink License. A "Quota Retail Liquor Drink License" when issued by the City of Park Hills, under authority of the City Council, shall authorize the holder thereof to purchase, receive, possess, and sell distilled spirits and wine at retail by the glass for consumption on the licensed premises. The fee for such "Quota Retail Drink License" shall be Five Hundred Dollars (\$500.00) per year. All licenses issued hereunder shall permit the licensee to sell malt beverages for consumption on the premises in addition to the distilled spirits and wine without further fee.

- (D) "Malt Liquor Drink License." A "Malt Liquor Drink License" (D) "Non-quota Type 4 Retail Malt Beverage Drink License." A "Non-quota Type 4 Retail Malt Beverage Drink License" when issued by the City of Park Hills, under authority of the City Council, shall permit its holder to dispense and sell malt liquors by drink or package. The fee for such "Malt Liquor Drink License" "Non-quota Type 4 Retail Malt Beverage Drink License" shall be Twenty-Five Dollars (\$25.00) per year.
- (E) "Malt Liquor Package License." (E) "Non-Quota Retail Malt Beverage Package License. A license issued by the City of Park Hills, under authority of the City Council under this section, shall permit its holder to sell any malt liquor or beverages to consumers in unbroken packages form, and said malt beverages shall not be consumed upon the premises, and the license for such shall be One Hundred Dollars (\$100.00) per year.
- (F) <u>"Sunday Distilled Spirits and Wine Retail Drink License."</u> "Special Sunday Retail Drink License." A license when issued by the City of Park Hills, under authority of the City Council, shall authorize the holder thereof to purchase, receive, possess, and sell distilled spirits and wine at retail by the glass for consumption on the licensed premises. The fee for such <u>Sunday Distilled Spirits and Wine Retail Drink License Special Sunday Retail Drink License</u> shall be Three Hundred Dollars (\$300.00) per year. All licenses issued hereunder shall permit the licensee to sell malt beverages for consumption on the premises in addition to distilled spirits and wine without further fee. All sales of distilled spirits and wine, and malt beverages by the drink, are governed by and limited to the hours of operation established herein. The entitlements of a <u>Sunday Distilled Spirits and Wine Retail Drink License</u> <u>Special Sunday Retail Drink License</u> include the right to sell distilled spirits and wine and malt beverages at retail by the glass only during the hours of operation established by this chapter.
- (G) <u>The holder of a Non-quota Retail Malt Beverage Package License may obtain a Non-quota Type 4 Retail Malt Beverage Drink License for a fee of fifty dollars (\$50.00). The holder of a Non-quota Type 4 Retail Malt Beverage Drink License may obtain a Non-quota Retail Malt Beverage Package License for a fee of fifty dollars (\$50.00).</u>

SECTION II

Any and all ordinances in conflict with this Ordinance shall be, and hereby are, repealed to the extent of said conflict.

SECTION III

The invalidity of any provision of this ordinance shall not affect the validity of any other provision.
