

THE CITY OF PARK HILLS, KENTUCKY
ORDINANCE NO. 18, 2011

AN ORDINANCE OF THE CITY OF PARK HILLS, KENTUCKY CREATING A NEW SECTION 100.02 (ENTITLED *BUILDINGS LOCATED WITHIN TROLLEY PARK*) WITHIN CHAPTER 100 (ENTITLED *PUBLIC PROPERTY*) OF TITLE IX (ENTITLED *GENERAL REGULATIONS*) OF THE PARK HILLS CODE OF ORDINANCES TO ADDRESS THE USE OF THE BUILDINGS LOCATED WITHIN TROLLEY PARK

WHEREAS, That construction was recently completed on a new All Purpose Building located within Trolley Park; and

WHEREAS, That other public buildings are located within Trolley Park; and

WHEREAS, That it is in the public interest that rules and regulations addressing the use of all buildings located within Trolley Park be enacted.

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF PARK HILLS, KENTUCKY, as follows:

Section 1. That a new Section 100.02, entitled *Buildings Located Within Trolley Park*, of Chapter 100, entitled *Public Property*, of Title IX, entitled *General Regulations*, of the Park Hills Code of Ordinances, be created to address the use of all buildings located within Trolley Park, as follows:

SECTION 100.02 ALL PURPOSE BUILDING IN TROLLEY PARK

A. *Public meetings.* No person shall hold or attend any public meeting, event, or gathering of any kind within any building located within Trolley Park without first obtaining a permit therefore from the City Clerk.

B. *Selling goods.* Except for subsidiaries and instrumentalities of Park Hills, no person shall sell or expose anything for sale within any building located within Trolley Park without first having obtained a permit from the City Clerk.

C. *Defacing or Destroying the All Purpose Building.* No person shall take, carry away, disturb, molest, destroy, mar, deface, mutilate, mark, or damage any building located within Trolley Park.

D. *Refuse to be Placed in Receptacles.* No person shall drop or throw paper, lunch boxes, refuse, food, liquids, or litter within any building located within Trolley Park. Litter shall be placed in receptacles provided for such purposes.

E. *Dangerous Weapons Prohibited.* No person shall discharge firearms, slings, bows, or any other device within any building located within Trolley Park by which persons or animals may be injured or frightened. No person shall throw stones or other missiles within any building located within Trolley Park.

F. *Fires Prohibited.* No person shall light, make, or use any fire within any building located within Trolley Park. For the purposes of this subsection, "fire" means any flame larger than a flame generated by a match or cigarette lighter.


G. *Use of Glass Bottles or Containers Prohibited.* The use of glass bottles or containers of any kind within any building located within Trolley Park is prohibited.

H. *Alcoholic Beverages; Controlled Substances.* No person shall be under the influence of intoxicating liquor or a controlled dangerous substance while within any building located within Trolley Park.


Section 2. That if any provision of this Ordinance is deemed by a court of competent jurisdiction to be unenforceable or unconstitutional, the remaining provisions of this Ordinance shall continue in full force and effect.

Section 3. That all other ordinances and parts of ordinances in conflict with this Ordinance are hereby repealed to the extent of the conflict.

Section 4. That this Ordinance shall be effective when passed, published and journalized according to law.
