THE CITY OF PARK HILLS, KENTUCKY ORDINANCE NO. 4, 2011

AN ORDINANCE AMENDING SECTION 72.05 (FIRE LANES) OF CHAPTER 72 (PARKING REGULATIONS) OF TITLE VII (TRAFFIC CODE) OF THE PARK HILLS CODE OF ORDINANCES TO: (A) PROHIBIT THE PARKING OF MOTOR VEHICLES ON ALL CUL-DE-SACS AND T TURNAROUNDS LOCATED WITHIN THE CITY OF PARK HILLS, KENTUCKY, AND IDENTIFYING THE CUL-DE-SACS AND T TURNAROUNDS THAT ARE SUBJECT TO THIS PROHIBITION, (B) PROHIBIT THE PARKING OF MOTOR VEHICLES ON THE EAST SIDE OF LAWTON ROAD ADJACENT TO 1064 LAWTON ROAD, (C) AUTHORIZING THE PUBLIC WORKS DIRECTOR TO INSTALL NO PARKING SIGNS AND OTHER WARNINGS AS APPROPRIATE, AND (D) AUTHORIZING SUMMARY PUBLICATION OF THIS ORDINANCE

WHEREAS, the City Council of the City of Park Hills, Kentucky finds and determines that the safety and general welfare of its residents and visitors require that the parking of motor vehicles be totally prohibited on all cul-de-sacs and T turnarounds within the City of Park Hills, Kentucky, and on the west side of Lawton Road adjacent to 1064 Lawton Road beginning at the catch basin and extending to the next catch basin.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF PARK HILLS, KENTUCKY, as follows:

<u>Section 1</u>. That Section 72.05, entitled *Fire Lanes*, of Chapter 72, entitled *Parking Regulations*, of Title VII, entitled *Traffic Code*, of the Park Hills Code of Ordinances be, and it is, amended as follows:

72.05 <u>FIRE LANES</u>.

(A) The following streets and the sides thereof which are hereinafter designated shall be no parking zones for the purpose of permitting fire apparatus and equipment to safely pass on such streets. Parking in the fire lanes hereinafter set forth is strictly prohibited at all times, and the police department is hereby authorized to impound and tow away any vehicles parked in these restricted areas in addition to other penalties prescribed in this chapter, to wit:

Aberdeen Rd. Alhambra Ct. Altavia Ave. Amsterdam Rd. Amsterdam Rd. (1000 block) Arlington Rd.

- West or uneven house numbered side.
- East or even house numbered side, and both cul-de-sacs.
- East or even house numbered side, and the T turnaround.
- North or even numbered side. (100 to Sleepy Hollow)
- From Montague to Terrace Drive parking prohibited on both sides of the street.
- West or uneven house numbered side. In addition, no parking on either side of Arlington Road from Dixie Highway to Lot 806.

Audubon Rd. - South or uneven house numbered side.

Audubon Lane.

Hamilton Rd.

Breckenridge Rd. - West or uneven house numbered side, and the cul-de-sac.

Cecelia Ave.

Cleveland Ave.

Coram St.

- South or uneven house numbered side.

- East or even house numbered side.

- North or even house numbered side.

Emerson Rd. - South or uneven house numbered side, and the cul-de-sac.

Exter Dr. - South or uneven house numbered side.

Hamilton Rd. (Amsterdam to Arlington) No parking from its intersection with Arlington to its intersection with Amsterdam.

- (Arlington Rd. to end) North or even house numbered side,

and the T turnaround.

Harriet St.East or even house numbered side.West or uneven house numbered side.

Hilltop Drive - North or even house numbered side, and the T turnaround.

<u>Irish Rose Lane</u> <u>- both cul-de-sacs.</u>

Jackson Rd. - (Upper and Lower) North on even numbered side east from

Cleveland Ave. to 1050 Jackson, and from 1050 Jackson Southeast uneven numbered side.

Lawton Rd. - Uneven house numbered side and the east side adjacent to

1064 Lawton beginning at the catch basin at the top of the road and extending to 1064 Lawton's driveway.

Montague Rd. - East or even house numbered side.

Morgan Ct. - West or uneven house numbered side, and the cul-de-sac.

Mt. Allen Rd.
Old State Rd.
Park Drive
South or uneven house numbered side.
North or even house numbered side.
West or uneven house numbered side.

Rose Circle - (Amsterdam to 1025) South or uneven house numbered

side.

Rosemont Ave. - East or even house numbered side, the 90° curve, and the

cul-de-sac.

St. Joseph Lane - West or uneven house numbered side. St. James Ave. - East or even house numbered side.

Scenic Ave. - West or uneven house numbered side, and the cul-de-sac.

Sleepy Hollow Rd. - (State Highway – no reg.).

So. Arlington Rd. - East or even house numbered side.

(B) The above designated streets and prohibited parking areas thereon supplement existing regulations but do not nullify said regulations that are now in existence except when in conflict therewith.

Section 2. That the Director of Public Works or his delegate shall forthwith post no parking signs or appropriately paint the curbs on the cul-de-sacs and T-turnarounds constructed on Rosemont Avenue, Irish Rose Lane, Scenic Drive, Alhambra Court, Morgan Court, Emerson Road, Breckenridge Road, Hilltop Lane, Hamilton Avenue, and Altavia Avenue, and also on Lawton Road adjacent to 1064 Lawton, indicating that it is unlawful to park motor vehicles thereupon.

<u>Section 3</u>. All ordinances or parts of ordinances in conflict herewith are hereby repealed but only with respect to said conflict.

 $\underline{Section~4}. \qquad \text{That this ordinance take full force and effect upon publication, as required by KRS Chapter 424 and other applicable law, and shall be published in summary pursuant to KRS §83A.060(9) and other applicable law.}$
