ORDINANCE NO. 4, 2018

AN ORDINANCE OF THE CITY OF PARK HILLS, IN KENTON COUNTY, KENTUCKY, CREATING A NEW SECTION 33.06 OF THE CODE OF ORDINANCES TO ESTABLISH A CAPITAL IMPROVEMENT FUND

WHEREAS, the City recently established a capital improvement plan that identifies known capital expenditures over the next five years;

WHEREAS, the City desires to create a capital improvement fund to set aside revenue for the capital expenditures identified in the capital improvement plan.

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF PARK HILLS, KENTUCKY, AS FOLLOWS:

SECTION I

A new Section 33.06 of the Code of Ordinances, titled "Capital Improvement Fund," shall provide as follows:

There is hereby established the Capital Improvement Fund of the City of Park Hills, Kentucky. The monies in the fund shall be dedicated to funding necessary capital expenditures. Any expenditure made from the fund must be approved by City Council in the budget for the fund.

SECTION IV

Any and all ordinances in conflict with this ordinance shall be, and hereby are, repealed to the extent of said conflict.

SECTION V

If any part of this ordinance or its application is deemed invalid by a court of competent jurisdiction, the City Council intends that such invalidity will not affect the effectiveness of the remaining provisions or applications and, to this end, the provisions of this ordinance are severable.

SECTION VI

That this ordinance shall become effective upon its passage and shall be published under KRS §83A.060(9) and other applicable law. The ordinance may be published by summary.

ORDINANCE NO. 5, 2018

AN ORDINANCE OF THE CITY OF PARK HILLS, IN KENTON COUNTY, KENTUCKY, REPEALING, IN LIGHT OF THE CITY'S CAPITAL IMPROVEMENT PLAN AND BASED ON THE RECOMMENDATIONS OF THE FINANCE COMMITTEE AND THE CITY'S ACCOUNTANT, §33.006 OF THE PARK HILLS CODE; DISSOLVING THE RESERVE FUNDS; AND, TRANSFERRING REVENUE FROM THE RESERVE FUNDS INTO THE CITY'S GENERAL FUND

WHEREAS, the City previously established various reserve funds ostensibly to set aside revenue for future unknown capital expenditures; and,

WHEREAS, the City recently retained David Baker to prepare a capital improvement plan that identifies known capital expenditures over the next five years; and,

WHEREAS, the City intends to set aside revenue for the capital expenditures identified in the capital improvement plan, rendering the reserve funds unnecessary; and,

WHEREAS, based on the recommendations of the financial oversight committee and the City's accountant, David Baker, the City desires to dissolve the reserve funds and transfer revenue in those funds into the City's general fund.

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF PARK HILLS, KENTUCKY, AS FOLLOWS:

SECTION I

That §33.006 of the Park Hills Code, entitled "DEPARTMENTAL RESERVE FUNDS," codified in §33.006 of the 2010 Code, amended and/or restated on April 8, 2013, by Ordinance 4, 2013, and amended and/or restated again on November 10, 2014, by Ordinance, 16, 2014, and related to the creation and application of the reserve funds referred to in Section II of this Ordinance, is hereby repealed in its entirety.

SECTION II

That the following reserve funds, hereinafter referred to as the "Dissolved Funds," are hereby dissolved:

The Police Department Fund;

The Fire Department Fund;

The Public Works Department Fund;

The Administration Department Fund;

The Parks Beautification Fund; and

The Tree Board Fund.

SECTION III

That any revenue in the Dissolved Funds is hereby transferred into the general fund of the City of Park Hills.

SECTION IV

Any and all ordinances in conflict with this ordinance shall be, and hereby are, repealed to the extent of said conflict.

SECTION V

If any part of this ordinance or its application is deemed invalid by a court of competent jurisdiction, the City Council intends that such invalidity will not affect the effectiveness of the remaining provisions or applications and, to this end, the provisions of this ordinance are severable.

SECTION VI

That this ordinance shall become effective upon its passage and shall be published under KRS §83A.060(9) and other applicable law. The ordinance may be published by summary.

ORDINANCE NO. 6, 2018

AN ORDINANCE OF THE CITY OF PARK HILLS, IN KENTON COUNTY, KENTUCKY, AMENDING ORDINANCE 11, 2014, TO CHANGE THE COMPENSATION OF THE CITY'S CHIEF OF POLICE, CODY STANLEY

WHEREAS, by Ordinance 11, 2014, adopted by City Council on June 10, 2014, the City established certain terms related to the employment of its Chief of Police, Cody Stanley; and

WHEREAS, the City Council desires to amend Ordinance 11, 2014, to increase Chief Stanley's compensation.

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF PARK HILLS, KENTUCKY, AS FOLLOWS:

SECTION I

Section 1 of Ordinance 11, 2014, shall be amended as follows:

The City of Park Hills, Kentucky, authorizes an annual salary in the amount of [\$58,864.40] \$60,320.00 plus [\$3,100.00] \$4,000.00 incentive pay from the Commonwealth of Kentucky for the Chief of Police, Cody Stanley. This figure is subject to change by ordinance or amendment to the City's then existing budget ordinance.

Chief Stanley shall be eligible to participate in the Deferred Compensation Plan through Kentucky Deferred Compensation.

SECTION II

Section 2 of Ordinance 11, 2014, shall remain unchanged.

SECTION III

Any and all ordinances in conflict with this ordinance shall be, and hereby are, repealed to the extent of said conflict.

SECTION IV

If any part of this ordinance or its application is deemed invalid by a court of competent jurisdiction, the City Council intends that such invalidity will not affect the effectiveness of the remaining provisions or applications and, to this end, the provisions of this ordinance are severable.
