RESOLUTION NO. 8, 2017

A RESOLUTION OF THE CITY OF PARK HILLS, IN KENTON COUNTY, KENTUCKY, AUTHORIZING THE MAYOR TO EXECUTE AN INTERLOCAL AGREEMENT BETWEEN PARK HILLS AND COVINGTON FOR MAINTENANCE OF TWO PORTIONS OF STREETS THAT FALL WITHIN THE BOUNDARIES OF THE CITY OF COVINGTON, BUT EXCLUSIVELY SERVE PARK HILLS RESIDENTS

WHEREAS, the cities of Covington and Park Hills are contiguous to each other, and Breckinridge Road lies within the boundaries of Covington and Park Hills, and Audubon Lane, lies within the boundaries of Covington and Park Hills; and

WHEREAS, the these streets service residences located within the boundaries of Park Hills; and

WHEREAS, Covington and Park Hills agree that the maintenance of Breckinridge Road and the Relevant Portion of Audubon Lane (collectively referred to as the "Streets") is both beneficial and necessary to the use of the Streets; and

WHEREAS, Covington and Park Hills mutually desire that the cost and obligation of the maintenance of the Streets be performed by, and at the primary cost of, Park Hills; and

WHEREAS, the maintenance of the Streets serves the public purpose of Park Hills by assuring that residents of Park Hills have reasonable access to their properties; and

WHEREAS, the maintenance of the Streets serves the public purpose of Covington by fostering good will between the cities and ensuring the repair and maintenance of public streets for which Covington is ultimately responsible; and

WHEREAS, legal counsel for both cities determined that annexation by Park Hills of the Streets is improper due to the prohibition contained in KRS §81A.410(2)

that no part of the area to be annexed shall be included within the boundary of another incorporated city; and

WHEREAS, Covington and Park Hills desire to effectuate an interlocal agreement, a copy of which is attached to this resolution, to formalize arrangements regarding the maintenance of the Streets.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PARK HILLS, KENTON COUNTY, KENTUCKY:


Section 1

That the Mayor is hereby authorized to execute an interlocal agreement between the City of Covington and the City of Park Hills to provide that Park Hills will provide street maintenance services including but not limited to resurfacing the Streets, patching, clearing snow, ice or other debris at a cost of \$100 annually to Covington to be paid by July 1 of each year.

Section 2


That this Order shall take effect and be in full force when passed and recorded according to law.
