ORDINANCE NO. 1, 2022

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PARK HILLS, KENTUCKY AMENDING ARTICLE VII-DEFINITIONS, SECTION 7 AND ARTICLE X-ZONES, SECTIONS 10.1 THRU 10.7 OF THE OFFICIAL ZONING CODE REGARDING FAMILY CHILD-CARE HOMES TO CREATE A DEFINITION THEREOF AND TO INCLUDE SUCH AS A CONDITIONAL USE WITHIN ALL RESIDENTIAL ZONES WITHIN THE CITY

WHEREAS, the Kenton County Planning Commission (PDS) submitted an application requesting proposed text amendments to the City of Park Hills official Zoning Code to add Family Child Care Homes as a conditional use in all residential zones of the City and to include a definition thereof within, all for compliance with Senate Bill 148 and KRS Chapter 199; and,

WHEREAS, PDS, upon application for the text amendments, held a public hearing upon such request, after giving notice as required by KRS Chapter 424, on February 3, 2022, Number PC2201-0005; and,

WHEREAS, PDS reviewed the application and voted to approve the request and made recommendation to the Council of the City of Park Hills, Kentucky to approve the requested text amendments; and,

WHEREAS, the Council of the City of Park Hills, Kentucky agreeing with the recommendation of PDS,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF PARK HILLS, KENTUCKY, as follows:

SECTION I

That Article VII-Definitions, Section 7 and Article X,-Zones, Sections 10.1 thru 10.7. of the Official Zoning Code of the City of Park Hills, Kentucky, adopted and incorporated by reference in Section 150.01 of the Code of Ordinances, shall be and are hereby amended to read as set forth in Attachment A which is made a part hereof:

ARTICLE VII – DEFINITIONS

SECTION 7.0 WORDS AND PHRASES:

FAMILY CHILD-CARE HOME: Family child-care home means a private home that is the primary residence of an individual who provides full or part-time care day or night for six (6) or fewer children who are not the children, siblings, stepchildren, grandchildren, nieces, nephews, or children in legal custody of the provider.

ARTICLE X – ZONES

SECTION 10.1 R-1C (SINGLE - FAMILY RESIDENTIAL - ONE C) ZONE

C. CONDITIONAL USES: No building or occupancy permit shall be issued for any of the following, nor shall any of the following uses or any customary accessory buildings or uses be permitted until and unless the location of said use shall have been applied for and approved of by the Board of Adjustment, as set forth in SECTION 9.13:

- 1. Cemeteries.
- 2. Churches and other buildings for the purpose of religious worship, provided they are located adjacent to an arterial street.
- 3. Institutions for higher education, provided they are located adjacent to an arterial street.
- Institutions for human medical care hospitals, clinic sanitariums, convalescent homes, nursing homes, homes for the aged, provided they are located adjacent to an arterial street.
- 5. Nursery school.
- 6. Police and fire stations, provided they are located adjacent to an arterial street.
- 7. Public and parochial schools.
- 8. Publicly owned and/or operated parks, playgrounds, golf courses, community recreational centers, including libraries.
- 9. Recreational uses other than those publicly owned and/or operated, as follows:
 - a. Golf courses.
 - b. Country clubs.
- 10. Family child-care homes

SECTION 10.2 R-1D (SINGLE - FAMILY RESIDENTIAL - ONE D) ZONE

- 2. Churches and other buildings for the purpose of religious worship, provided they are located adjacent to an arterial street.
- 3. Institutions for higher education, provided they are located adjacent to an arterial street. 4. Institutions for human medical care - hospitals, clinic sanitariums, convalescent homes, nursing homes, homes for the aged, provided they are located adjacent to an arterial street.
- 5. Nursery school.
- 6. Police and fire stations, provided they are located adjacent to an arterial street.
- 7. Public and parochial schools.

- 3. Institutions for higher education, provided they are located adjacent to an arterial street.
- Institutions for human medical care hospitals, clinic sanitariums, convalescent homes, nursing homes, homes for the aged, provided they are located adjacent to an arterial street.
- 5. Nursery school.
- 6. Police and fire stations, provided they are located adjacent to an arterial street.

MUNICIPAL ORDER NO. 2, 2022

AN ORDER OF THE CITY COUNCIL OF THE CITY OF PARK HILLS, KENTUCKY DECLARING CERTAIN PERSONAL PROPERTY OF THE CITY OF PARK HILLS AS SURPLUS PERSONAL PROPERTY AND AUTHORIZING TRANSFER IN ACCORDANCE WITH STATE LAW.

BE IT ORDERED BY THE CITY COUNCIL OF THE CITY OF PARK HILLS, KENTUCKY, as follows:

SECTION I

Pursuant to KRS 82.083, the City of Park Hills, Kentucky hereby declares as surplus personal property, the item listed below and it is hereby authorized that such be disposed of in accordance with the provisions of KRS 82.083.

Further, pursuant to KRS 82.083(3), the City makes the following written determinations: (a) the personal property item is City of Park Hills Fire Department equipment fully described as set forth below; (b) the intended use at the time of purchase or acquisition was as equipment necessary for daily operations of the City's Fire Department; (c) that it is in the public interest to dispose of such personal property as this items is either outdated or old and too costly to maintain and disposing will reduce maintenance costs, and, (d) the method of disposition will either be a transfer, by way of donation, to another Kentucky governmental agency, without compensation, as permitted by KRS 82.083(4)(a), or sold by electronic public auction pursuant to KRS 82.083(4)(d).
