AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PARK HILLS, KENTUCKY AMENDING SECTION 91.12 (B)(15) OF THE CODE OF ORDINANCES REGARDING PROHIBITED NUISANCES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PARK HILLS, KENTUCKY, as follows:

SECTION I

That Section 91.12(15) of the Code of Ordinances shall be and is hereby amended to read as follows:

Sec. 91.12 NUISANCES DESCRIBED AND PROHIBITED.

- (B) Public nuisances include, but are not limited to:
- (15) Any fowl or livestock within 500 10 feet of any neighboring residence the closest lot and which are restricted to being maintained in the rear of the property. Roosters are entirely prohibited.

ORDINANCE NO. 11, 2023

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PARK HILLS, KENTUCKY AMENDING THE TITLE TO CHAPTER 52 OF THE CODE OF ORDINANCES AND ADDING SECTION 52.10 THERETO REGARDING ENCROACHMENTS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PARK HILLS, KENTUCKY, as follows:

SECTION I

That the title to Chapter 52 of the Code of Ordinances and the newly added Section 52.10 thereof shall read as follows:

CHAPTER 52: STREET EXCAVATION, UTILITY CUTTING AND ENCROACHMENTS

SECTION 52.10 ENCROACHMENTS

- 1. No permanent structure of any kind or nature shall be permitted to be constructed within or upon any City rights-of-way or roadways.
- 2. However, any request, upon application, for installation and construction of any parking pad within, upon or which crosses any City rights-of-way or roadway shall be in accord with the City's Zoning Code and any and all other regulations or requirements of the City and which shall also be approved by Planning and Development Services of Kenton County.

SECTION II

That this Ordinance shall be signed by the Mayor, attested to by the City Clerk, recorded, published and be effective upon publication.

RESOLUTION NO 3, 2023

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PARK HILLS, KENTUCKY SUPPORTING THE CREATION OF THE NORTHERN KENTUCKY BRANCH OF THE DEPARTMENT OF CRIMINAL JUSTICE TRAINING POLICE ACADEMY

WHEREAS, the Department of Criminal Justice Training (DOCJT) has been established as a branch of the Kentucky Justice and Public Safety Cabinet in order to certify and train all Kentucky police recruits to become police officers; and,

WHEREAS, the training facility for Basic Training of new police recruits is currently located in Richmond, Kentucky and is the only facility available for the majority of Kentucky police departments to train new police recruits; and.

WHEREAS, the current wait time for police agencies across the Commonwealth to get newly hired police recruits into the required Basic Training program at DOCJT is approximately six (6) months after completion of the hiring process; and,

WHEREAS, the combination of the hiring process of police recruits required under Kentucky law, the wait time to commence Basic training and the length of the required Basic Training routinely leaves police agencies across the Commonwealth without trained police officers for a period of at least one (1) year; AND,

WHEREAS, the support of cities and police agencies across the Commonwealth is needed to support the establishment of a Northern Kentucky branch of the DOCJT Police Academy;

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF PARK HILLS, KENTUCKY, that it hereby strongly supports the creation of a new DOCJT police recruit training facility in Northern Kentucky to aid in alleviating the time required to get newly hired police recruits trained to become police officers in service to the cities and communities throughout the Commonwealth.
