- 1. Review of the <u>July</u> minutes. (5 minutes)
 - a. Minutes approved
- 2. Committee roster update (2 minutes)
 - a. Marty Boyer is now co-chair and Mike Conway is a member, per <u>Executive Order</u> No. 5, 2023.

- 4. Opportunities along the Dixie Highway corridor (10 minutes)
 - a. New city building update: Police Department has moved in
 - b. Liquor store update: Expected opening as early as the beginning of November
 - c. New Park Hills entrance sign on Dixie Highway: Reviewed illustration and Mike Conway shared that the design is slightly different now, noting that the sign needs to be stationary. It may be more like a monument sign.
 - d. Szechuan Garden: High price, may need to be razed, may need new infrastructure, needs a buyer or developer with a vision. How safe is the building? Could it be a medical office building?
 - e. Jim Cline Upholstering: May be closed. Building seems to be empty and they aren't answering their phone line. The mayor is inquiring, but hasn't officially confirmed.
 - f. Sisters of Notre Dame: We need to communicate with them and find out what's happening with their property.
- 5. Next step suggestions from Josh Wice at PDS (3 minutes)
 - a. Parcel analysis in the business district. This is something PDS could assist with.
 - b. KLC strategic planning—Josh Wice has agreed to reach out to KLC to see if that is a complimentary service or if they charge for it.
 - c. Sarah hasn't received replies via email in a couple of months and will follow up by phone.
- 6. Engaging with Park Hills businesses (15 minutes)
 - Goal: To find at least 3 business or business property owners to serve on this committee
 - b. Questions asked to help us learn more about Park Hills businesses: Who's growing? Who's leaving? Who's coming?
 - c. Review updates:
 - i. Marty Boyer committed to contacting Permakil, Tapestry on the Ridge, Reality Tuesday, Park Hills Animal Hospital, and Finke's.
 - 1. Dr. Mark Collett at Park Hills Animal Hospital is a maybe.
 - ii. Mike Conway committed to contacting Ron Stam at Ft. Mitchell Garage, Ron at Loschiavo's, Bob Niehaus, and possibly Pat Flannery to see if he's interested in working with this committee.
 - iii. Sarah Froelich committed to contacting Granite World, Good Spirits liquor store (via Mayor Zembrodt, also asking for current/final design), and Edward Jones.
 - iv. Emily committed to contacting Sisters of Notre Dame, Covington Catholic, Notre Dame Academy, and Julie Learning Center.
 - 1. Mary at the Julie Learning Center is interested.
